AN ACT

To repeal section 160.261, RSMo, and to enact in lieu thereof one new section relating to school safety, with penalty provisions.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Section 160.261, RSMo, is repealed and one new section enacted in lieu thereof, to be known as section 160.261, to read as follows:

160.261. 1. The local board of education of each school district shall clearly establish a written policy of discipline, including the district's determination on the use of corporal punishment and the procedures in which punishment will be applied. A written copy of the district's discipline policy and corporal punishment procedures, if applicable, shall be provided to the pupil and parent or legal guardian of every pupil enrolled in the district at the beginning of each school year and also made available in the office of the superintendent of such district, during normal business hours, for public inspection. All employees of the district shall annually receive instruction related to the specific contents of the policy of discipline and any interpretations necessary to implement the provisions of the policy in the course of their duties, including but not limited to approved methods of dealing with acts of school violence, disciplining students with disabilities and instruction in the necessity and requirements for confidentiality.

2. The policy shall require school administrators to report acts of school violence to all teachers at the attendance center and, in addition, to other school district employees with a need to know. For the purposes of this chapter or chapter 167, "need to know" is defined as school personnel who are directly responsible for the student's education or who otherwise interact with

17 the student on a professional basis while acting within the scope of their assigned duties. As
18 used in this section, the phrase "act of school violence" or "violent behavior" means the exertion
19 of physical force by a student with the intent to do serious physical injury as defined in
20 subdivision (6) of section 565.002 to another person while on school property, including a school
21 bus in service on behalf of the district, or while involved in school activities. The policy shall
22 at a minimum require school administrators to report, as soon as reasonably practical, to the
23 appropriate law enforcement agency any of the following crimes, or any act which if committed
24 by an adult would be one of the following crimes:

- 26 (2) Second degree murder under section 565.021;
- 27 (3) Kidnapping under section 565.110;
- 28 (4) First degree assault under section 565.050;
- 29 (5) Rape in the first degree under section 566.030;

52 committed on school property, including but not limited to actions on any school bus in service
53 on behalf of the district or while involved in school activities. The policy shall require that any
54 portion of a student's individualized education program that is related to demonstrated or
55 potentially violent behavior shall be provided to any teacher and other school district employees
56 who are directly responsible for the student's education or who otherwise interact with the
57 student on an educational basis while acting within the scope of their assigned duties. The policy
58 shall also contain the consequences of failure to obey standards of conduct set by the local board
59 of education, and the importance of the standards to the maintenance of an atmosphere where
60 orderly learning is possible and encouraged.

61 3. The policy shall provide that any student who is on suspension for any of the offenses
62 listed in subsection 2 of this section or any act of violence or drug-related activity defined by
63 school district policy as a serious violation of school discipline pursuant to subsection 9 of this
64 section shall have as a condition of his or her suspension the requirement that such student is not
65 allowed, while on such suspension, to be within one thousand feet of any school property in the
66 school district where such student attended school or any activity of that district, regardless of
67 whether or not the activity takes place on district property unless:

68 (1) Such student is under the direct supervision of the student's parent, legal guardian,
69 or custodian and the superintendent or the superintendent's designee has authorized the student
70 to be on school property;

71 (2) Such student is under the direct supervision of another adult designated by the
72 student's parent, legal guardian, or custodian, in advance, in writing, to the principal of the school
73 which suspended the student and the superintendent or the superintendent's designee has
74 authorized the student to be on school property;

75 (3) Such student is enrolled in and attending an alternative school that is located within
76 one thousand feet of a public school in the school district where such student attended school;
77 or

78 (4) Such student resides within one thousand feet of any public school in the school
79 district where such student attended school in which case such student may be on the property
80 of his or her residence without direct adult supervision.

81 4. Any student who violates the condition of suspension required pursuant to subsection
82 3 of this section may be subject to expulsion or further suspension pursuant to the provisions of
83 sections 167.161, 167.164, and 167.171. In making this determination consideration shall be
84 given to whether the student poses a threat to the safety of any child or school employee and
85 whether such student's unsupervised presence within one thousand feet of the school is disruptive
86 to the educational process or undermines the effectiveness of the school's disciplinary policy.

87 Removal of any pupil who is a student with a disability is subject to state and federal procedural
88 rights. This section shall not limit a school district's ability to:

89 (1) Prohibit all students who are suspended from being on school property or attending
90 an activity while on suspension;

91 (2) Discipline students for off-campus conduct that negatively affects the educational
92 environment to the extent allowed by law.

93 5. The policy shall provide for a suspension for a period of not less than one year, or
94 expulsion, for a student who is determined to have brought a weapon to school, including but
95 not limited to the school playground or the school parking lot, brought a weapon on a school bus
96 or brought a weapon to a school activity whether on or off of the school property in violation of
97 district policy, except that:

98 (1) The superintendent or, in a school district with no high school, the principal of the
99 school which such child attends may modify such suspension on a case-by-case basis; and

100 (2) This section shall not prevent the school district from providing educational services
101 in an alternative setting to a student suspended under the provisions of this section.

102 6. For the purpose of this section, the term "weapon" shall mean a firearm as defined
103 under 18 U.S.C. 921 and the following items, as defined in section 571.010: a blackjack, a
104 concealable firearm, an explosive weapon, a firearm, a firearm silencer, a gas gun, a knife,
105 knuckles, a machine gun, a projectile weapon, a rifle, a shotgun, a spring gun or a switchblade
106 knife; except that this section shall not be construed to prohibit a school board from adopting a
107 policy to allow a Civil War reenactor to carry a Civil War era weapon on school property for
108 educational purposes so long as the firearm is unloaded. The local board of education shall
109 define weapon in the discipline policy. Such definition shall include the weapons defined in this
110 subsection but may also include other weapons.

111 7. All school district personnel responsible for the care and supervision of students are
112 authorized to hold every pupil strictly accountable for any disorderly conduct in school or on any
113 property of the school, on any school bus going to or returning from school, during
114 school-sponsored activities, or during intermission or recess periods.

115 8. Teachers and other authorized district personnel in public schools responsible for the
116 care, supervision, and discipline of schoolchildren, including volunteers selected with reasonable
117 care by the school district, shall not be civilly liable when acting in conformity with the
118 established policies developed by each board, including but not limited to policies of student
119 discipline or when reporting to his or her supervisor or other person as mandated by state law
120 acts of school violence or threatened acts of school violence, within the course and scope of the
121 duties of the teacher, authorized district personnel or volunteer, when such individual is acting
122 in conformity with the established policies developed by the board. Nothing in this section shall

123 be construed to create a new cause of action against such school district, or to relieve the school
124 district from liability for the negligent acts of such persons.

125 9. Each school board shall define in its discipline policy acts of violence and any other
126 acts that constitute a serious violation of that policy. "Acts of violence" as defined by school
127 boards shall include but not be limited to exertion of physical force by a student with the intent
128 to do serious bodily harm to another person while on school property, including a school bus in
129 service on behalf of the district, or while involved in school activities. School districts shall for
130 each student enrolled in the school district compile and maintain records of any serious violation
131 of the district's discipline policy. Such records shall be made available to teachers and other
132 school district employees with a need to know while acting within the scope of their assigned
133 duties, and shall be provided as required in section 167.020 to any school district in which the
134 student subsequently attempts to enroll.

135 10. Spanking, when administered by certificated personnel and in the presence of a
136 witness who is an employee of the school district, or the use of reasonable force to protect
137 persons or property, when administered by personnel of a school district in a reasonable manner
138 in accordance with the local board of education's written policy of discipline, is not abuse within
139 the meaning of chapter 210. The provisions of sections 210.110 to 210.165 notwithstanding, the
140 children's division shall not have jurisdiction over or investigate any report of alleged child abuse
141 arising out of or related to the use of reasonable force to protect persons or property when
142 administered by personnel of a school district or any spanking administered in a reasonable
143 manner by any certificated school personnel in the presence of a witness who is an employee of
144 the school district pursuant to a written policy of discipline established by the board of education
145 of the school district, as long as no allegation of sexual misconduct arises from the spanking or
146 use of force.

147 11. If a student reports alleged sexual misconduct on the part of a teacher or other school
148 employee to a person employed in a school facility who is required to report such misconduct
149 to the children's division under section 210.115, such person and the superintendent of the school
150 district shall report the allegation to the children's division as set forth in section 210.115.
151 Reports made to the children's division under this subsection shall be investigated by the division
152 in accordance with the provisions of sections 210.145 to 210.153 and shall not be investigated
153 by the school district under subsections 12 to 20 of this section for purposes of determining
154 whether the allegations should or should not be substantiated. The district may investigate the
155 allegations for the purpose of making any decision regarding the employment of the accused
156 employee.

157 12. Upon receipt of any reports of child abuse by the children's division other than
158 reports provided under subsection 11 of this section, pursuant to sections 210.110 to 210.165

159 which allegedly involve personnel of a school district, the children's division shall notify the
160 superintendent of schools of the district or, if the person named in the alleged incident is the
161 superintendent of schools, the president of the school board of the school district where the
162 alleged incident occurred.

163 13. If, after an initial investigation, the superintendent of schools or the president of the
164 school board finds that the report involves an alleged incident of child abuse other than the
165 administration of a spanking by certificated school personnel or the use of reasonable force to
166 protect persons or property when administered by school personnel pursuant to a written policy
167 of discipline or that the report was made for the sole purpose of harassing a public school
168 employee, the superintendent of schools or the president of the school board shall immediately
169 refer the matter back to the children's division and take no further action. In all matters referred
170 back to the children's division, the division shall treat the report in the same manner as other
171 reports of alleged child abuse received by the division.

172 14. If the report pertains to an alleged incident which arose out of or is related to a
173 spanking administered by certificated personnel or the use of reasonable force to protect persons
174 or property when administered by personnel of a school district pursuant to a written policy of
175 discipline or a report made for the sole purpose of harassing a public school employee, a
176 notification of the reported child abuse shall be sent by the superintendent of schools or the
177 president of the school board to the law enforcement in the county in which the alleged incident
178 occurred.

179 15. The report shall be jointly investigated by the law enforcement officer and the
180 superintendent of schools or, if the subject of the report is the superintendent of schools, by a law
181 enforcement officer and the president of the school board or such president's designee.

182 16. The investigation shall begin no later than forty-eight hours after notification from
183 the children's division is received, and shall consist of, but need not be limited to, interviewing
184 and recording statements of the child and the child's parents or guardian within two working days
185 after the start of the investigation, of the school district personnel allegedly involved in the
186 report, and of any witnesses to the alleged incident.

187 17. The law enforcement officer and the investigating school district personnel shall
188 issue separate reports of their findings and recommendations after the conclusion of the
189 investigation to the school board of the school district within seven days after receiving notice
190 from the children's division.

191 18. The reports shall contain a statement of conclusion as to whether the report of alleged
192 child abuse is substantiated or is unsubstantiated.

193 19. The school board shall consider the separate reports referred to in subsection 17 of
194 this section and shall issue its findings and conclusions and the action to be taken, if any, within

195 seven days after receiving the last of the two reports. The findings and conclusions shall be
196 made in substantially the following form:

197 (1) The report of the alleged child abuse is unsubstantiated. The law enforcement officer
198 and the investigating school board personnel agree that there was not a preponderance of
199 evidence to substantiate that abuse occurred;

200 (2) The report of the alleged child abuse is substantiated. The law enforcement officer
201 and the investigating school district personnel agree that the preponderance of evidence is
202 sufficient to support a finding that the alleged incident of child abuse did occur;

203 (3) The issue involved in the alleged incident of child abuse is unresolved. The law
204 enforcement officer and the investigating school personnel are unable to agree on their findings
205 and conclusions on the alleged incident.

206 20. The findings and conclusions of the school board under subsection 19 of this section
207 shall be sent to the children's division. If the findings and conclusions of the school board are
208 that the report of the alleged child abuse is unsubstantiated, the investigation shall be terminated,
209 the case closed, and no record shall be entered in the children's division central registry. If the
210 findings and conclusions of the school board are that the report of the alleged child abuse is
211 substantiated, the children's division shall report the incident to the prosecuting attorney of the
212 appropriate county along with the findings and conclusions of the school district and shall
213 include the information in the division's central registry. If the findings and conclusions of the
214 school board are that the issue involved in the alleged incident of child abuse is unresolved, the
215 children's division shall report the incident to the prosecuting attorney of the appropriate county
216 along with the findings and conclusions of the school board, however, the incident and the names
217 of the parties allegedly involved shall not be entered into the central registry of the children's
218 division unless and until the alleged child abuse is substantiated by a court of competent
219 jurisdiction.

220 21. Any superintendent of schools, president of a school board or such person's designee
221 or law enforcement officer who knowingly falsifies any report of any matter pursuant to this
222 section or who knowingly withholds any information relative to any investigation or report
223 pursuant to this section is guilty of a class A misdemeanor.

224 22. In order to ensure the safety of all students, should a student be expelled for bringing
225 a weapon to school, violent behavior, or for an act of school violence, that student shall not, for
226 the purposes of the accreditation process of the Missouri school improvement plan, be
227 considered a dropout or be included in the calculation of that district's educational persistence
228 ratio.
