### AN ACT

To repeal sections 301.010 and 304.180, RSMo, and to enact in lieu thereof two new sections relating to vehicles hauling livestock and agricultural products.

---

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

Section A. Sections 301.010 and 304.180, RSMo, are repealed and two new sections enacted in lieu thereof, to be known as sections 301.010 and 304.180, to read as follows:

301.010. As used in this chapter and sections 304.010 to 304.040, 304.120 to 304.260, and sections 307.010 to 307.175, the following terms mean:

(1) "All-terrain vehicle", any motorized vehicle manufactured and used exclusively for off-highway use which is fifty inches or less in width, with an unladen dry weight of one thousand five hundred pounds or less, traveling on three, four or more nonhighway tires, with a seat designed to be straddled by the operator, or with a seat designed to carry more than one person, and handlebars for steering control;

(2) "Automobile transporter", any vehicle combination designed and used specifically for the transport of assembled motor vehicles;

(3) "Axle load", the total load transmitted to the road by all wheels whose centers are included between two parallel transverse vertical planes forty inches apart, extending across the full width of the vehicle;

(4) "Boat transporter", any vehicle combination designed and used specifically to transport assembled boats and boat hulls;

(5) "Body shop", a business that repairs physical damage on motor vehicles that are not owned by the shop or its officers or employees by mending, straightening, replacing body parts, or painting;

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

- 18           (6) "Bus", a motor vehicle primarily for the transportation of a driver and eight or more  
19 passengers but not including shuttle buses;
- 20           (7) "Commercial motor vehicle", a motor vehicle designed or regularly used for carrying  
21 freight and merchandise, or more than eight passengers but not including vanpools or shuttle  
22 buses;
- 23           (8) "Cotton trailer", a trailer designed and used exclusively for transporting cotton at  
24 speeds less than forty miles per hour from field to field or from field to market and return;
- 25           (9) "Dealer", any person, firm, corporation, association, agent or subagent engaged in  
26 the sale or exchange of new, used or reconstructed motor vehicles or trailers;
- 27           (10) "Director" or "director of revenue", the director of the department of revenue;
- 28           (11) "Driveaway operation":  
29           (a) The movement of a motor vehicle or trailer by any person or motor carrier other than  
30 a dealer over any public highway, under its own power singly, or in a fixed combination of two  
31 or more vehicles, for the purpose of delivery for sale or for delivery either before or after sale;  
32           (b) The movement of any vehicle or vehicles, not owned by the transporter, constituting  
33 the commodity being transported, by a person engaged in the business of furnishing drivers and  
34 operators for the purpose of transporting vehicles in transit from one place to another by the  
35 driveaway or towaway methods; or  
36           (c) The movement of a motor vehicle by any person who is lawfully engaged in the  
37 business of transporting or delivering vehicles that are not the person's own and vehicles of a  
38 type otherwise required to be registered, by the driveaway or towaway methods, from a point of  
39 manufacture, assembly or distribution or from the owner of the vehicles to a dealer or sales agent  
40 of a manufacturer or to any consignee designated by the shipper or consignor;
- 41           (12) "Dromedary", a box, deck, or plate mounted behind the cab and forward of the fifth  
42 wheel on the frame of the power unit of a truck tractor-semitrailer combination. A truck tractor  
43 equipped with a dromedary may carry part of a load when operating independently or in a  
44 combination with a semitrailer;
- 45           (13) "Farm tractor", a tractor used exclusively for agricultural purposes;
- 46           (14) "Fleet", any group of ten or more motor vehicles owned by the same owner;
- 47           (15) "Fleet vehicle", a motor vehicle which is included as part of a fleet;
- 48           (16) "Fullmount", a vehicle mounted completely on the frame of either the first or last  
49 vehicle in a saddlemount combination;
- 50           (17) "Gross weight", the weight of vehicle and/or vehicle combination without load, plus  
51 the weight of any load thereon;
- 52           (18) "Hail-damaged vehicle", any vehicle, the body of which has become dented as the  
53 result of the impact of hail;

54 (19) "Highway", any public thoroughfare for vehicles, including state roads, county roads  
55 and public streets, avenues, boulevards, parkways or alleys in any municipality;

56 (20) "Improved highway", a highway which has been paved with gravel, macadam,  
57 concrete, brick or asphalt, or surfaced in such a manner that it shall have a hard, smooth surface;

58 (21) "Intersecting highway", any highway which joins another, whether or not it crosses  
59 the same;

60 (22) "Junk vehicle", a vehicle which is incapable of operation or use upon the highways  
61 and has no resale value except as a source of parts or scrap, and shall not be titled or registered;

62 (23) "Kit vehicle", a motor vehicle assembled by a person other than a generally  
63 recognized manufacturer of motor vehicles by the use of a glider kit or replica purchased from  
64 an authorized manufacturer and accompanied by a manufacturer's statement of origin;

65 (24) "Land improvement contractors' commercial motor vehicle", any not-for-hire  
66 commercial motor vehicle the operation of which is confined to:

67 (a) An area that extends not more than a radius of one hundred miles from its home base  
68 of operations when transporting its owner's machinery, equipment, or auxiliary supplies to or  
69 from projects involving soil and water conservation, or to and from equipment dealers'  
70 maintenance facilities for maintenance purposes; or

71 (b) An area that extends not more than a radius of fifty miles from its home base of  
72 operations when transporting its owner's machinery, equipment, or auxiliary supplies to or from  
73 projects not involving soil and water conservation. Nothing in this subdivision shall be  
74 construed to prevent any motor vehicle from being registered as a commercial motor vehicle or  
75 local commercial motor vehicle;

76 (25) "Local commercial motor vehicle", a commercial motor vehicle whose operations  
77 are confined solely to a municipality and that area extending not more than fifty miles therefrom,  
78 or a commercial motor vehicle whose property-carrying operations are confined solely to the  
79 transportation of property owned by any person who is the owner or operator of such vehicle to  
80 or from a farm owned by such person or under the person's control by virtue of a landlord and  
81 tenant lease; provided that any such property transported to any such farm is for use in the  
82 operation of such farm;

83 (26) "Local log truck", a commercial motor vehicle which is registered pursuant to this  
84 chapter to operate as a motor vehicle on the public highways of this state, used exclusively in this  
85 state, used to transport **any form or type of** harvested forest products, operated solely at a  
86 forested site and in an area extending not more than a [one] **two** hundred-mile radius from such  
87 site, carries a load with dimensions not in excess of twenty-five cubic yards per two axles with  
88 dual wheels, and when operated on the national system of interstate and defense highways  
89 described in Title 23, Section 103(e) of the United States Code, such vehicle shall not exceed

90 the weight limits of section 304.180, does not have more than four axles, and does not pull a  
91 trailer which has more than two axles. Harvesting equipment which is used specifically for  
92 cutting, felling, trimming, delimbing, debarking, chipping, skidding, loading, unloading, and  
93 stacking may be transported on a local log truck. A local log truck may not exceed the limits  
94 required by law, however, if the truck does exceed such limits as determined by the inspecting  
95 officer, then notwithstanding any other provisions of law to the contrary, such truck shall be  
96 subject to the weight limits required by such sections as licensed for eighty thousand pounds;

97 (27) "Local log truck tractor", a commercial motor vehicle which is registered under this  
98 chapter to operate as a motor vehicle on the public highways of this state, used exclusively in this  
99 state, used to transport **any form or type of** harvested forest products, operated solely at a  
100 forested site and in an area extending not more than a [one] **two** hundred-mile radius from such  
101 site, operates with a weight not exceeding twenty-two thousand four hundred pounds on one axle  
102 or with a weight not exceeding forty-four thousand eight hundred pounds on any tandem axle,  
103 and when operated on the national system of interstate and defense highways described in Title  
104 23, Section 103(e) of the United States Code, such vehicle does not exceed the weight limits  
105 contained in section 304.180, and does not have more than three axles and does not pull a trailer  
106 which has more than two axles. Violations of axle weight limitations shall be subject to the load  
107 limit penalty as described for in sections 304.180 to 304.220;

108 (28) "Local transit bus", a bus whose operations are confined wholly within a municipal  
109 corporation, or wholly within a municipal corporation and a commercial zone, as defined in  
110 section 390.020, adjacent thereto, forming a part of a public transportation system within such  
111 municipal corporation and such municipal corporation and adjacent commercial zone;

112 (29) "Log truck", a vehicle which is not a local log truck or local log truck tractor and  
113 is used exclusively to transport harvested forest products to and from forested sites which is  
114 registered pursuant to this chapter to operate as a motor vehicle on the public highways of this  
115 state for the transportation of harvested forest products;

116 (30) "Major component parts", the rear clip, cowl, frame, body, cab, front-end assembly,  
117 and front clip, as those terms are defined by the director of revenue pursuant to rules and  
118 regulations or by illustrations;

119 (31) "Manufacturer", any person, firm, corporation or association engaged in the  
120 business of manufacturing or assembling motor vehicles, trailers or vessels for sale;

121 (32) "Motor change vehicle", a vehicle manufactured prior to August, 1957, which  
122 receives a new, rebuilt or used engine, and which used the number stamped on the original  
123 engine as the vehicle identification number;

124 (33) "Motor vehicle", any self-propelled vehicle not operated exclusively upon tracks,  
125 except farm tractors;

- 126           (34) "Motor vehicle primarily for business use", any vehicle other than a recreational  
127 motor vehicle, motorcycle, motortricycle, or any commercial motor vehicle licensed for over  
128 twelve thousand pounds:
- 129           (a) Offered for hire or lease; or  
130           (b) The owner of which also owns ten or more such motor vehicles;
- 131           (35) "Motorcycle", a motor vehicle operated on two wheels;  
132           (36) "Motorized bicycle", any two-wheeled or three-wheeled device having an automatic  
133 transmission and a motor with a cylinder capacity of not more than fifty cubic centimeters, which  
134 produces less than three gross brake horsepower, and is capable of propelling the device at a  
135 maximum speed of not more than thirty miles per hour on level ground;
- 136           (37) "Motortricycle", a motor vehicle operated on three wheels, including a motorcycle  
137 while operated with any conveyance, temporary or otherwise, requiring the use of a third wheel.  
138 A motortricycle shall not be included in the definition of all-terrain vehicle;
- 139           (38) "Municipality", any city, town or village, whether incorporated or not;  
140           (39) "Nonresident", a resident of a state or country other than the state of Missouri;
- 141           (40) "Non-USA-std motor vehicle", a motor vehicle not originally manufactured in  
142 compliance with United States emissions or safety standards;
- 143           (41) "Operator", any person who operates or drives a motor vehicle;  
144           (42) "Owner", any person, firm, corporation or association, who holds the legal title to  
145 a vehicle or in the event a vehicle is the subject of an agreement for the conditional sale or lease  
146 thereof with the right of purchase upon performance of the conditions stated in the agreement  
147 and with an immediate right of possession vested in the conditional vendee or lessee, or in the  
148 event a mortgagor of a vehicle is entitled to possession, then such conditional vendee or lessee  
149 or mortgagor shall be deemed the owner for the purpose of this law;
- 150           (43) "Public garage", a place of business where motor vehicles are housed, stored,  
151 repaired, reconstructed or repainted for persons other than the owners or operators of such place  
152 of business;
- 153           (44) "Rebuilder", a business that repairs or rebuilds motor vehicles owned by the  
154 rebuilder, but does not include certificated common or contract carriers of persons or property;
- 155           (45) "Reconstructed motor vehicle", a vehicle that is altered from its original  
156 construction by the addition or substitution of two or more new or used major component parts,  
157 excluding motor vehicles made from all new parts, and new multistage manufactured vehicles;
- 158           (46) "Recreational motor vehicle", any motor vehicle designed, constructed or  
159 substantially modified so that it may be used and is used for the purposes of temporary housing  
160 quarters, including therein sleeping and eating facilities which are either permanently attached  
161 to the motor vehicle or attached to a unit which is securely attached to the motor vehicle.

162 Nothing herein shall prevent any motor vehicle from being registered as a commercial motor  
163 vehicle if the motor vehicle could otherwise be so registered;

164 (47) "Recreational off-highway vehicle", any motorized vehicle manufactured and used  
165 exclusively for off-highway use which is sixty-four inches or less in width, with an unladen dry  
166 weight of two thousand pounds or less, traveling on four or more nonhighway tires, with a  
167 nonstraddle seat, and steering wheel, which may have access to ATV trails;

168 (48) "Rollback or car carrier", any vehicle specifically designed to transport wrecked,  
169 disabled or otherwise inoperable vehicles, when the transportation is directly connected to a  
170 wrecker or towing service;

171 (49) "Saddlemount combination", a combination of vehicles in which a truck or truck  
172 tractor tows one or more trucks or truck tractors, each connected by a saddle to the frame or fifth  
173 wheel of the vehicle in front of it. The "saddle" is a mechanism that connects the front axle of  
174 the towed vehicle to the frame or fifth wheel of the vehicle in front and functions like a fifth  
175 wheel kingpin connection. When two vehicles are towed in this manner the combination is  
176 called a "double saddlemount combination". When three vehicles are towed in this manner, the  
177 combination is called a "triple saddlemount combination";

178 (50) "Salvage dealer and dismantler", a business that dismantles used motor vehicles for  
179 the sale of the parts thereof, and buys and sells used motor vehicle parts and accessories;

180 (51) "Salvage vehicle", a motor vehicle, semitrailer, or house trailer which:

181 (a) Was damaged during a year that is no more than six years after the manufacturer's  
182 model year designation for such vehicle to the extent that the total cost of repairs to rebuild or  
183 reconstruct the vehicle to its condition immediately before it was damaged for legal operation  
184 on the roads or highways exceeds eighty percent of the fair market value of the vehicle  
185 immediately preceding the time it was damaged;

186 (b) By reason of condition or circumstance, has been declared salvage, either by its  
187 owner, or by a person, firm, corporation, or other legal entity exercising the right of security  
188 interest in it;

189 (c) Has been declared salvage by an insurance company as a result of settlement of a  
190 claim;

191 (d) Ownership of which is evidenced by a salvage title; or

192 (e) Is abandoned property which is titled pursuant to section 304.155 or section 304.157  
193 and designated with the words "salvage/abandoned property". The total cost of repairs to rebuild  
194 or reconstruct the vehicle shall not include the cost of repairing, replacing, or reinstalling  
195 inflatable safety restraints, tires, sound systems, or damage as a result of hail, or any sales tax on  
196 parts or materials to rebuild or reconstruct the vehicle. For purposes of this definition, "fair  
197 market value" means the retail value of a motor vehicle as:

- 198           a. Set forth in a current edition of any nationally recognized compilation of retail values,  
199 including automated databases, or from publications commonly used by the automotive and  
200 insurance industries to establish the values of motor vehicles;
- 201           b. Determined pursuant to a market survey of comparable vehicles with regard to  
202 condition and equipment; and
- 203           c. Determined by an insurance company using any other procedure recognized by the  
204 insurance industry, including market surveys, that is applied by the company in a uniform  
205 manner;
- 206           (52) "School bus", any motor vehicle used solely to transport students to or from school  
207 or to transport students to or from any place for educational purposes;
- 208           (53) "Scrap processor", a business that, through the use of fixed or mobile equipment,  
209 flattens, crushes, or otherwise accepts motor vehicles and vehicle parts for processing or  
210 transportation to a shredder or scrap metal operator for recycling;
- 211           (54) "Shuttle bus", a motor vehicle used or maintained by any person, firm, or  
212 corporation as an incidental service to transport patrons or customers of the regular business of  
213 such person, firm, or corporation to and from the place of business of the person, firm, or  
214 corporation providing the service at no fee or charge. Shuttle buses shall not be registered as  
215 buses or as commercial motor vehicles;
- 216           (55) "Special mobile equipment", every self-propelled vehicle not designed or used  
217 primarily for the transportation of persons or property and incidentally operated or moved over  
218 the highways, including farm equipment, implements of husbandry, road construction or  
219 maintenance machinery, ditch-digging apparatus, stone crushers, air compressors, power shovels,  
220 cranes, graders, rollers, well-drillers and wood-sawing equipment used for hire, asphalt  
221 spreaders, bituminous mixers, bucket loaders, ditchers, leveling graders, finished machines,  
222 motor graders, road rollers, scarifiers, earth-moving carryalls, scrapers, drag lines, concrete pump  
223 trucks, rock-drilling and earth-moving equipment. This enumeration shall be deemed partial and  
224 shall not operate to exclude other such vehicles which are within the general terms of this  
225 section;
- 226           (56) "Specially constructed motor vehicle", a motor vehicle which shall not have been  
227 originally constructed under a distinctive name, make, model or type by a manufacturer of motor  
228 vehicles. The term specially constructed motor vehicle includes kit vehicles;
- 229           (57) "Stinger-steered combination", a truck tractor-semitrailer wherein the fifth wheel  
230 is located on a drop frame located behind and below the rearmost axle of the power unit;
- 231           (58) "Tandem axle", a group of two or more axles, arranged one behind another, the  
232 distance between the extremes of which is more than forty inches and not more than ninety-six  
233 inches apart;

234 (59) "Tractor", "truck tractor" or "truck-tractor", a self-propelled motor vehicle designed  
235 for drawing other vehicles, but not for the carriage of any load when operating independently.  
236 When attached to a semitrailer, it supports a part of the weight thereof;

237 (60) "Trailer", any vehicle without motive power designed for carrying property or  
238 passengers on its own structure and for being drawn by a self-propelled vehicle, except those  
239 running exclusively on tracks, including a semitrailer or vehicle of the trailer type so designed  
240 and used in conjunction with a self-propelled vehicle that a considerable part of its own weight  
241 rests upon and is carried by the towing vehicle. The term "trailer" shall not include cotton  
242 trailers as defined in subdivision (8) of this section and shall not include manufactured homes  
243 as defined in section 700.010;

244 (61) "Truck", a motor vehicle designed, used, or maintained for the transportation of  
245 property;

246 (62) "Truck-tractor semitrailer-semitrailer", a combination vehicle in which the two  
247 trailing units are connected with a B-train assembly which is a rigid frame extension attached to  
248 the rear frame of a first semitrailer which allows for a fifth-wheel connection point for the second  
249 semitrailer and has one less articulation point than the conventional A-dolly connected truck-  
250 tractor semitrailer-trailer combination;

251 (63) "Truck-trailer boat transporter combination", a boat transporter combination  
252 consisting of a straight truck towing a trailer using typically a ball and socket connection with  
253 the trailer axle located substantially at the trailer center of gravity rather than the rear of the  
254 trailer but so as to maintain a downward force on the trailer tongue;

255 (64) "Used parts dealer", a business that buys and sells used motor vehicle parts or  
256 accessories, but not including a business that sells only new, remanufactured or rebuilt parts.  
257 "Business" does not include isolated sales at a swap meet of less than three days;

258 (65) "Utility vehicle", any motorized vehicle manufactured and used exclusively for off-  
259 highway use which is sixty-three inches or less in width, with an unladen dry weight of one  
260 thousand eight hundred fifty pounds or less, traveling on four or six wheels, to be used primarily  
261 for landscaping, lawn care, or maintenance purposes;

262 (66) "Vanpool", any van or other motor vehicle used or maintained by any person, group,  
263 firm, corporation, association, city, county or state agency, or any member thereof, for the  
264 transportation of not less than eight nor more than forty-eight employees, per motor vehicle, to  
265 and from their place of employment; however, a vanpool shall not be included in the definition  
266 of the term bus or commercial motor vehicle as defined by subdivisions (6) and (7) of this  
267 section, nor shall a vanpool driver be deemed a chauffeur as that term is defined by section  
268 303.020; nor shall use of a vanpool vehicle for ride-sharing arrangements, recreational, personal,



269 or maintenance uses constitute an unlicensed use of the motor vehicle, unless used for monetary  
 270 profit other than for use in a ride-sharing arrangement;

271 (67) "Vehicle", any mechanical device on wheels, designed primarily for use, or used,  
 272 on highways, except motorized bicycles, vehicles propelled or drawn by horses or human power,  
 273 or vehicles used exclusively on fixed rails or tracks, or cotton trailers or motorized wheelchairs  
 274 operated by handicapped persons;

275 (68) "Wrecker" or "tow truck", any emergency commercial vehicle equipped, designed  
 276 and used to assist or render aid and transport or tow disabled or wrecked vehicles from a  
 277 highway, road, street or highway rights-of-way to a point of storage or repair, including towing  
 278 a replacement vehicle to replace a disabled or wrecked vehicle;

279 (69) "Wrecker or towing service", the act of transporting, towing or recovering with a  
 280 wrecker, tow truck, rollback or car carrier any vehicle not owned by the operator of the wrecker,  
 281 tow truck, rollback or car carrier for which the operator directly or indirectly receives  
 282 compensation or other personal gain.

304.180. 1. No vehicle or combination of vehicles shall be moved or operated on any  
 2 highway in this state having a greater weight than twenty thousand pounds on one axle, no  
 3 combination of vehicles operated by transporters of general freight over regular routes as defined  
 4 in section 390.020 shall be moved or operated on any highway of this state having a greater  
 5 weight than the vehicle manufacturer's rating on a steering axle with the maximum weight not  
 6 to exceed twelve thousand pounds on a steering axle, and no vehicle shall be moved or operated  
 7 on any state highway of this state having a greater weight than thirty-four thousand pounds on  
 8 any tandem axle; the term "tandem axle" shall mean a group of two or more axles, arranged one  
 9 behind another, the distance between the extremes of which is more than forty inches and not  
 10 more than ninety-six inches apart.

11 2. An "axle load" is defined as the total load transmitted to the road by all wheels whose  
 12 centers are included between two parallel transverse vertical planes forty inches apart, extending  
 13 across the full width of the vehicle.

14 3. Subject to the limit upon the weight imposed upon a highway of this state through any  
 15 one axle or on any tandem axle, the total gross weight with load imposed by any group of two  
 16 or more consecutive axles of any vehicle or combination of vehicles shall not exceed the  
 17 maximum load in pounds as set forth in the following table:

79 Notwithstanding the above table, two consecutive sets of tandem axles may carry a gross load  
80 of thirty-four thousand pounds each if the overall distance between the first and last axles of such  
81 consecutive sets of tandem axles is thirty-six feet or more.

82 4. Whenever the state highways and transportation commission finds that any state  
83 highway bridge in the state is in such a condition that use of such bridge by vehicles of the  
84 weights specified in subsection 3 of this section will endanger the bridge, or the users of the  
85 bridge, the commission may establish maximum weight limits and speed limits for vehicles using  
86 such bridge. The governing body of any city or county may grant authority by act or ordinance  
87 to the state highways and transportation commission to enact the limitations established in this  
88 section on those roadways within the purview of such city or county. Notice of the weight limits  
89 and speed limits established by the commission shall be given by posting signs at a conspicuous  
90 place at each end of any such bridge.

91 5. Nothing in this section shall be construed as permitting lawful axle loads, tandem axle  
92 loads or gross loads in excess of those permitted under the provisions of Section 127 of Title 23  
93 of the United States Code.

94           6. Notwithstanding the weight limitations contained in this section, any vehicle or  
95 combination of vehicles operating on highways other than the interstate highway system may  
96 exceed single axle, tandem axle and gross weight limitations in an amount not to exceed two  
97 thousand pounds. However, total gross weight shall not exceed eighty thousand pounds, except  
98 as provided in subsections 9 and 10 of this section.

99           7. Notwithstanding any provision of this section to the contrary, the department of  
100 transportation shall issue a single-use special permit, or upon request of the owner of the truck  
101 or equipment, shall issue an annual permit, for the transporting of any concrete pump truck or  
102 well-drillers' equipment. The department of transportation shall set fees for the issuance of  
103 permits pursuant to this subsection. Notwithstanding the provisions of section 301.133, concrete  
104 pump trucks or well-drillers' equipment may be operated on state-maintained roads and highways  
105 at any time on any day.

106           8. Notwithstanding the provision of this section to the contrary, the maximum gross  
107 vehicle limit and axle weight limit for any vehicle or combination of vehicles equipped with an  
108 idle reduction technology may be increased by a quantity necessary to compensate for the  
109 additional weight of the idle reduction system as provided for in 23 U.S.C. Section 127, as  
110 amended. In no case shall the additional weight increase allowed by this subsection be greater  
111 than five hundred fifty pounds. Upon request by an appropriate law enforcement officer, the  
112 vehicle operator shall provide proof that the idle reduction technology is fully functional at all  
113 times and that the gross weight increase is not used for any purpose other than for the use of idle  
114 reduction technology.

115           9. **(1)** Notwithstanding subsection 3 of this section or any other provision of law to the  
116 contrary, the total gross weight of any vehicle or combination of vehicles hauling livestock **or**  
117 **agricultural products not including local log trucks as defined in section 301.010** may be  
118 as much as, but shall not exceed, eighty-five thousand five hundred pounds [while operating on  
119 U.S. Highway 36 from St. Joseph to U.S. Highway 63, on U.S. Highway 65 from the Iowa state  
120 line to U.S. Highway 36, and on U.S. Highway 63 from the Iowa state line to U.S. Highway 36,  
121 and on U.S. Highway 63 from U.S. Highway 36 to Missouri Route 17]. The provisions of this  
122 subsection shall not apply to vehicles operated on the Dwight D. Eisenhower System of Interstate  
123 and Defense Highways. **As used in this section, "agricultural product" means an**  
124 **agricultural, horticultural, viticultural, or vegetable product, growing of grapes that will**  
125 **be processed into wine, bees, honey, fish or other aquacultural product, planting seed,**  
126 **livestock, a livestock product, a forestry product, poultry or a poultry product, either in**  
127 **its natural or processed state, that has been produced, processed, or otherwise had value**  
128 **added to it in this state.**

129           **(2) Any business operating any vehicles hauling greater than eighty thousand**  
130 **pounds under the provisions of this subsection shall apply yearly to the department of**  
131 **transportation for a permit and upon payment of a twenty-five dollar fee, the department**  
132 **shall grant the applicant a permit. Upon renewal of the permit, an applicant shall submit**  
133 **to the department a list of roads traveled and the number of miles traveled on each road**  
134 **during the year.**

135           10. Notwithstanding any provision of this section or any other law to the contrary, the  
136 total gross weight of any vehicle or combination of vehicles hauling milk from a farm to a  
137 processing facility may be as much as, but shall not exceed, eighty-five thousand five hundred  
138 pounds while operating on highways other than the interstate highway system. The provisions  
139 of this subsection shall not apply to vehicles operated and operating on the Dwight D.  
140 Eisenhower System of Interstate and Defense Highways.
