AN ACT

To amend chapter 227, RSMo, by adding thereto thirteen new sections relating to the designation of memorial highways and bridges.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Chapter 227, RSMo, is amended by adding thereto thirteen new

- 2 sections, to be known as sections 227.301, 227.316, 227.327, 227.328, 227.332,
- 3 227.344, 227.382, 227.399, 227.401, 227.450, 227.504, 227.507, and 227.520, to
- 4 read as follows:

227.301. The portion of State Highway U from the intersection of

- 2 State Highway M to the intersection of Province Road in Washington
- 3 County shall be designated the "SGM Patrick R. Hurley Memorial
- 4 Highway". The department of transportation shall erect and maintain
- 5 appropriate signs designating such highway with the costs to be paid
- 6 by private donations.

227.316. The portion of State Highway U from the intersection of

- 2 Province Road to the intersection of State Highway 8 in Washington
- 3 County shall be designated the "Thomas Wesley Benoist Memorial
- 4 Highway". The department of transportation shall erect and maintain
- 5 appropriate signs designating such highway with the costs to be paid
- 6 by private donations.

227.327. The bridge on Missouri Highway 5 crossing over

- 2 Interstate 44 in Laclede County shall be designated the "James R.
- 3 Ledbetter Memorial Bridge". The department of transportation shall
- 4 erect and maintain appropriate signs designating the bridge, with the
- 5 costs for such designation to be paid for by private donation.

227.328. The bridge on Missouri Route N over the Meramec river

2 in Franklin County shall be designated as the "Marc Perez Memorial

- 3 Bridge". The department of transportation shall erect and maintain
- 4 appropriate signs designating such bridge, with the costs of such
- 5 designation to be paid for by private donations.

227.332. The bridge on Highway 185 crossing over Interstate 44

- 2 in Franklin County shall be designated the "James K. Schatz Memorial
- Bridge". The department of transportation shall erect and maintain
- 4 appropriate signs designating the bridge with the costs for such
- 5 designation to be paid by private donation.

227.344. The portion of Interstate Highway 49 in Newton County

- 2 from the intersection of Highway 60 to the Newton-McDonald County
- 3 line shall be designated the "James B. Tatum Highway". The department
- 4 of transportation shall erect and maintain appropriate signs
- 5 designating such highway with the costs to be paid by private
- 6 donations.

227.382. The portion of Interstate 55 in St. Louis County and

- 2 Jefferson County between Meramec Bottom Road and Highway 141
- 3 shall be designated the "Police Officer Steven Jarvis Memorial
- 4 Highway". The department of transportation shall erect and maintain
- 5 appropriate signs designating such highway with the costs to be paid
- 6 by private donations.

227.399. The portion of U.S. Highway 54 in Cole County from the

- 2 Hammann Drive intersection to a location one mile south of such
- 3 intersection shall be designated the "Billy Dean Robinett Memorial
- 4 Highway". The department of transportation shall erect and maintain
- 5 appropriate signs designating such highway, with the cost of such signs
- 6 to be paid by private donations.

227.401. The bridge on East Stadium Drive crossing over

- 2 Interstate 435 in Jackson County shall be designated the "Len Dawson
- 3 Bridge". The department of transportation shall erect and maintain
- 4 appropriate signs designating the bridge, with the costs for such
- 5 designation to be paid for by private donation.

227.450. The portion of U.S. Highway 60 from the intersection of

- 2 State Route O to the intersection of State Highway 5 in Wright County
- 3 shall be designated the "Spc. Justin Blake Carter Memorial Highway for
- 4 Life". The department of transportation shall erect and maintain
- 5 appropriate signs designating such highway, with the costs to be paid

227.504. The bridge on U.S. Highway 160 crossing over Lick 2 Creek in Ozark County shall be designated the "Barney Douglas (The 3 Citizen) Memorial Bridge". The department of transportation shall 4 erect and maintain appropriate signs designating the bridge, with the 5 costs for such designation to be paid for by private donation.

227.507. The portion of U.S. Highway 54 from the intersection of County Road 557 to the intersection of County Road 577 in Audrain County shall be designated the "Officer Orville Rosenstengel Memorial Highway". The department of transportation shall erect and maintain appropriate signs designating such highway with the costs paid by private donations.

227.520. The portion of U.S. Highway 54 from the Kansas/Missouri
2 state line east to the Missouri/Illinois state line shall be designated the
3 "Discover More on Route 54" Highway. The department of
4 transportation shall erect and maintain appropriate signs designating
5 such highway, with the cost to be paid for by private donations.
