6	"135.2000. 1. As used in this section, the following terms mean:
7	(1) "Commissioner", the commissioner of education for the department of elementary and
8	secondary education;
9	(2) "Contribution", a donation of cash;
10	(3) "Fund", the foster child education fund established in section 210.1500;
11	(4) "State tax liability", in the case of a business taxpayer, any liability incurred by such
12	taxpayer under the provisions of chapters 143, 147, 148, and 153, excluding sections 143.191 to
13	143.265 and related provisions, and in the case of an individual taxpayer, any liability incurred by
14	such taxpayer under the provisions of chapter 143, excluding sections 143.191 to 143.265 and
15	related provisions;
16	(5) "Tax credit", a credit against the taxpayer's state tax liability;
17	(6) "Tax credit certificate", a certificate evidencing a taxpayer's right to receive a tax credit;
18	(7) "Taxpayer", a person, firm, partner in a partnership, member in a limited liability
19	company, shareholder in an S corporation, or a corporation doing business in the state of Missouri
20	and subject to the state income tax imposed by the provisions of chapter 143, or a corporation subject
21	to the annual corporation franchise tax imposed by the provisions of chapter 147, or an insurance
22	company paying an annual tax on its gross premium receipts in this state, or other financial
23	institution paying taxes to the state of Missouri or any political subdivision of this state under the
24	provisions of chapter 148, or an express company which pays an annual tax on its gross receipts in
25	this state under chapter 153, or an individual subject to the state income tax imposed by the
26	provisions of chapter 143, or any charitable organization which is exempt from federal income tax
27	and whose Missouri unrelated business taxable income, if any, would be subject to the state income
28	tax imposed under chapter 143.
29	2. (1) Subject to the provisions of subsection 5 of this section, any contribution to the fund
30	made on or after January 1, 2016, shall be eligible for a tax credit as provided by this section.

1	receive a tax credit against the taxpayer's state tax liability in an amount equal to sixty-five percent of
2	the amount such taxpayer contributed to the fund evidenced by a tax credit certificate.
3	3. The commissioner shall be responsible for the administration and issuance of tax credit
4	certificates authorized by this section.
5	4. The amount of the tax credit claimed shall not exceed fifty percent of the taxpayer's state
6	tax liability for the taxable year for which the credit is claimed, and such taxpayer shall not be
7	allowed to claim a tax credit in excess of twenty-five thousand dollars per taxable year. Any amount
8	of credit that the taxpayer is prohibited by this section from claiming in a taxable year shall not be
9	refundable. However, any tax credit that cannot be claimed in the taxable year in which the
10	contribution was made may be carried over to the next three succeeding taxable years until the full
11	credit has been claimed.
12	5. Except for any excess credit which is carried over under subsection 4 of this section, a
13	taxpayer shall not be allowed to claim a tax credit unless the amount of such taxpayer's contribution
14	to the fund in such taxpayer's taxable year has a value of one hundred dollars or more, up to a
15	maximum of fifty thousand dollars. Any excess of a contribution above fifty thousand dollars or
16	contribution less than one hundred dollars shall be ineligible to receive a tax credit under this section.
17	6. The total amount of tax credits authorized under the provisions of this section shall not
18	exceed five million dollars in any fiscal year. The total amount of tax credits issued but not
19	redeemed shall not exceed fifteen million dollars in any fiscal year. Tax credits shall be issued in the
20	order contributions are received.
21	7. Tax credits issued under this section may not be transferred, sold, or assigned.
22	8. The department of elementary and secondary education may promulgate rules to

There is hereby created in the state treasury the "Foster Child Education Fund", which 4 shall consist of moneys collected from donations made under section 135.2000. The state treasurer 5 shall be custodian of the fund. In accordance with sections 30.170 and 30.180, the state treasurer 6 may approve disbursements. The fund shall be a dedicated fund and, upon appropriation, moneys in 7 the fund shall be used solely for the purposes of providing scholarships to eligible recipients to 8 attend a qualified school. Notwithstanding the provisions of section 33.080 to the contrary, any 9 moneys remaining in the fund at the end of the biennium shall not revert to the credit of the general 10 revenue fund. The state treasurer shall invest moneys in the fund in the same manner as other funds are invested. Any interest and moneys earned on such investments shall be credited to the fund. 11 12 3. Any eligible recipient who receives a scholarship under the provisions of this section shall 13 continue to be eligible to receive his or her scholarship upon a legal adoption. 14 4. In the event an eligible recipient who receives a scholarship under the provisions of this 15 section graduates from the qualified school to which he or she first received a scholarship, the 16 eligible recipient shall remain eligible to receive a scholarship under this section to a new qualified 17 school. 18 5.
