- 2. The use of any physical force in making an arrest is not justified under this section unless the arrest is lawful or the law enforcement officer reasonably believes the arrest is lawful.
- 3. A law enforcement officer in effecting an arrest or in preventing an escape from custody is justified in using deadly force only
 - (1) When such is authorized under other sections of this chapter; or
- (2) When [he reasonably believes that such use of deadly force is immediately necessary to effect the arrest and also] all other reasonable means of apprehension have been exhausted or are unavailable, the officer has given notice of the officer's identity as such and a warning that deadly force may be used unless resistance or flight ceases, and the officer reasonably believes that the person to be arrested

- "650.467. 1. There is hereby established in the department of public safety a "Task Force On The Use Of Force By A Law Enforcement Officer". The task force shall focus its efforts clarifying the use of force allowed by law enforcement officers, under section 563.046, in a county with a charter form of government and with more than nine hundred fifty thousand inhabitants.
- 2. The task force shall have a membership of nine persons appointed by the director of public safety. Membership may include, but not be limited to, the following:
 - (1) A person from the POST commission:
 - (2) A former sheriff, chief of police, deputy sheriff, or deputy chief of police;
 - (3) An assistant attorney general;
 - (4) A retired judge;

- (5) A licensed attorney with experience in criminal defense who is in no way involved in prosecuting crimes; and
- (6) A former prosecuting attorney or assistant prosecuting attorney who served in that capacity for at least ten years.
- 3. The director of the department of public safety or the director's designee shall convene the first meeting of the task force for the purpose of establishing the bylaws of the task force and electing officers to include a chairperson, vice chairperson, and secretary. The task force shall not meet more than four times annually. Members may be reimbursed for expenses but shall not receive a per-diem allowance."; and
