1 AMEND House Committee Substitute for House Bill No. 742, Page 1, In the Title, Line 3, by
2 deleting the words "academic performance standards" and inserting in lieu thereof the words
3 "elementary and secondary education"; and

5 Further amend said bill, Page 6, Section 161.855, Line 66, by inserting after all of said line the
6 following:

8 "161.960. 1. There is hereby established in the department of elementary and secondary
9 education a "Council for Community Education".

10 2. The council shall have a membership of eleven persons, appointed by the governor.
11 Membership may include, but not be limited to, representatives of the following groups:

12 (1) Civic organizations;

13 (2) Community-based organizations;

14 (3) Community education organizations;

15 (4) Local government;

16 (5) Local school district administrators;

17 (6) Parent organizations;

18 (7) Post-secondary education;

19 (8) School boards; and

20 (9) Teachers.

21 3. The commissioner of education or the commissioner's designee shall convene the first
22 meeting of the council for the purpose of establishing the bylaws of the council and electing officers
23 to include a chairperson, vice chairperson, and secretary. The council shall not meet more than four
24 times annually. Members may be reimbursed for expenses but shall not receive a per diem
25 allowance.

26 4. The council shall:

27 (1) Conduct feasibility studies on the establishment of community education programs
28 within the state;

29 (2) Advise the commissioner of education and the department of education on issues relating
30 to the establishment of community education programs;

31 (3) Make recommendations for a state plan for community education which sets forth the

1 goals and objectives of a community schools program and establishes a system of priorities for
2 targeting available resources on the areas with the greatest need within a school district; and

3 (4) Make recommendations for the funding of local community education programs.

4 5. For purposes of this section, "community school", means a school that makes its facilities
5 available for citizen use, coordinates activities of local citizens in identifying program needs and
6 establishing priorities, identifies and utilizes available program resources, and assists in the initiation
7 of programs to improve the cultural, social, recreational, and educational opportunities available in a
8 community. "Community education program", means a program in which a public building,
9 including a public elementary or secondary school, is used as a community center operated by a
10 school board in cooperation with other groups in the community, community organizations, and local
11 governmental agencies to provide educational, recreational, cultural, health care, and other related
12 community services in accordance with the needs, interests, and concerns of the community.

13 161.965. 1. There is hereby established in the department of elementary and secondary
14 education a "Task Force on School Safety Improvement".

15 2. The task force shall have a membership of eleven persons, appointed by the commissioner
16 of the department of elementary and secondary education. Membership may include, but not be
17 limited to, representatives of the following groups:

18 (1) Licensed attorneys with experience in criminal defense who are in no way involved in
19 prosecuting crimes;

20 (2) Community-based organizations;

21 (3) Community education organizations;

22 (4) Law enforcement agencies, including at least one representative from a city not within a
23 county, a county with a charter form of government and with more than nine hundred fifty thousand
24 inhabitants, or a home rule city with more than four hundred thousand inhabitants and located in
25 more than one county;

26 (5) Local government;

27 (6) Local school district administrators;

28 (7) Parent organizations;

29 (8) Postsecondary education;

30 (9) School boards; and

31 (10) Teachers.

32 3. The commissioner of education or the commissioner's designee shall convene the first
33 meeting of the task force for the purpose of establishing the bylaws of the task force and electing
34 officers to include a chairperson, vice chairperson, and secretary. The task force shall not meet more
35 than four times annually. Members may be reimbursed for expenses but shall not receive a per diem
36 allowance.

37 4. The task force shall conduct studies on:

38 (1) School security features and practices schools and law enforcement officers can take to
39 decrease the likelihood that an event or crisis will occur;

40 (2) Actions schools and law enforcement officers can take to eliminate or reduce the loss of
41 life and property damage related to an event or crisis;

1 (3) The establishment of programs within schools to provide instruction in grades seven
2 through twelve on the criminal justice system and make curriculum recommendations for such
3 programs, including recommendations on specific curriculum designed to educate students about
4 career opportunities in law enforcement; and

5 (4) The practicality and need for the appointment of a director of school safety in a county
6 with a charter form of government and with more than nine hundred fifty thousand inhabitants."; and

9 Further amend said bill by amending the title, enacting clause, and intersectional references
