1 AMEND House Committee Substitute for Senate Bill No. 148, Page 8, Section 274.190, Line 10, by
2 inserting after all of said section and line the following:

4 "311.091. 1. Except as provided under subsection 2 of this section and notwithstanding any
5 other provisions of this chapter to the contrary, any person who possesses the qualifications required
6 by this chapter and who meets the requirements of and complies with the provisions of this chapter
7 may apply for and the supervisor of alcohol and tobacco control may issue a license to sell
8 intoxicating liquor, as defined in this chapter, by the drink at retail for consumption on the premises
9 of any boat, or other vessel licensed by the United States Coast Guard to carry [one hundred] thirty
10 or more passengers for hire on navigable waters in or adjacent to this state, which has a regular place
11 of mooring in a location in this state or within two hundred yards of a location which would
12 otherwise be licensable under this chapter. The license shall be valid even though the boat, or other
13 vessel, leaves its regular place of mooring during the course of its operation.

14 2. [Any person who possesses the qualifications required by this chapter and who meets the
15 requirements of, and complies with the provisions of, this chapter may apply for, and the supervisor
16 of alcohol and tobacco control may issue, a license to sell intoxicating liquor by the drink at retail for
17 consumption on the premises of any boat or other vessel licensed by the United States Coast Guard
18 to carry forty-five to ninety-nine passengers for hire on a lake with a shoreline that is in three
19 counties, one of which is any county of the third classification without a township form of
20 government and with more than thirty-three thousand but fewer than thirty-seven thousand
21 inhabitants and with a city of the fourth classification with more than three thousand but fewer than
22 three thousand seven hundred inhabitants as the county seat, one of which is any county of the third
23 classification without a township form of government and with more than twenty-nine thousand but
24 fewer than thirty-three thousand inhabitants and with a city of the fourth classification with more
25 than four hundred but fewer than four hundred fifty inhabitants as the county seat, and one of which
26 is any county of the first classification with more than fifty thousand but fewer than seventy
27 thousand inhabitants. The boat must have a regular place of mooring in a location in this state or
28 within two hundred yards of a location which would otherwise be licensable under this chapter. The
29 license shall be valid even though the boat, or other vessel, leaves its regular place of mooring during
30 the course of its operation.
