1 AMEND House Committee Substitute for Senate Committee Substitute for Senate Bill No. 456,
2 Page 1, in the Title, Line 3, by deleting the words "ownership of motor vehicles" and inserting in lieu
3 thereof the word "transportation"; and

5 Further amend said bill, Page 9, Section 301.190, Line 167, by inserting immediately after said line
6 the following:

8 "301.196. 1. Beginning January 1, 2006, except as otherwise provided in this section, the
9 transferor of an interest in a motor vehicle or trailer listed on the face of a Missouri title, excluding
10 salvage titles and junking certificates, shall notify the department of revenue of the transfer within
11 thirty days of the date of transfer. The notice shall be in a form determined by the department by
12 rule and shall contain:

13 (1) The name of the transferor and transferee;

14 (2) A description of the motor vehicle or trailer sufficient to identify it;

15 [(2)] (3) The vehicle identification number of the motor vehicle or trailer;

16 [(3)] (4) The name and address of the transferee;

17 [(4)] (5) The date of birth of the transferee, unless the transferee is not a natural person;

18 [(5)] (6) The date of the transfer or sale;

19 [(6)] (7) The purchase price of the motor vehicle or trailer, if applicable;

20 [(7)] (8) The number of the transferee's drivers license, unless the transferee does not have a
21 drivers license;

22 [(8) The printed name and signature] (9) The transferor's electronic signature if transmitted
23 electronically or the signatures of the transferee and transferor if not submitted electronically. For
24 the purposes of this section, "transmitted electronically" shall have the same meaning as an
25 electronic signature as defined in section 432.205;

26 [(9)] (10) Any other information required by the department by rule.

27 2. A notice of sale substantially complying with the requirements of this section is effective
28 even though it contains minor errors which are not materially misleading.

29 3. For purposes of giving notice under this section, if the transfer occurs by operation of law,
30 the personal representative, receiver, trustee, sheriff, or other representative or successor in interest
31 of the person whose interest is transferred shall be considered the transferor. Repossession by a
32 creditor shall not be considered a transfer of ownership requiring such notice.

33 [3.] 4. The requirements of this section shall not apply to transfers when there is no complete
34 change of ownership interest or upon award of ownership of a motor vehicle or trailer made by court
35 order, or transfers of ownership of a motor vehicle or trailer to or between vehicle dealers, or
36 transfers of ownership of a motor vehicle or trailer to an insurance company due to a theft or casualty

1 loss, or transfers of beneficial ownership of a motor vehicle owned by a trust.

2 [4.] 5. Notification under this section is only required for transfers of ownership that would
3 otherwise require registration and an application for certificate of title in this state under section
4 301.190, and is for informational purposes only and does not constitute an assignment or release of
5 any interest in the vehicle.

6 [5.] 6. Retail sales made by licensed dealers including sales of new vehicles shall be reported
7 pursuant to the provisions of section 301.280."; and

9 Further amend said bill by amending the title, enacting clause, and intersectional references
10 accordingly.
