1 AMEND House Committee Substitute for Senate Committee Substitute for Senate Bill No. 322,
2 Page 7, Section 208.010, Line 210, by inserting immediately after said line the following:

4 "208.024. 1. Eligible recipients of temporary assistance for needy families (TANF) or
5 [supplementary] supplemental nutrition assistance program (SNAP) benefits shall not use such funds
6 in any electronic benefit transfer transaction in any liquor store, casino, gambling casino, or gaming
7 establishment, any retail establishment which provides adult-oriented entertainment in which
8 performers disrobe or perform in an unclothed state for entertainment, or in any place for the
9 purchase of alcoholic beverages, lottery tickets, pornography, or tobacco products or for any item the
10 department determines by rule is primarily marketed for or used by adults eighteen or older and is
11 not in the best interests of the child or household. An eligible recipient of TANF or SNAP assistance
12 who makes a purchase in violation of this section shall reimburse the department of social services
13 for such purchase. For any third or subsequent offense, a TANF recipient shall lose his or her TANF
14 benefits for a period of two years.

15 2. An individual, store owner or proprietor of an establishment shall not knowingly accept
16 TANF cash assistance or supplementary nutrition assistance program (SNAP) funds held on
17 electronic benefit transfer cards for the purchase of alcoholic beverages, lottery tickets, pornography,
18 or tobacco products or for use in any electronic benefit transfer transaction in any liquor store,
19 casino, gambling casino, or gaming establishment, any retail establishment which provides
20 adult-oriented entertainment in which performers disrobe or perform in an unclothed state for
21 entertainment, or in any place for the purchase of alcoholic beverages, lottery tickets, pornography,
22 or tobacco products or for any item the department determines by rule is primarily marketed for or
23 used by adults eighteen or older and is not in the best interests of the child or household. No store
24 owner or proprietor of any liquor store, casino, gambling casino, gaming establishment, or any retail
25 establishment which provides adult-oriented entertainment in which performers disrobe or perform
26 in an unclothed state for entertainment shall adopt any policy, either explicitly or implicitly, which
27 encourages, permits, or acquiesces in its employees knowingly accepting electronic benefit transfer
28 cards in violation of this section. [This section shall not be construed to require any store owner or
29 proprietor of an establishment which is not a liquor store, casino, gambling casino, gaming
30 establishment, or retail establishment which provides adult-oriented entertainment in which
31 performers disrobe or perform in an unclothed state for entertainment to check the source of payment

1 from every individual who purchases alcoholic beverages, lottery tickets, tobacco products, or any
2 item the department determines by rule is primarily marketed for or used by adults eighteen or older
3 and is not in the best interests of the child or household.] An individual, store owner or proprietor of
4 an establishment who knowingly accepts electronic benefit transfer cards in violation of this section
5 shall be punished by a fine of not more than five hundred dollars for the first offense, a fine of not
6 less than five hundred dollars nor more than one thousand dollars for the second offense, and a fine
7 of not less than one thousand dollars for the third or subsequent offense.

8 3. Any recipient of TANF or SNAP benefits who does not make at least one electronic
9 benefit transfer transaction within the state for a period of ninety days shall have his or her benefit
10 payments to the electronic benefit account temporarily suspended, pending an investigation by the
11 department of social services to determine if the recipient is no longer a Missouri resident. If the
12 department finds that the recipient is no longer a Missouri resident, it shall close the recipient's case.
13 Closure of a recipient's case shall trigger the automated benefit eligibility process under section
14 208.238. A recipient may appeal the closure of his or her case to the director under section 208.080.

15 4. A recipient who does not make an electronic benefit transfer transaction within the state
16 for a period of sixty days shall be provided notice of the possibility of the suspension of funds if no
17 electronic benefit transfer transaction occurs in the state within another thirty days after the date of
18 the notice.

19 5. The total amount of cash benefits accessed by a TANF or SNAP benefits recipient with his
20 or her electronic benefit transfer (EBT) card from an ATM, as cash back on a purchase, and through
21 any other means of accessing cash from an EBT card shall not exceed forty dollars per month.

22 6. For purposes of this section:

23 (1) The following terms shall mean:

24 (a) "Electronic benefit transfer transaction", the use of a credit or debit card service,
25 automated teller machine, point-of-sale terminal, or access to an online system for the withdrawal of
26 funds or the processing of a payment for merchandise or a service; [and]

27 (b) "Liquor store", any retail establishment which sells exclusively or primarily intoxicating
28 liquor. Such term does not include a grocery store which sells both intoxicating liquor and groceries
29 including staple foods as outlined under the Food and Nutrition Act of 2008;

30 (c) "Pornography", any of the following:

31 a. Any obscene material or performance depicting sexual conduct, sexual contact as defined
32 in section 566.010, or a sexual performance; or

33 b. Any visual depiction, including any photograph, film, video, picture, or computer or
34 computer-generated image or picture, whether made or produced by electronic, mechanical, or other
35 means, of sexually explicit conduct; and

36 (d) "Tobacco products", cigarettes, cigarette papers, cigars, smokeless tobacco, smoking
37 tobacco, vapor products, or any other form of tobacco products or products made with tobacco
38 substitute containing nicotine;

39 (2) Casinos, gambling casinos, or gaming establishments shall not include:

40 (a) A grocery store which sells groceries including staple foods, and which also offers, or is
41 located within the same building or complex as a casino, gambling, or gaming activities; or

1 (b) Any other establishment that offers casino, gambling, or gaming activities incidental to
2 the principal purpose of the business."; and

4 Further amend said bill, page 8, section 208.065, line 27, by inserting immediately after said line the
5 following:

6 "[208.182. 1. The family support division shall establish pilot projects in St.
7 Louis City and in any county with a population of six hundred thousand or more,
8 which shall provide for a system of electronic transfer of benefits to public assistance
9 recipients. Such system shall allow recipients to obtain cash from automated teller
10 machines or point of sale terminals. If less than the total amount of benefits is
11 withdrawn, the recipient shall be given a receipt showing the current status of his or
12 her account.

13 2. The disclosure of any information provided to a financial institution, business or
14 vendor by the family support division under this section is prohibited. Such financial
15 institution, business or vendor may not use or sell such information and may not
16 divulge the information without a court order. Violation of this subsection is a class A
17 misdemeanor.

18 3. Subject to appropriations and subject to receipt of waivers from the federal
19 government to prevent the loss of any federal funds, the department of social services
20 shall require the use of photographic identification on electronic benefit transfer cards
21 issued to recipients in this system. Such photographic identification electronic benefit
22 transfer card shall be in a form approved by the department of social services.

23 4. The family support division shall promulgate rules and regulations necessary to
24 implement the provisions of this section pursuant to section 660.017 and chapter 536.

25 5. The delivery of electronic benefits and the electronic eligibility
26 verification, including, but not limited to, aid to families with dependent children
27 (AFDC), women, infants and children (WIC), early periodic screening diagnosis and
28 treatment (EPSDT), food stamps, supplemental security income (SSI), including
29 Medicaid, child support, and other programs, shall reside in one card that may be
30 enabled by function from time to time in a convenient manner.] "; and
