#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials at the **Department of Higher Education**, **Lincoln University**, **Metropolitan Community College**, **Missouri Southern State University**, **State Fair Community College**and the **University of Missouri** each assume there is no fiscal impact to their respective organizations from this proposal.

Officials at the **Missouri State University** assume this would negatively impact the University due to the implementation costs. However, the specific amount and extent is unknown at this time.

Officials at the **University of Central Missouri** estimate an impact of \$100,000 annually in increased costs to open and staff an office to administer procedures needed to ensure compliance.

Officials at the **State Technical College of Missouri** (**STC**) assume there would be time involved with current staff reviewing current policies to make sure that current policies satisfy all specifics in proposed legislation, but would appear that we could absorb these costs by utilizing the current staff. It appears that there would be no significant financial impact to STC at this time.

Officials at the **Missouri Western State University** assume that with regard to any potential financial implications, there does not appear to be any impact to the University unless there is a financial penalty assessed to an institution that is determined to have provided favoritism.

Officials at the **Moberly Area Community College** assume this proposal may cost the College \$600 -\$2,000 in the initial year of implementation and \$200 - \$1,000 annually thereafter.

Officials at the **Truman State University** assume they are unable to determine the impact at this time.

Officials at the **Joint Committee on Administrative Rules** assume there is no fiscal impact from this proposal.

Officials from the **Office of the Secretary of State (SOS)** state many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$2,500. The SOS recognizes that

this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with the core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

**Oversight** assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could request funding through the appropriation process.

Officials at the following colleges: Crowder, East Central Community College, Harris-Stowe, Jefferson College, Northwest Missouri State University, Southeast Missouri State University, St. Charles Community College, St. Louis Community College and the Three Rivers Community College did not respond to **Oversight's** request for fiscal impact.

**Oversight** assumes that the colleges and universities have staff that could review existing policies for compliance with these provisions or could create new policies on student favoritism. Oversight assumes the colleges and universities could absorb this proposal with existing resources.
