FISCAL ANALYSIS

ASSUMPTION

Oversight was unable to receive some of the agency responses in a timely manner due to the short fiscal note request time. Oversight has presented this fiscal note on the best current information that we have or on prior year information regarding a similar bill. Upon the receipt of agency responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval of the chairperson of the Joint Committee on Legislative Research to publish a new fiscal note.

In response to a similar proposal, SB 360, Oversight received the following responses:

Officials from the **Attorney General's Office** assumed that any potential costs arising from this proposal can be absorbed with existing resources.

Officials from the **Office of the State Courts Administrator** and the **Administrative Hearing Commission** each assumed the proposal would not fiscally impact their respective agencies.

Officials from the **Department of Insurance, Financial Institutions and Professional Registration** stated it is unknown how many civil justice funding companies may need to be registered with the state. The department believes it can absorb the potential registration for a small number of entities. However, should the number of entities be greater than anticipated, or there are a large number of hearings, the department would request additional appropriation and/or FTE through the budget process.

Oversight assumes income of less than \$100,000 from applications and renewals in Section 436.570, RSMo.
