FISCAL ANALYSIS

ASSUMPTION

Officials at the Platte County Board of Election Commission, the Jackson County Board of Election Commission, the St. Louis County Board of Election Commission, the Callaway County Commission and St. Louis County each assume no fiscal impact to their respective entities from this proposal.

In response to a previous version, officials at the **Central County Fire and Rescue District** assumed no fiscal impact from this proposal.

Oversight assumes this proposal prohibits ambulance and fire protection district board members from being hired by the board within 12 months of serving on the board. Oversight assumes there would be no cost associated with this proposal.

House Amendment 1

Oversight assumes House Amendment 1 will have no fiscal impact. Cities will levy and collect property taxes and pay a portion of the collected property taxes to the fire protection districts on an annual basis. Oversight assumes this distribution of revenue and cost will net to zero.
