FISCAL ANALYSIS

ASSUMPTION

Oversight was unable to receive some of the agency responses in a timely manner due to the short fiscal note request time. Oversight has presented this fiscal note on the best current information that we have or on prior year information regarding a similar bill. Upon the receipt of agency responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval of the chairperson of the Joint Committee on Legislative Research to publish a new fiscal note.

Officials at the **Office of the State Courts Administrator** assume the proposed legislation requires any juvenile certified as an adult be detained in a juvenile facility until the juvenile has been sentenced. While it is not possible to quantify the impact of this change exactly, there should not be any significant impact. Policies and procedures would have to be modified, but we do have the bed space in most circuits as well as the staffing ratio. There are some smaller circuits that would not be able to handle the youth based on layout of the facility or type of staff they have trained. There will possibly be some cost with housing older violent offenders with younger juvenile offenders. Certified youth may be 17-18-19 years old before sentencing and possibly older.

Officials at the **Department of Mental Health**, the **Office of Prosecution Services** and the **Department of Corrections** each assume no fiscal impact to their respective agencies from this proposal.
