#### FISCAL ANALYSIS

#### ASSUMPTION

**Oversight** was unable to receive some of the agency responses in a timely manner due to the short fiscal note request time. Oversight has presented this fiscal note on the best current information that we have or on prior year information regarding a similar bill. Upon the receipt of agency responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval of the chairperson of the Joint Committee on Legislative Research to publish a new fiscal note.

**Oversight** notes in response to similar legislation from the current session, HB 113, agencies provided the following responses:

In response to HB 113, officials from the **University of Missouri Health Care System (UM)** state they have reviewed the proposed legislation and determined that there is an unquantifiable potential negative fiscal impact to UM in excess of \$100,000 annually. The potential impact is uncertain due to the nature of the proposed legislation and the impact on patients that may have no source for payment of these services.

**Oversight** notes the provisions of the proposal do not require a health care facility, nursing home, or physician to have a written policy relating to life-sustaining or non-beneficial treatment for patients (minor or adult), residents, or wards. However, paragraph 4 provides "No facility shall withhold life-sustaining procedures, food, medication, or nutrition, nor place any restrictions on life-sustaining procedures...for any minor patient, resident or ward without the written permission of at least one parent or legal guardian of the minor patient or ward."

Oversight assumes if one incident involving a minor patient occurred in a fiscal year where a parent or legal guardian for the minor was not available, insurance denied payment for a life-sustaining procedure, or the hospital could not get the signature of one parent/guardian to withhold life-sustaining procedures or medication, that costs would exceed \$100,000. Therefore, for fiscal note purposes, Oversight will present the fiscal impact of Unknown, greater than \$100,000 annually as an impact to University Funds.

In response to HB 113, officials from the **Department of Health and Senior Services**, the **Department of Insurance, Financial Institutions and Professional Registration**, and the **Department of Social Services**, **MO HealthNet Division**, the **Division of Legal Services**, **Missouri Medicaid Audit Compliance**, and the **Children's Division** each assumed the proposal would not fiscally impact their respective agencies.

Officials from the **Department of Mental Health** and the **Office of State Courts Administrator** each assume the proposal would not fiscally impact their respective agencies. L.R. No. 2094-02 Bill No. SB 466 Page 4 of 6 March 18, 2015

# FISCAL IMPACT - Small Business

This proposal could have a negative fiscal impact on small business health care facilities, nursing homes or other health care facilities that may have to provided life sustaining or nonbeneficial treatment to minors.

# FISCAL DESCRIPTION

This proposal requires health care facilities, nursing homes, and physicians to disclose to patients, residents, prospective patients or residents, or parents or legal guardians of minor patients or residents, in writing, any existing policies relating to life-sustaining or nonbeneficial treatment. Additionally, health care facilities, nursing homes, physicians, nurses, or medical staff shall not withhold or restrict life-sustaining procedures, food, medication, or nutrition without the written permission of at least one parent or legal guardian of a minor patient or ward. Do-not-resuscitate orders or similar physician's orders shall not be instituted without the written permission of at least one parent or legal guardian of the minor patient or resident.

# FISCAL DESCRIPTION (continued)

This proposal shall not interfere with the rights of a physician, nurse, other health care provider, or employee of a health care facility to refuse to honor a health care decision withholding or withdrawing life-sustaining treatment if such refusal is based on the individual's religious beliefs or moral convictions.

This proposal prohibits health care facilities, nursing homes, physicians, nurses, or medical staff from denying a patient, resident, or prospective patient or resident life-sustaining treatment that is provided to other patients or residents for the following reasons: (1) on the basis of a view that extending the life of an elderly, disabled, or terminally ill individual is of lower value than extending the life of a younger, able, or not terminally ill individual; or (2) on the basis of a disagreement with how the patient or resident values the trade-off between extending their life and the risk of disability.

This proposal also provides that minors with developmental disabilities shall not be deemed ineligible for an organ transplant solely because of that developmental disability, unless a physician, following an individualized evaluation of the potential recipient, deems that developmental disability to be medically significant.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
