AN ACT

To amend chapter 227, RSMo, by adding thereto eight new sections relating to highway designations.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Chapter 227, RSMo, is amended by adding thereto eight new
2 sections, to be known as sections 227.380, 227.417, 227.423, 227.428, 227.523,
3 227.524, 227.525, and 227.526, to read as follows:

**227.380. The portion of State Highway 115 in St. Louis City from the
2 intersection of Natural Bridge Avenue and Salisbury Street west to the
3 intersection of State Highway 115 and Jennings Station Road shall be
4 designated the "Theodore McNeal Highway". Cost for such designation
5 shall be paid by private donations.**

**227.417. The portion of U.S. Highway 160 in Ozark County from the
2 bridge that crosses Bryant Creek to a location two and one-half miles east
3 of such bridge shall be known as the "Jerry Corp Memorial Highway". The
4 costs for such designation shall be paid by private donations.**

**227.423. The bridge on State Highway 19 crossing over the Meramec
2 River in Crawford County between the cities of Cuba and Steelville shall
3 be designated as the "Betty Vickers Memorial Bridge". The department of
4 transportation shall erect and maintain appropriate signs designating such
5 bridge, with the costs of such designation to be paid for by private
6 donations.**

**227.428. The portion of Business Highway 71 from the Interstate 29
2 intersection traveling north for two miles and located in Andrew County
3 shall be designated as the "Randy Bever Memorial Highway". The**

4 department of transportation shall erect and maintain appropriate signs
5 designating such highway with the cost for such designation to be paid by
6 private donation.

227.523. The bridge on Highway CC crossing over North Fork White
2 River in Ozark County shall be designated the "Irwin C. Cudworth
3 Memorial Bridge". The department of transportation shall erect and
4 maintain appropriate signs designating such bridge, with the costs of such
5 designation to be paid for by private donations.

227.524. The portion of Highway 10 from the western border of the
2 city limits of Norborne in Carroll County to the eastern border of the city
3 limits of Hardin in Ray County shall be designated the "Ray-Carroll County
4 Veterans Memorial Highway". The department of transportation shall erect
5 and maintain appropriate signs designating such highway with costs to be
6 paid by private donations.

227.525. The portion of U.S. Highway 160 in Ripley County which is
2 located within the city limits of Doniphan shall be designated the "Billy
3 Yates Highway". The department of transportation shall erect and maintain
4 appropriate signs designating such highway, with the costs to be paid for
5 by private donation.

227.526. The portion of Highway 54 from the Grand Glaize Bridge in
2 Camden County to Key Largo Road in Camden County shall be designated
3 the "Veterans Memorial Expressway". The department of transportation
4 shall erect and maintain appropriate signs designating such highway with
5 costs to be paid by private donations.
