1 AMEND House Bill No. 1755, Page 1, in the Title, Lines 2-3, by removing the phrase "the 2 protection of parental rights" and insert in lieu thereof the word "minors"; and 3 4 Further amend said bill and page, Section 1.250, Line 11, by inserting immediately after said line 5 the following: 6 "431.056. 1. A minor shall be qualified and competent to contract for housing, 7 employment, purchase of an automobile, receipt of a student loan, admission to high school or 8 postsecondary school, obtaining medical care, establishing a bank account, admission to a shelter 9 for victims of domestic violence, as defined in section 455.200, or a homeless shelter, and receipt of services as a victim of domestic violence or sexual abuse, including but not limited to counseling, 10 11 court advocacy, financial assistance, and other advocacy services, if: 12 (1) The minor is sixteen or seventeen years of age; and 13 (2) The minor is homeless, as defined in subsection 1 of section 167.020, or a victim of 14 domestic violence, as defined in section 455.200, unless the child is under the supervision of the 15 children's division or the jurisdiction of the juvenile court; and 16 (3) The minor is self-supporting, such that the minor is without the physical or financial 17 support of a parent or legal guardian; and (4) The minor's parent or legal guardian has consented to the minor living independent of 18 19 the parents' or guardians' control. Such consent [may] shall be expressed [or implied, such that: 20 (a) Expressed consent is] consent. For purposes of this subdivision, "expressed consent" 21 means any [verbal or] written statement made by the parents or guardian of the minor displaying 22 approval or agreement that the minor may live independently of the parent's or guardian's control[; (b) Implied consent is any action made by the parent or guardian of the minor that indicates 23 24 the parent or guardian is unwilling or unable to adequately care for the minor. Such actions may include, but are not limited to: 25 26 a. Barring the minor from the home or otherwise indicating that the minor is not welcome to 27 stay; 28 b. Refusing to provide any or all financial support for the minor; or 29 c. Abusing or neglecting the minor, as defined in section 210.110 or committing an act or 30 acts of domestic violence against the minor, as defined in section 455.010]. 31 2. A minor who is sixteen years of age or older and who is in the legal custody of the 32 children's division pursuant to an order of a court of competent jurisdiction shall be qualified and 33 competent to contract for the purchase of automobile insurance with the consent of the children's 34 division or the juvenile court. The minor shall be responsible for paying the costs of the insurance premiums and shall be liable for damages caused by his or her negligent operation of a motor 35 vehicle.
