1 AMEND Senate Committee Substitute for Senate Bill No. 650, Page 1, In the Title, Line 3, by
2 deleting the words "higher education financial aid eligibility" and inserting in lieu thereof the words
3 "elementary and secondary education"; and

5 Further amend said bill, Page 4, Section 160.545, Line 119, by inserting after all of said section and
6 line the following:

8 "167.225. 1. As used in this section, the following terms mean:

9 (1) ["Blind persons", individuals who:

10 (a) Have a visual acuity of 20/200 or less in the better eye with conventional correction, or
11 have a limited field of vision such that the widest diameter of the visual field subtends an angular
12 distance not greater than twenty degrees; or

13 (b) Have a reasonable expectation of visual deterioration; or

14 (c) Cannot read printed material at a competitive rate of speed and with facility due to lack
15 of visual acuity] "Assessment", the National Reading Media Assessment or another research-based
16 assessment or series of research-based assessments authorized under the Individuals with
17 Disabilities Education Act that determines a student's reading and writing skills, needs, and
18 appropriate reading and writing media and addresses the student's academic and functional
19 strengths, deficits, as well as the student's current and future educational needs;

20 (2) "Braille", the system of reading and writing through touch [commonly known as
21 standard English Braille];

22 (3) "Student", any student who [is blind or any student eligible for special education
23 services for visually impaired as defined in P.L. 94-142] is eligible for special education services
24 under the Individuals with Disabilities Education Act and who:

25 (a) Has an impairment in vision that, even with correction, adversely affects a child's
26 educational performance;

27 (b) Has a reasonable expectation of visual deterioration; or

28 (c) Cannot read printed material at a competitive rate of speed and with facility due to lack
29 of visual acuity or field.

30 2. All students [may] shall receive instruction in Braille reading and writing as part of their
31 individualized education plan unless, as a result of an assessment, instruction in Braille or the use of
32 Braille is determined not appropriate for the student. No student shall be denied the opportunity of
33 instruction in Braille reading and writing solely because the student has some remaining vision.

34 3. Instruction in Braille reading and writing shall be sufficient to enable each student to
35 communicate effectively and efficiently at a level commensurate with his sighted peers of
36 comparable grade level and intellectual functioning. The student's individualized education plan

1 shall specify:

2 (1) How Braille will be implemented as the primary mode for learning through integration
3 with normal classroom activities. If Braille will not be provided to a child who is blind, the reason
4 for not incorporating it in the individualized education plan shall be documented therein;

5 (2) The date on which Braille instruction will commence;

6 (3) The level of competency in Braille reading and writing to be achieved by the end of the
7 period covered by the individualized education plan; and

8 (4) The duration of each session.

9 4. As part of the certification process, teachers certified in the education of blind and
10 visually impaired children shall be required to demonstrate competence in reading and writing
11 Braille. The department of elementary and secondary education shall adopt assessment procedures
12 to assess such competencies which are consistent with standards adopted by the National Library
13 Service for the Blind and Physically Handicapped, Library of Congress, Washington, D. C.

14 5. Under the Individuals with Disabilities Education Act or sections 162.959 to 162.963,
15 parents of students as defined under subdivision (3) of subsection 1 of section 167.255 shall have
16 the right to:

17 (1) An independent evaluation at public expense for any agency evaluation, including the
18 assessment established under subdivision (1) of subsection 1 of section 167.225;

19 (2) Mediation to allow parents and schools to resolve disagreements involving the IEP teams
20 determination of the need for Braille instruction;

21 (3) File a due process complaint with the department of elementary and secondary education
22 concerning the proposed action of the agency regarding provision of Braille instruction or any other
23 matter related to the provision of a free appropriate public education to the student which will be
24 forwarded to the Administrative Hearing Commission for an impartial hearing; and

25 (4) A resolution meeting convened by the school with the parent and the relevant members
26 of the IEP team who have specific knowledge of the facts identified in the due process complaint to
27 discuss the due process complaint and the facts that form the basis of the complaint so that the
28 school and parent have the opportunity to resolve the dispute."; and

30 Further amend said bill, Pages 4-5, Section B, Lines 1-5, by deleting all of said lines and inserting in
31 lieu thereof the following:

33 "Section B. Because of the importance of providing financial aid for Missouri high school
34 graduates, section 160.545 of section A of this act is deemed necessary for the immediate
35 preservation of the public health, welfare, peace, and safety, and is hereby declared to be an
36 emergency act within the meaning of the constitution, and section 160.545 of section A of this act
37 shall be in full force and effect upon its passage and approval."; and

39 Further amend said bill by amending the title, enacting clause, and intersectional references
40 accordingly.
