1 AMEND House Committee Substitute for Senate Bill No. 573, Page 1, Section 30.267, Line 5, by
2 inserting immediately after the word "operations" on said line the following: "in strategic
3 industries"; and

5 Further amend said page and section, Line 17, by inserting after all of said line the following:

7 "5. For purposes of this section, "strategic industries" shall include:

8 (1) Military equipment such as:

9 (a) Weapons;

10 (b) Arms;

11 (c) Military supplies; and

12 (d) Equipment, including but not limited to, radar systems, or military-grade transport
13 vehicles, that readily may be used for military purposes;

14 (2) Mineral extraction activities including:

15 (a) Exploring;

16 (b) Extracting;

17 (c) Processing;

18 (d) Transporting;

19 (e) Wholesale selling or trading of elemental minerals or associated metal alloys or oxides,
20 also known as ore, including gold, copper, chromium, chromite, diamonds, iron, iron ore,
21 silver, tungsten, uranium, and zing;

22 (f) Includes facilitating such activities, including by providing supplies or services in
23 support of such activities;

24 (3) Oil-related activities including but not limited to:

25 (a) Owning rights to oil blocks;

26 (b) Exporting, extracting, producing, refining, processing, exploring for, transporting,
27 selling, or trading of oil;

28 (c) Constructing, maintaining, or operating a pipeline, refinery, or other oil-field
29 infrastructure; or

30 (d) Facilitating such activities, including by providing supplies or services in support of
31 such activities, including by providing supplies or services in support of such activities.

33 "Oil-related activities" does not mean engaging in only the retail sale of gasoline and related
34 consumer products;

35 (4) Petroleum resources such as petroleum, petroleum byproducts, or natural gas;

36 (5) Power production including any business operation that involves a project

15 designated as state sponsors of terrorism, including Iran, Syria and Sudan, in the following
16 industries: military equipment, mineral extraction, oil-related activities, petroleum resources and
17 power production?"; and
