1 AMEND House Committee Substitute for Senate Bill No. 573, Page 1, Section 30.267, Line 5, by
2 inserting immediately after the word "operations" on said line the following: "in strategic
3 industries"; and

5 Further amend said page and section, Lines 15-17, by deleting said lines and inserting in lieu thereof
6 the following:

8 "4. For purposes of this section, "strategic industries" shall include:

9 (1) Military equipment such as:

10 (a) Weapons;

11 (b) Arms;

12 (c) Military supplies; and

13 (d) Equipment, including but not limited to, radar systems, or military-grade transport
14 vehicles, that readily may be used for military purposes;

15 (2) Mineral extraction activities including:

16 (a) Exploring;

17 (b) Extracting;

18 (c) Processing;

19 (d) Transporting;

20 (e) Wholesale selling or trading of elemental minerals or associated metal alloys or oxides,
21 also known as ore, including gold, copper, chromium, chromite, diamonds, iron, iron ore,
22 silver, tungsten, uranium, and zing;

23 (f) Includes facilitating such activities, including by providing supplies or services in
24 support of such activities;

25 (3) Oil-related activities including but not limited to:

26 (a) Owning rights to oil blocks;

27 (b) Exporting, extracting, producing, refining, processing, exploring for, transporting,
28 selling, or trading of oil;

29 (c) Constructing, maintaining, or operating a pipeline, refinery, or other oil-field
30 infrastructure; or

31 (d) Facilitating such activities, including by providing supplies or services in support of
32 such activities, including by providing supplies or services in support of such activities.

34 "Oil-related activities" does not mean engaging in only the retail sale of gasoline and related
35 consumer products;

36 (4) Petroleum resources such as petroleum, petroleum byproducts, or natural gas;

1 (5) Power production including any business operation that involves a project
2 commissioned by the national electricity corporation of the designated country or other similar
3 entity of the government of the designated county whose purpose is to facilitate power generation
4 and delivery, including but not limited to:
5 (a) Establishing power-generating plants or hydroelectric dams;
6 (b) Selling or installing components for a project;
7 (c) Providing service contracts related to the installation or maintenance of a project; or
8 (d) Facilitating any of these activities, including by providing supplies or services in support
9 of such activities."; and

11 Further amend said bill, Page 2, Section B, Line 6, by inserting immediately after all of said section
12 and line the following:

14 " Section C. Shall Missouri law be amended to prohibit the state, its political subdivisions, and
15 public retirement systems from investing in corporations doing business in countries currently
16 designated as state sponsors of terrorism, including Iran, Syria and Sudan, in certain strategic
17 industries?"; and

19 Further amend said bill by amending the title, enacting clause, and intersectional references
20 accordingly.
