1 AMEND House Bill No. 1478, Page 1, the title, Line 3, by removing "bonding requirements for
2 treasurers of seven-director"; and

4 Further amend said bill, said page, Section 162.401, Line 9, by inserting immediately after said line
5 the following:

7 "162.1265. 1. The department of elementary and secondary education shall develop and
8 implement a grant program to extend instructional time in underperforming districts for the purpose
9 of improving academic achievement including, but not limited to, early childhood education. The
10 grant program shall be known as the "Extended Learning Grant Program". The department shall
11 develop guidelines for grant applications and establish priorities for grant distribution. The amounts
12 awarded in grant moneys under this section shall be proportional to the amount the additional
13 instruction time exceeds the required minimum hours of attendance and average daily attendance
14 rate of the affected students. Notwithstanding any other provision of law, unaccredited districts and
15 provisionally accredited districts shall receive priority for grants awarded under this section.

16 2. There is hereby established in the state treasury a fund to be known as the "Extended
17 Learning Fund", which shall consist of all moneys that may be appropriated to it by the general
18 assembly, and in addition may include any gifts, contributions, grants, or bequests received from
19 federal, state, private, or other sources. The fund shall be administered by the department of
20 elementary and secondary education. The state treasurer shall be custodian of the fund and may
21 approve disbursements from the fund in accordance with sections 30.170 and 30.180. Upon
22 appropriation, moneys in the fund shall be used solely for the implementation of the extended
23 learning grant program. Notwithstanding the provisions of section 33.080 to the contrary, any
24 moneys remaining in the fund at the end of the biennium shall not revert to the credit of the general
25 revenue fund. The state treasurer shall invest moneys in the fund in the same manner as other funds
26 are invested. Any interest and moneys earned on such investments shall be credited to the fund.

27 3. Any rule or portion of a rule, as that term is defined in section 536.010, that is created
28 under the authority delegated in this section shall become effective only if it complies with and is
29 subject to all of the provisions of chapter 536 and, if applicable, section 536.028. This section and
30 chapter 536 are nonseverable, and if any of the powers vested with the general assembly pursuant to
31 chapter 536 to review, to delay the effective date, or to disapprove and annul a rule are subsequently
32 held unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted after
33 August 28, 2016, shall be invalid and void."; and

35 Further amend said bill by amending the title, enacting clause, and intersectional references
36 accordingly.
