1 AMEND House Committee Substitute for Senate Bill No. 831, Page 16, Section 324.004, Line 237,
2 by inserting immediately after all of said section and line the following:

4 "327.272. 1. A professional land surveyor shall include any person who practices in
5 Missouri as a professional land surveyor who uses the title of "surveyor" alone or in combination
6 with any other word or words including, but not limited to "registered", "professional" or "land"
7 indicating or implying that the person is or holds himself or herself out to be a professional land
8 surveyor who by word or words, letters, figures, degrees, titles or other descriptions indicates or
9 implies that the person is a professional land surveyor or is willing or able to practice professional
10 land surveying or who renders or offers to render, or holds himself or herself out as willing or able
11 to render, or perform any service or work, the adequate performance of which involves the special
12 knowledge and application of the principles of land surveying, mathematics, the related physical
13 and applied sciences, and the relevant requirements of law, all of which are acquired by education,
14 training, experience and examination, that affect real property rights on, under or above the land and
15 which service or work involves:

16 (1) The determination, location, relocation, establishment, reestablishment, layout, or
17 retracing of land boundaries and positions of the United States Public Land Survey System;

18 (2) The monumentation of land boundaries, land boundary corners and corners of the
19 United States Public Land Survey System;

20 (3) The subdivision of land into smaller tracts and preparation of property descriptions;

21 (4) The survey and location of rights-of-way and easements;

22 (5) Creating, preparing, or modifying electronic or computerized data relative to the
23 performance of the activities in subdivisions (1) to (4) of this subsection;

24 (6) Consultation, investigation, design surveys, evaluation, planning, design and execution
25 of surveys;

26 (7) The preparation of any drawings showing the shape, location, dimensions or area of
27 tracts of land;

28 (8) Monumentation of geodetic control and the determination of their horizontal and
29 vertical positions;

30 (9) Establishment of state plane coordinates;

31 (10) Topographic surveys and the determination of the horizontal and vertical location of
32 any physical features on, under or above the land;

33 (11) The preparation of plats, maps or other drawings showing elevations and the locations
34 of improvements and the measurement and preparation of drawings showing existing improvements
35 after construction;

36 (12) Layout of proposed improvements;

1 (13) The determination of azimuths by astronomic observations.

2 2. None of the specific duties listed in subdivisions (4) to (13) of subsection 1 of this section
3 are exclusive to professional land surveyors unless they affect real property rights. For the purposes
4 of this section, the term "real property rights" means a recordable interest in real estate as it affects
5 the location of land boundary lines. The validity of any document prepared between August 27,
6 2014, and August 28, 2015, by a provider of utility or communications services purporting to affect
7 real property rights shall remain valid and enforceable notwithstanding that any legal description
8 contained therein was not prepared by a professional land surveyor.

9 3. Professional land surveyors shall be in responsible charge of all drawings, maps, surveys,
10 and other work product that can affect the health, safety, and welfare of the public within their scope
11 of practice.

12 4. Nothing in this section shall be construed to preclude the practice of architecture or
13 professional engineering or professional landscape architecture as provided in sections 327.091,
14 327.181, and 327.600.

15 5. Nothing in this section shall be construed to preclude the practice of title insurance
16 business or the business of title insurance as provided in chapter 381, or to preclude the practice of
17 law or law business as governed by the Missouri supreme court and as provided in chapter 484."
