	2. Such teacher representative shall be an active classroom teacher. For purposes of this
_	section, "active classroom teacher" means a resident of the state of Missouri who is a full-time
_	eacher with at least five years of teaching experience in the state of Missouri, who is certified to
	each under the laws governing the certification of teachers in Missouri, and who is not on leave at
	the time of the appointment to the position of teacher representative. Such teacher representative
1	shall have the written support of the local school board prior to accepting the appointment.
	<u>3. The term of the teacher representative shall be four years and appointments made under</u>
	his section shall be made in rotation from each congressional district beginning with the first
<u>(</u>	congressional district and continuing in numerical order.
	4. If a vacancy occurs for any reason in the position of teacher representative, the governor
	shall appoint, by and with the advice and consent of the senate, a replacement for the unexpired
_	term. Such replacement shall be a resident of the same congressional district as the teacher
	representative being replaced, shall meet the qualifications set forth in subsection 2 of this section,
	and shall serve until his or her successor is appointed and qualified. If the general assembly is not
	n session at the time for making an appointment, the governor shall make a temporary appointment
	until the next session of the general assembly, when the governor shall nominate a person to fill the
1	position of teacher representative.
	5. If the teacher representative ceases to be an active classroom teacher, as defined in
	subsection 2 of this section, or fails to follow the board's attendance policy, the teacher
	representative's position shall immediately become vacant unless an absence is caused by sickness
	or some accident preventing such representative's arrival at the time and place appointed for the

	6. The teacher representative shall receive the same reimbursement for expenses as
Ī	members of the state board of education receive under section 161.022.
	7. At no time shall more than one non-voting member serve on the state board of education.

The government and control of a seven-director school district, other than an 27 urban district, is vested in a board of education of seven members, who hold their office for three 28 years, except as provided in section 162.241, and until their successors are duly elected and 29 qualified. Any vacancy occurring in the board shall be filled by the remaining members of the board; except that if there are more than two vacancies at any one time, the county commission 30 31 upon receiving written notice of the vacancies shall fill the vacancies by appointment. If there are 32 more than two vacancies at any one time in a county without a county commission, the county 33 executive upon receiving written notice of the vacancies shall fill the vacancies, with the advice and 34 consent of the county council, by appointment.
