1 AMEND House Committee Substitute for House Bill No. 2380, in the Title, Line 16 by deleting the
2 word "special"; and

4 Further amend said bill, Page 10, Section 301.010, Line 283, by inserting immediately after all of
5 said line the following:

7 "301.125. 1. There is hereby established an advisory committee for the department of
8 revenue, which shall exist solely to develop uniform designs and common colors for motor vehicle
9 license plates issued under this chapter and to determine appropriate license plate parameters for all
10 license plates issued under this chapter. The advisory committee shall adopt a type of design and
11 color scheme for license plates issued under this chapter that commemorates the bicentennial of
12 Missouri. The advisory committee may adopt more than one type of design and color scheme;
13 however, each license plate of a distinct type shall be uniform in design and color scheme with all
14 other license plates of that distinct type. The specifications for the fully reflective material used for
15 the plates, as required by section 301.130, shall be determined by the committee. Such plates shall
16 meet any specific requirements prescribed in this chapter. The advisory committee shall consist of
17 the director of revenue, the superintendent of the highway patrol, the correctional enterprises
18 administrator, the director of the department of transportation, the executive director of the Missouri
19 State Historical Society, and the respective chairpersons of both the senate and house of
20 representatives transportation committees. The committee shall meet, select a chairperson from
21 among its members, and develop uniform design and license plate parameters for the motor vehicle
22 license plates issued under this chapter not later than January 1, 2017. Prior to determining the final
23 design of the plates, the committee shall hold at least three public meetings in different areas of the
24 state to invite public input on the final design. Members of the committee shall be reimbursed for
25 their actual and necessary expenses incurred in the performance of their duties under this section.
26 The committee shall direct the director of revenue to implement its final design of the uniform
27 motor vehicle license plates and any specific parameters for all license plates developed by the
28 committee not later than August 10, 2017. The committee shall be dissolved upon completion of its
29 duties under this section.

30 2. Upon commencement by the director of revenue to reissue new license plates that
31 commemorate the bicentennial of Missouri consistent with the terms, conditions, and provisions of
32 this section and this chapter, except as otherwise provided in this chapter and in addition to all other
33 fees required by law, applicants for registration of vehicles with license plates that expire during the
34 period of reissuance, applicants for registration of trailers or semitrailers with license plates that
35 expire during the period of reissuance and applicants for registration of vehicles that are to be issued
36 new license plates during the period of reissuance shall pay the cost of the bicentennial plates

1 required by this section. The additional cost prescribed by in this section shall not be charged to
2 persons receiving special license plates issued under section 301.073 or 301.443. Historic motor
3 vehicle license plates registered pursuant to section 301.131 and specialized license plates are
4 exempt from the provisions of this subsection. Except for new, replacement, and trailer
5 applications, permanent nonexpiring license plates issued to commercial motor vehicles and trailers
6 registered under section 301.041 are exempt from the provisions of this subsection."; and

8 Further amend said bill, Page 111, Section 301.3170, Line 48, by inserting immediately after all of
9 said line the following:

11 "Section B. Because immediate action is necessary to ensure that the department has
12 adequate time to develop, design, and produce new license plates, and to implement a statewide
13 reissuance, the enactment of section 301.125 of Section A of this act is deemed necessary for the
14 immediate preservation of the public health, welfare, peace, and safety, and is hereby declared to be
15 an emergency act within the meaning of the constitution, and the enactment of section 301.125 of
16 section A of this act shall be in full force and effect upon its passage and approval."; and

18 Further amend said bill by amending the title, enacting clause, and intersectional references
19 accordingly.
