FISCAL ANALYSIS

ASSUMPTION

Oversight was unable to receive some of the agency responses in a timely manner due to the short fiscal note request time. Oversight has presented this fiscal note on the best current information that we have or on prior year information regarding a similar bill. Upon the receipt of agency responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval of the chairperson of the Joint Committee on Legislative Research to publish a new fiscal note.

Oversight notes this proposal gives the coordinating board of higher education authority to develop policies that allow a student to enroll in a community college and four-year institution simultaneously.

Oversight assumes the Department of Higher Education can develop the policies using existing resources. Oversight is unable to determine how many students may take advantage of this dual enrollment program. Oversight notes this proposal may not fiscally impact the institutions unless they chose to participate in this program. Oversight will not show a fiscal impact to this proposal.

Officials at the Metropolitan Community College, Missouri State University, Northwest Missouri State University, St. Louis Community College and the University of Missouri each assume there is no fiscal impact from this proposal to their respective institution.
