FISCAL ANALYSIS

ASSUMPTION

Officials at the **Department of Elementary and Secondary Education** assume there is no fiscal impact from this proposal. They defer to local school districts to determine a fiscal impact.

Oversight notes this proposal would change the bonding requirements for the treasurer of a school board. Oversight assumes this would not fiscally impact the school districts.

Officials at the Everton R-III, Hawthorn Leadership School, Kansas City, Kearney R-1, Kingston 42, Lee's Summit, Malta Bend, Middle Grove C-1, Parkway, Sarcoxie, Seymour R-II, St. Charles, St. Elizabeth R-IV, Tipton, Warren County R-III, West Plains and the Wright City R-II School Districts each assume there is no fiscal impact from this proposal to their respective districts.

Officials at the **Shell Knob School District** are unsure if this would have a fiscal impact.

Officials at the **Eldon School District** assume a cost of \$150.

§162.531 and §162.541 Reducing the number of sureties to one for the treasurer (HA 1) **Oversight** assumes this amendment would require only one surety for a treasurer instead of the current two sureties. Oversight assumes this would not fiscally impact the state or school districts.

Officials at the **DESE** assume there is no fiscal impact from this amendment.
