FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Revenue (DOR)** assume this proposal eliminates the availability of "Representative" and "Senator" specialty license plates to the members of the General Assembly.

Administrative Impact:

Motor Vehicle Bureau

Procedures will need to be revised by a Management Analyst Specialist I requiring 40 hours at a cost of \$890 in FY 2017.

This proposal eliminates the availability of "Representative" and "Senator" specialty license plates. If passed and upon the effective date of August 28, 2016, it is assumed that DOR would mail a notification to each titled owner notifying them of the requirement to surrender the plate and obtain a new Missouri license plate (stock, personalized, or specialty).

There are currently 156 "Representative" and 35 "Senator" license plates resulting in a cost \$106 in FY 2017 for envelopes (\$0.04), letters (\$0.025), and postage (\$0.49).

Total OA-ITSD Impact for FY `17 is 86.4 hours at \$75 per hour = \$6,480.

Oversight assumes DOR is provided with core funding to handle a certain amount of activity each year. Oversight assumes DOR could absorb the costs related to this proposal.

Revenue Impact:

As the "Representative" and "Senator" license plates would need to be surrendered and new plates (stock, personalized, or specialty) would need to be obtained by the owner to replace the surrendered plates, there is no revenue impact being shown as DOR will continue to receive the same fees.

Officials from the **Department of Transportation** concur with the Department of Revenue regarding this proposal.
