FISCAL ANALYSIS

ASSUMPTION

Oversight notes that beginning in the 2017-2018 (FY 2018) school year the minimum teacher's salary will go from \$25,000 to \$30,000 subject to appropriations. For teacher's with a master's degree and ten years of teaching experience the minimum salary goes from \$33,000 to \$35,000. This proposal creates the Teacher Minimum Salary Fund that has money appropriated to it for the purpose of paying the difference between the district's reported salary and the new salary minimums.

Oversight will show the impact to General Revenue as \$0 (no funds appropriated) to the amount estimated by DESE.

Officials at the **Department of Elementary and Secondary Education (DESE)** assume this creates the "Teacher Minimum Salary Fund". A query of information reported to DESE by school districts showed that roughly 3,852 teachers in 410 school districts were paid less than \$30,000. The total amount underpaid was \$4,839,866. For the master's degree and ten years experience, the query showed roughly 2,964 teachers from 480 school districts impacted for a total of \$788,173. The total appropriation required to meet the terms of this proposal would be \$5,628,039 per year.

Officials at the **Office of the State Treasurer** assume there is no fiscal impact from this proposal.

Officials at the **Cassville School District** assume a cost of \$225,500.

Officials at the **Chilhowee School District** assume it would increase salaries 7.55% or \$84,361 annually.

Officials at the Everton School District assume increased costs of \$400,000.

Officials at the **Fair Play School District** assume they already pay the new teachers the required rate. The master degree teachers would see an increase of \$3,000 each for a total of \$60,000.

Officials at the **Fredericktown School District** assume a large impact as starting salaries are \$27,000.

Officials at the **Kennett School District** assume an unknown impact.

Officials at the **Kingston 42 School District** assume a salary increase of \$15,000 for a staff of 7.

Officials at the **Macon County R-IV School District** assume an increase of \$8,588 for five impacted staff members.

Officials at the **Mexico School District** assume an impact of \$500,000 to bring salaries to new minimum.

Officials at the Scotland School District assume an unknown increase.

Officials at the St. Elizabeth School District assume this would increase salaries by \$32,388.

Officials at the **Wright City School District** assume this would cost \$62,000.

Officials at the **Avilla R-XIII School District** assume this is no impact as they already pay this proposal's required amount.

Officials at the **Hawthorn Leadership Academy** and the **Tipton School District** each assume no impact as they already exceed these minimums.

Officials at the East Newton, Eldon, Kansas City, Kearney R-I, Parkway, Pettis County R-XII, Sarcoxie R-II, Shell Knob, Smithville R-II, St. Charles, Warren County R-III and the West Plains school districts each assume there is no fiscal impact from this proposal to their respective districts.

Officials at the **Malta Bend School District** responded to Oversight's request for impact but did not indicate an impact.

Oversight notes that this proposal would raise the amount of the new teacher's salary. However, this proposal allows the money in the Teacher Minimum Salary Fund to be prorated should not enough money be appropriated to cover the full cost of the salary increase. The school districts assume they would be required to pay the new minimum salary. Therefore, Oversight will show the impact to schools as \$0 (the state pays full amount) Up to the full amount owed to teachers.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

This bill raises the minimum teacher salary beginning in school year 2017-18 from \$25,000 to \$30,000, subject to appropriation. The minimum salary for the holder of a master's degree with at least 10 years' teaching experience is raised from \$32,000 to \$35,000, subject to appropriation, beginning in the 2016-17 school year if the degree is in a field directly related to the teacher's assignment.

The Minimum Teacher Salary Fund is created for moneys appropriated to be distributed to each school district on the basis of the difference between the required minimum salary and the salary reported by the district on core data for each teacher who does not make the minimum salary. If the appropriation is insufficient to meet the need, the Department of Elementary and Secondary Education must prorate the appropriated amount so that the shortfall is equally distributed among all eligible teachers.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
