## FISCAL ANALYSIS

### ASSUMPTION

**Oversight** was unable to receive some of the agency responses in a timely manner due to the short fiscal note request time. Oversight has presented this fiscal note on the best current information that we have or on prior year information regarding a similar bill. Upon the receipt of agency responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval of the chairperson of the Joint Committee on Legislative Research to publish a new fiscal note.

In response to similar legislation this year, SB 637, officials at the **Office of the Secretary of State** and the **Missouri Department of Transportation** each assumed no fiscal impact to their respective agencies from this proposal.

In response to similar legislation this year, SB 637, officials at **St. Louis County**, the **Platte County Board of Election Commissioners**, the **Jackson County Board of Election Commissioners** and the **Christian County Commission** each assumed no fiscal impact to their respective entities from this proposal.
