FISCAL ANALYSIS

ASSUMPTION

Officials at the **Missouri Ethics Commission (MEC)** assume §105.470.(8) would include special executive branch appointees to the definition of public official.

This change would require the MEC to do the following:

- Provide information to public officials and the public as specified in the Commission duties in §105.491, 105.955.14 (4), RSMo., about the new statutory requirements; examples include providing education, developing informational materials, telephone and email assistance.
- Provide oversight to ensure those filing lobbyist expenditures reports adhere to the requirements detailed in §105.473.
- Respond to written complaints, as established in §105.955.14, RSMo, through conducting investigations and any legal actions arising from those investigations.

MEC assumes this prohibition would result in a minimal number of complaints; however, if this assumption is incorrect the Commission would require additional staff resources.

House Committee Amendment 1

MEC assumes no fiscal impact from the committee amendment. However, if this assumption is incorrect and there is a significant increase in complaints, the Commission would require additional investigative resources.

House Amendment 1

MEC assumes no fiscal impact from the floor amendment. However, if this assumption is incorrect and there is a significant increase in complaints, the Commission would require additional investigative resources.
