#### FISCAL ANALYSIS

# **ASSUMPTION**

**Oversight** was unable to receive some of the agency responses in a timely manner due to the short fiscal note request time. Oversight has presented this fiscal note on the best current information that we have or on prior year information regarding a similar bill. Upon the receipt of agency responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval of the chairperson of the Joint Committee on Legislative Research to publish a new fiscal note.

**Oversigh**t notes this proposal establishes the Urban Education Institute, a joint collaboration between students at Lincoln University and Harris Stowe State University. The Institute is to create a plan to address the urban educational crisis in Missouri. This program is subject to appropriations.

Officials at the **Department of Higher Education** assume they would need to promulgate rules and that the rules can be created using existing resources.

**Oversight** will show the impact as \$0 (no money appropriated for the collaboration) or funding that could exceed \$100,000 to General Revenue.

# FISCAL IMPACT - Small Business

## FISCAL DESCRIPTION

This bill establishes the Urban Education Institute, a joint program between Lincoln University and Harris-Stowe State University to address the urban education crisis and to develop a framework to improve quality education in urban areas and public schools.

The provisions of this bill shall sunset six years after the effective date unless reauthorized.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
