#### **FISCAL ANALYSIS**

#### **ASSUMPTION**

Officials from the Office of the Governor, the Office of the State Auditor, the Department of Public Safety - Missouri Gaming Commission, the Office of the State Treasurer, the Department of Public Safety - Division of Fire Safety, the Department of Public Safety - Missouri Veterans Commission, the State Tax Commission, the Missouri Consolidated Health Care Plan, the Department of Revenue, the Joint Committee on Public Employee Retirement, the Administrative Hearing Commission, the Office of the State Courts Administrator, the Missouri Lieutenant Governor, the Office of the State Public Defender, the Legislative Research, the Missouri State Employees Retirement System, the Missouri Lottery Commission and the MoDOT and Patrol Employees Retirement System each assume the current proposal would not fiscally impact their respective agencies.

Officials from the **Office of Administration - Budget and Planning** state that currently, RSMo 610.026.1(1) allows public agencies, when fulfilling records requests, to charge fees for research time. This proposal specifies that research time includes time spent reviewing records to determine whether they are closed or are authorized to be closed. This could impact state agencies fulfilling such requests. This may increase Total State Revenue by an unknown amount and could impact the calculation under Article X, Section 18(e).

**Oversight** assumes this proposal may impact local law enforcement agencies in a similar manner as stated above by Office of Administration - Budget and Planning. For fiscal note purposes, Oversight will show an unknown positive impact to these agencies.

In response to a previous version of this proposal, officials from the Department of Mental Health, the Department of Transportation, the Department of Elementary and Secondary Education, the Missouri Senate, the Department of Economic Development, the Office of Prosecution Services, the Department of Agriculture, the Missouri Ethics Commission, the Joint Committee on Administrative Rules, the Department of Higher Education, the Department of Public Safety - the Alcohol and Tobacco Control, the Department of Public Safety - State Emergency Management Agency, and the Department of Public Safety - Missouri Highway Patrol each assumed the proposal would not fiscally impact their respective agencies.

This proposal could increase Total State Revenue.

## FISCAL DESCRIPTION

This proposal requires a mobile video recording that is recorded in a nonpublic location to be closed, except that any person who is depicted in the recording or whose voice is in the recording, or his or her agent as specified in the bill, may obtain a complete, unaltered, and unedited copy of the recording upon written request.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
