FISCAL ANALYSIS

ASSUMPTION

Oversight was unable to receive some of the agency responses in a timely manner due to the short fiscal note request time. Oversight has presented this fiscal note on the best current information that we have or on prior year information regarding a similar bill. Upon the receipt of agency responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval of the chairperson of the Joint Committee on Legislative Research to publish a new fiscal note.

In response to a similar proposal from 2015 (HB 605), officials from the **Office of Secretary of State (SOS)** assumed the proposal cleans up the language in 181.100, 181.110, and 181.130 to better reflect the use of an electronic repository for provision of access to state publications. State publications are stored on this repository for access by the public, and there is no longer a need to distribute paper copies of state publications to participating libraries around the state in order to provide public access.

As revised, state agencies are still required to provide copies of reports as defined in 181.100.2 to the state library and the other entities listed in 181.100.3.

The proposal removes section 181.100.1.(4) that defines "participating libraries"; language in 181.110 relating to the role of these libraries in the program; and 181.130 specifying that the state library may enter into agreements with participating libraries, since that aspect of the program is no longer needed.

The SOS assumed no impact from the proposal.
