#### FISCAL ANALYSIS

#### **ASSUMPTION**

**Oversight** was unable to receive some of the agency responses in a timely manner due to the short fiscal note request time. Oversight has presented this fiscal note on the best current information that we have or on prior year information regarding a similar bill. Upon the receipt of agency responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval of the chairperson of the Joint Committee on Legislative Research to publish a new fiscal note.

Officials at the Platte County Board of Election Commissioners, Callaway County, Buchanan County, St. Louis County Directors of Elections and the Kansas City Board of Election Commissioners each assume no fiscal impact from this proposal to their respective organizations.
