FISCAL ANALYSIS

ASSUMPTION

Oversight was unable to receive some of the agency responses in a timely manner due to the short fiscal note request time. Oversight has presented this fiscal note on the best current information that we have or on prior year information regarding a similar bill. Upon the receipt of agency responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval of the chairperson of the Joint Committee on Legislative Research to publish a new fiscal note.

Officials at the **Missouri Department of Transportation** and the **Department of Natural Resources** each assume no fiscal impact to their respective agencies from this proposal.

Oversight assumes there could be a decrease in revenues to local political subdivisions who have ordinances in place that enact or enforce restrictions on residential dwelling rentals. Oversight assumes this amount would be minimal and will reflect no fiscal impact to local political subdivisions.
