AN ACT

To repeal sections 311.060, 311.205, and 311.298, RSMo, and to enact in lieu thereof four new sections relating to liquor control.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Sections 311.060, 311.205, and 311.298, RSMo, are repealed

- 2 and four new sections enacted in lieu thereof, to be known as sections 311.060,
- 3 311.205, 311.298, and 311.950, to read as follows:

311.060. 1. No person shall be granted a license hereunder unless such

- 2 person is of good moral character and a qualified legal voter and a taxpaying
- 3 citizen of the county, town, city or village, nor shall any corporation be granted
- 4 a license hereunder unless the managing officer of such corporation is of good
- 5 moral character and a qualified legal voter and taxpaying citizen of the county,
- 6 town, city or village; and, except as otherwise provided under subsection
- 7 of this section, no person shall be granted a license or permit hereunder
- 8 whose license as such dealer has been revoked, or who has been convicted, since
- 9 the ratification of the twenty-first amendment to the Constitution of the United
- 10 States, of a violation of the provisions of any law applicable to the manufacture
- 11 or sale of intoxicating liquor, or who employs in his or her business as such dealer
- 12 any person whose license has been revoked unless five years have passed
- 13 since the revocation as provided under subsection 6 of this section, or
- 14 who has been convicted of violating such law since the date aforesaid; provided,
- 15 that nothing in this section contained shall prevent the issuance of licenses to
- 16 nonresidents of Missouri or foreign corporations for the privilege of selling to duly
- 17 licensed wholesalers and soliciting orders for the sale of intoxicating liquors to,

18 by or through a duly licensed wholesaler, within this state.

- 2. (1) No person, partnership or corporation shall be qualified for a 19 license under this law if such person, any member of such partnership, or such 20 corporation, or any officer, director, or any stockholder owning, legally or 21beneficially, directly or indirectly, ten percent or more of the stock of such 22 corporation, or other financial interest therein, or ten percent or more of the 2324interest in the business for which the person, partnership or corporation is 25licensed, or any person employed in the business licensed under this law shall have had a license revoked under this law except as otherwise provided 26 27 under subsections 6 and 7 of this section, or shall have been convicted of violating the provisions of any law applicable to the manufacture or sale of intoxicating liquor since the ratification of the twenty-first amendment to the 30 Constitution of the United States, or shall not be a person of good moral 31 character.
- 32 (2) No license issued under this chapter shall be denied, suspended, 33 revoked or otherwise affected based solely on the fact that an employee of the 34 licensee has been convicted of a felony unrelated to the manufacture or sale of 35 intoxicating liquor. Each employer shall report the identity of any employee 36 convicted of a felony to the division of liquor control. The division of liquor control shall promulgate rules to enforce the provisions of this subdivision.
 - (3) No wholesaler license shall be issued to a corporation for the sale of intoxicating liquor containing alcohol in excess of five percent by weight, except to a resident corporation as defined in this section.
- 41 3. A "resident corporation" is defined to be a corporation incorporated under the laws of this state, all the officers and directors of which, and all the 42 stockholders, who legally and beneficially own or control sixty percent or more of 43 the stock in amount and in voting rights, shall be qualified legal voters and 44 taxpaying citizens of the county and municipality in which they reside and who 45 shall have been bona fide residents of the state for a period of three years 46 continuously immediately prior to the date of filing of application for a license, 47 provided that a stockholder need not be a voter or a taxpayer, and all the resident 48 stockholders of which shall own, legally and beneficially, at least sixty percent of 49 50 all the financial interest in the business to be licensed under this law; provided, 51 that no corporation, licensed under the provisions of this law on January 1, 1947, 52nor any corporation succeeding to the business of a corporation licensed on January 1, 1947, as a result of a tax-free reorganization coming within the

- provisions of Section 112, United States Internal Revenue Code, shall be disqualified by reason of the new requirements herein, except corporations engaged in the manufacture of alcoholic beverages containing alcohol in excess of five percent by weight, or owned or controlled, directly or indirectly, by nonresident persons, partnerships or corporations engaged in the manufacture of alcoholic beverages containing alcohol in excess of five percent by weight.
- 60 4. The term "financial interest" as used in this chapter is defined to mean all interest, legal or beneficial, direct or indirect, in the capital devoted to the 61 licensed enterprise and all such interest in the net profits of the enterprise, after 62 the payment of reasonable and necessary operating business expenses and taxes, 63 including interest in dividends, preferred dividends, interest and profits, directly or indirectly paid as compensation for, or in consideration of interest in, or for use of, the capital devoted to the enterprise, or for property or money advanced, 66 loaned or otherwise made available to the enterprise, except by way of ordinary 67 commercial credit or bona fide bank credit not in excess of credit customarily 68 granted by banking institutions, whether paid as dividends, interest or profits, 70 or in the guise of royalties, commissions, salaries, or any other form whatsoever.
- 5. The supervisor shall by regulation require all applicants for licenses to file written statements, under oath, containing the information reasonably required to administer this section. Statements by applicants for licenses as wholesalers and retailers shall set out, with other information required, full information concerning the residence of all persons financially interested in the business to be licensed as required by regulation. All material changes in the information filed shall be promptly reported to the supervisor.
 - 6. Any person whose license or permit issued under this chapter has been revoked shall be automatically eligible to work as an employee of an establishment holding a license or permit under this chapter five years after the date of the revocation.
- 7. Any person whose license or permit issued under this chapter has been revoked shall be eligible to apply and be qualified for a new license or permit five years after the date of the revocation. The person may be issued a new license or permit at the discretion of the division of alcohol and tobacco control. If the division denies the request for a new permit or license, the person may not submit a new application for five years from the date of the denial. If the application is approved, the person shall pay all fees required by law for the

90 license or permit. Any person whose request for a new license or 91 permit is denied may seek a determination by the administrative 92 hearing commission as provided under section 311.691.

311.205. 1. Any person licensed to sell liquor at retail by the drink for consumption on the premises where sold may use a [table tap dispensing] self-dispensing system [to allow], which is monitored and controlled by the licensee and allows patrons of the licensee to [dispense] self-dispense beer [at a table] or wine. Before a patron may dispense beer or wine, an employee of the licensee must first authorize an amount of beer or wine, not to exceed thirty-two ounces of beer or sixteen ounces of wine per patron per authorization, to be dispensed by the [table tap dispensing] self-dispensing system.

2. No provision of law or rule or regulation of the supervisor shall be interpreted to allow any wholesaler, distributor, or manufacturer of intoxicating liquor to furnish [table tap dispensing] self-dispensing or cooling equipment or provide services for the maintenance, sanitation, or repair of [table tap dispensing] self-dispensing systems.

311.298. When January first, **February fourteenth**, March seventeenth, July fourth, or December thirty-first falls on Sunday, and on the Sundays prior to Memorial Day and Labor Day and on the Sunday on which the national championship game of the national football league is played, commonly known as "Super Bowl Sunday", any person having a license to sell intoxicating liquor by the drink may be open for business and sell intoxicating liquor by the drink under the provisions of his license on that day from the time and until the time which would be lawful on another day of the week, notwithstanding any provisions of section 311.290 or any other provision of law to the contrary.

311.950. 1. Notwithstanding any provision of law to the contrary,
2 entertainment facilities including, but not limited to, arenas and
3 stadiums used primarily for concerts, shows, and sporting events of any
4 kind and entities selling concessions at such facilities that possess all
5 necessary and valid licenses and permits to allow for the sale of
6 alcoholic beverages shall not be prohibited from selling and delivering
7 alcoholic beverages purchased through the use of mobile applications
8 to individuals attending events on the premises of such facilities if the
9 facilities are in compliance with all applicable state laws and
10 regulations regarding the sale of alcoholic beverages.

2. For purposes of this section, the term "mobile application" 12 shall mean a computer program or software designed to be used on 13 hand-held mobile devices such as cellular phones and tablet computers.

- 3. Any employee of a facility or entity selling concessions at a facility who delivers an alcoholic beverage purchased through a mobile application to an individual shall require the individual to show a valid, government-issued identification document that includes the photograph and birth date of the individual, such as a driver's license, and shall verify that the individual is twenty-one years of age or older before the individual is allowed possession of the alcoholic beverage.
- 4. The division of alcohol and tobacco control may promulgate 2122rules to implement the provisions of this section. Any rule or portion of a rule, as that term is defined in section 536.010, that is created 23under the authority delegated in this section shall become effective 24only if it complies with and is subject to all of the provisions of chapter 25536 and, if applicable, section 536.028. This section and chapter 536 are 26 nonseverable, and if any of the powers vested with the general assembly pursuant to chapter 536 to review, to delay the effective date, 28 or to disapprove and annul a rule are subsequently held 29 unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted after August 28, 2016, shall be invalid and void.
