32 EXPLANATION: SUBSECTIONS 3 TO 5 OF THIS SECTION BECAME OBSOLETE ON  
33 08-28-14:

1.310. 1. This section shall be known and may be cited as the "Big Government Get Off  
2 My Back Act".

3           2. Any federal mandate compelling the state to enact, enforce, or administer a federal  
4 regulatory program shall be subject to authorization through appropriation or statutory  
5 enactment.

6           [3. No user fees imposed by the state of Missouri shall increase for the five-year period  
7 beginning on August 28, 2009, unless such fee increase is to implement a federal program  
8 administered by the state or is a result of an act of the general assembly. For purposes of this  
9 section, "user fee" does not include employer taxes or contributions, assessments to offset the  
10 cost of examining insurance or financial institutions, any health-related taxes approved by the  
11 Center for Medicare and Medicaid Services, or any professional or occupational licensing fees  
12 set by a board of members of that profession or occupation and required by statute to be set at  
13 a level not to exceed the cost of administration.

14           4. For the five-year period beginning on August 28, 2009, any state agency proposing  
15 a rule as that term is defined in subdivision (6) of section 536.010, other than any rule  
16 promulgated as a result of a federal mandate, or to implement a federal program administered  
17 by the state or an act of the general assembly, shall either:

18           (1) Certify that the rule does not have an adverse impact on small businesses consisting  
19 of fewer than fifty full- or part-time employees; or

20           (2) Certify that the rule is necessary to protect the life, health or safety of the public; or

21           (3) Exempt any small business consisting of fewer than fifty full- or part-time employees  
22 from coverage.

23           5. The provisions of this section shall not be construed to prevent or otherwise restrict  
24 an agency from promulgating emergency rules pursuant to section 536.025, or from rescinding  
25 any existing rule pursuant to section 536.021.]

27 THE DEPARTMENT REFERENCE IN THIS SECTION IS OBSOLETE BASED ON THE  
28 DEPARTMENTAL REORGANIZATION IN EXECUTIVE ORDER 13-03:

8.800. As used in sections 8.800 to 8.825, the following terms mean:

2           (1) "Builder", the prime contractor that hires and coordinates building subcontractors or  
3 if there is no prime contractor, the contractor that completes more than fifty percent of the total  
4 construction work performed on the building. Construction work includes, but is not limited to,  
5 foundation, framing, wiring, plumbing and finishing work;

6           (2) "Department", the department of [natural resources] **economic development**;

7           (3) "Designer", the architect, engineer, landscape architect, builder, interior designer or  
8 other person who performs the actual design work or is under the direct supervision and  
9 responsibility of the person who performs the actual design work;

10 (4) "District heating and cooling systems", heat pump systems which use waste heat from  
11 factories, sewage treatment plants, municipal solid waste incineration, lighting and other heat  
12 sources in office buildings or which use ambient thermal energy from sources including  
13 temperature differences in rivers to provide regional heating or cooling;

14 (5) "Division", the division of facilities management, design and construction;

15 (6) "Energy efficiency", the increased productivity or effectiveness of energy resources  
16 use, the reduction of energy consumption, or the use of renewable energy sources;

17 (7) "Gray water", all domestic wastewater from a state building except wastewater from  
18 urinals, toilets, laboratory sinks, and garbage disposals;

19 (8) "Life cycle costs", the costs associated with the initial construction or renovation and  
20 the proposed energy consumption, operation and maintenance costs over the useful life of a state  
21 building or over the first twenty-five years after the construction or renovation is completed;

22 (9) "Public building", a building owned or operated by a governmental subdivision of  
23 the state, including, but not limited to, a city, county or school district;

24 (10) "Renewable energy source", a source of thermal, mechanical or electrical energy  
25 produced from solar, wind, low-head hydropower, biomass, hydrogen or geothermal sources, but  
26 not from the incineration of hazardous waste, municipal solid waste or sludge from sewage  
27 treatment facilities;

28 (11) "State agency", a department, commission, authority, office, college or university  
29 of this state;

30 (12) "State building", a building owned by this state or an agency of this state;

31 (13) "Substantial renovation" or "substantially renovated", modifications that will affect  
32 at least fifty percent of the square footage of the building or modifications that will cost at least  
33 fifty percent of the building's fair market value.

35 THE DEPARTMENT REFERENCE IN THIS SECTION IS OBSOLETE BASED ON THE  
36 DEPARTMENTAL REORGANIZATION IN EXECUTIVE ORDER 13-03:

8.805. 1. For the first three years of each completed energy efficiency project for state  
2 buildings, to the extent that there are energy savings beyond payment of the financing obligation,  
3 required reserves and other expenses associated with project financing, one-half of the energy  
4 savings shall be placed in the energy analyses account, created in section 8.807, and one-half  
5 shall revert to the general revenue fund. The division, in conjunction with the department, shall  
6 establish criteria for determining projected savings from energy efficiency projects in state  
7 buildings. The division, in conjunction with all state agencies, shall establish criteria for  
8 determining the actual savings which result from a specific energy efficiency project.

9           2. Beginning January 15, 1997, and annually thereafter, the office of administration and  
10 the department of [natural resources] **economic development** shall file a joint report to the house  
11 committee on energy and environment, the senate committee on energy and environment, or their  
12 successor committees, and the governor on the identification of, planning for and implementation  
13 of energy efficiency projects in state buildings.

8.830. For purposes of sections 8.830 to 8.851, the following terms mean:

2           (1) "Department", the department of [natural resources] **economic development**;

3           (2) "Director", the director of the department of [natural resources] **economic**  
4 **development**;

5           (3) "Division", the division of facilities management, design and construction;

6           (4) "Public building", a building owned or operated by a governmental subdivision of  
7 the state, including, but not limited to, a city, county or school district;

8           (5) "State building", a building owned or operated by the state, a state agency or  
9 department, a state college or a state university.

10

11 THE DEPARTMENT REFERENCE IN THIS SECTION IS OBSOLETE BASED ON THE  
12 DEPARTMENTAL REORGANIZATION IN EXECUTIVE ORDER 13-03:

8.843. There is hereby established an interagency advisory committee on energy cost  
2 reduction and savings. The committee shall consist of the commissioner of administration, the  
3 director of the division of facilities management, design and construction, the director of the  
4 department of [natural resources] **economic development**, the director of the environmental  
5 improvement and energy resources authority, the director of the division of energy, the director  
6 of the department of transportation, the director of the department of conservation and the  
7 commissioner of higher education. The committee shall advise the department on the  
8 development of the minimum energy efficiency standard and state building energy efficiency  
9 rating system and shall assist the office of administration in implementing sections 8.833 and  
10 8.835.

11

12 EXPLANATION: THE AUTHORITY FOR AUDITS UNDER SUBSECTION 4 OF THIS  
13 SECTION EXPIRED 12-31-13:

42.300. 1. There is hereby created in the state treasury the "Veterans Commission  
2 Capital Improvement Trust Fund" which shall consist of money collected under section 313.835.  
3 The state treasurer shall administer the veterans commission capital improvement trust fund, and

4 the moneys in such fund shall be used solely, upon appropriation, by the Missouri veterans  
5 commission for:

6 (1) The construction, maintenance or renovation or equipment needs of veterans' homes  
7 in this state;

8 (2) The construction, maintenance, renovation, equipment needs and operation of  
9 veterans' cemeteries in this state;

10 (3) Fund transfers to Missouri veterans' homes fund established under the provisions of  
11 section 42.121, as necessary to maintain solvency of the fund;

12 (4) Fund transfers to any municipality with a population greater than four hundred  
13 thousand and located in part of a county with a population greater than six hundred thousand in  
14 this state which has established a fund for the sole purpose of the restoration, renovation and  
15 maintenance of a memorial or museum or both dedicated to World War I. Appropriations from  
16 the veterans commission capital improvement trust fund to such memorial fund shall be provided  
17 only as a one-time match for other funds devoted to the project and shall not exceed five million  
18 dollars. Additional appropriations not to exceed ten million dollars total may be made from the  
19 veterans commission capital improvement trust fund as a match to other funds for the new  
20 construction or renovation of other facilities dedicated as veterans' memorials in the state. All  
21 appropriations for renovation, new construction, reconstruction, and maintenance of veterans'  
22 memorials shall be made only for applications received by the Missouri veterans commission  
23 prior to July 1, 2004;

24 (5) The issuance of matching fund grants for veterans' service officer programs to any  
25 federally chartered veterans' organization or municipal government agency that is certified by  
26 the Veterans Administration to process veteran claims within the Veterans Administration  
27 System; provided that such veterans' organization has maintained a veterans' service officer  
28 presence within the state of Missouri for the three-year period immediately preceding the  
29 issuance of any such grant. A total of one million five hundred thousand dollars in grants shall  
30 be made available annually for service officers and joint training and outreach between veterans'  
31 service organizations and the Missouri veterans commission with grants being issued in July of  
32 each year. Application for the matching grants shall be made through and approved by the  
33 Missouri veterans commission based on the requirements established by the commission;

34 (6) For payment of Missouri National Guard and Missouri veterans commission  
35 expenses associated with providing medals, medallions and certificates in recognition of service  
36 in the Armed Forces of the United States during World War II, the Korean Conflict, and the  
37 Vietnam War under sections 42.170 to 42.226. Any funds remaining from the medals,  
38 medallions and certificates shall not be transferred to any other fund and shall only be utilized

39 for the awarding of future medals, medallions, and certificates in recognition of service in the  
40 Armed Forces;

41 (7) Fund transfers totaling ten million dollars to any municipality with a population  
42 greater than three hundred fifty thousand inhabitants and located in part in a county with a  
43 population greater than six hundred thousand inhabitants and with a charter form of government,  
44 for the sole purpose of the construction, restoration, renovation and maintenance of a memorial  
45 or museum or both dedicated to World War I; and

46 (8) The administration of the Missouri veterans commission.

47 2. Any interest which accrues to the fund shall remain in the fund and shall be used in  
48 the same manner as moneys which are transferred to the fund under this section.  
49 Notwithstanding the provisions of section 33.080 to the contrary, moneys in the veterans  
50 commission capital improvement trust fund at the end of any biennium shall not be transferred  
51 to the credit of the general revenue fund.

52 3. Upon request by the veterans commission, the general assembly may appropriate  
53 moneys from the veterans commission capital improvement trust fund to the Missouri National  
54 Guard trust fund to support the activities described in section 41.958.

55 [4. The state auditor shall conduct an audit of all moneys in the veterans commission  
56 capital improvement trust fund every year beginning January 1, 2011, and ending on December  
57 31, 2013. The findings of each audit shall be distributed to the general assembly, governor, and  
58 lieutenant governor no later than ten business days after the completion of such audit.]

60 THE DEPARTMENT REFERENCES IN THIS SECTION ARE OBSOLETE BASED ON THE  
61 DEPARTMENTAL REORGANIZATION IN EXECUTIVE ORDER 13-01:

44.105. 1. In a governor-declared state of emergency, the [department of health and  
2 senior services] **governor** may suspend any provision of chapters 195 and 334 pertaining to  
3 dispensing medications. Persons who dispense medications under this section shall be trained  
4 by the [department of health and senior services] **agency** and shall dispense medications under  
5 the supervision of a licensed health care provider according to the [department's] **agency's**  
6 strategic national stockpile plan.

7 2. The [department] **agency** may develop effective citizen involvement to recruit, train,  
8 and accept the services of volunteers to supplement the programs administered by the  
9 [department] **agency** in dispensing medications to the population in the event of an emergency.

10 3. Volunteers recruited, trained, and accepted by the [department] **agency** shall comply  
11 with the [department's] **agency's** strategic national stockpile plan in dispensing medications.

12 4. The [department] **agency** may:

13 (1) Provide staff as deemed necessary for the effective management and development  
14 of volunteer dispensing sites deployed in response to a governor-declared emergency;

15 (2) Provide or assure access to professional staff as deemed necessary for the effective  
16 training and oversight of volunteers;

17 (3) Develop and provide to all volunteers written rules governing the job descriptions,  
18 recruitment, screening, training responsibility, utilization, and supervision of volunteers; and

19 (4) Educate volunteers to ensure that they understand their duties and responsibilities.

20 5. Non-health care professional volunteers, whose liability is not otherwise protected by  
21 section 44.045 shall be deemed unpaid employees and shall be accorded the protection of the  
22 legal expense fund and other provisions of section 105.711.

23 6. As used in this section, "volunteer" means any person who, of his or her own free will,  
24 performs any assigned duties for the [department of health and senior services] **agency** with no  
25 monetary or material compensation.

26

27 EXPLANATION: THIS SECTION CHANGES OBSOLETE SOCIAL SECURITY  
28 PROVISIONS AND BRINGS MISSOURI INTO COMPLIANCE WITH FEDERAL LAW:

51.165. In all counties of class three and four which shall enter into an agreement with  
2 the state agency to place county employees under the Federal Social Security Act in accordance  
3 with the provisions of sections 105.300 to [105.440] **105.430**, it shall be the duty of the county  
4 clerk to keep necessary records, collect contributions of county employees [and remit the same  
5 to the state agency], and do all other administrative acts required by the agreement or by ruling  
6 of the federal or state agency in order to carry out the purposes of the aforesaid law.

7

8 EXPLANATION: THIS SECTION REMOVES OBSOLETE LANGUAGE REGARDING THE  
9 COMMINGLING OF STATE AND LOCAL FUNDS:

67.5016. 1. Any county levying a local sales tax under the authority of sections 67.5000  
2 to 67.5038 shall not administer or collect the tax locally, but shall utilize the services of the state  
3 department of revenue to administer, enforce, and collect the tax. The sales tax shall be  
4 administered, enforced, and collected in the same manner and by the same procedure as other  
5 local sales taxes are levied and collected and shall be in addition to any other sales tax authorized  
6 by law. Except as modified in this section, all provisions of sections 32.085 and 32.087 shall  
7 apply to the tax imposed pursuant to this section.

8 2. Upon receipt of a certified copy of a resolution from the county authorizing the levy  
9 of a local sales tax, which resolution shall state the name of the district in which that county is  
10 included, the director of the department of revenue shall cause this tax to be collected at the same  
11 time and in the same manner provided for the collection of the state sales tax. All moneys

12 derived from this local sales tax imposed under the authority of sections 67.5000 to 67.5038 and  
13 collected under the provisions of this section by the director of revenue shall be [credited to a  
14 fund established for the district, which is hereby established in] **deposited with** the state  
15 treasury[,] under the name of that district, as established. **The moneys derived from local sales**  
16 **tax shall not be deemed to be state funds and shall not be commingled with any funds of**  
17 **the state.** Any refund due on any local sales tax collected pursuant to section 67.5000 to  
18 67.5038 shall be paid out of the sales tax refund fund and reimbursed by the director of revenue  
19 from the sales tax revenue collected under this section. All local sales tax revenue derived from  
20 the authority granted by sections 67.5000 to 67.5038 and collected from within any county, under  
21 this section, shall be remitted at least quarterly by the director of revenue to the district  
22 established by sections 67.5000 to 67.5038, the source county included in the district and the  
23 cities in that county, in the percentages set forth in section 67.5014.

25 EXPLANATION: REMOVES THE REFERENCE IN SUBDIVISION (15) TO THE JOINT  
26 COMMITTEE ON ECONOMIC POLICY AND PLANNING WHICH WAS REPEALED IN  
27 2014:

100.710. As used in sections 100.700 to 100.850, the following terms mean:

- 2 (1) "Assessment", an amount of up to five percent of the gross wages paid in one year  
3 by an eligible industry to all eligible employees in new jobs, or up to ten percent if the economic  
4 development project is located within a distressed community as defined in section 135.530;
- 5 (2) "Board", the Missouri development finance board as created by section 100.265;
- 6 (3) "Certificates", the revenue bonds or notes authorized to be issued by the board  
7 pursuant to section 100.840;
- 8 (4) "Credit", the amount agreed to between the board and an eligible industry, but not  
9 to exceed the assessment attributable to the eligible industry's project;
- 10 (5) "Department", the Missouri department of economic development;
- 11 (6) "Director", the director of the department of economic development;
- 12 (7) "Economic development project":
  - 13 (a) The acquisition of any real property by the board, the eligible industry, or its affiliate;
  - 14 or
  - 15 (b) The fee ownership of real property by the eligible industry or its affiliate; and
  - 16 (c) For both paragraphs (a) and (b) of this subdivision, "economic development project"  
17 shall also include the development of the real property including construction, installation, or  
18 equipping of a project, including fixtures and equipment, and facilities necessary or desirable for  
19 improvement of the real property, including surveys; site tests and inspections; subsurface site  
20 work; excavation; removal of structures, roadways, cemeteries and other surface obstructions;

21 filling, grading and provision of drainage, storm water retention, installation of utilities such as  
22 water, sewer, sewage treatment, gas, electricity, communications and similar facilities; off-site  
23 construction of utility extensions to the boundaries of the real property; and the acquisition,  
24 installation, or equipping of facilities on the real property, for use and occupancy by the eligible  
25 industry or its affiliates;

26 (8) "Eligible employee", a person employed on a full-time basis in a new job at the  
27 economic development project averaging at least thirty-five hours per week who was not  
28 employed by the eligible industry or a related taxpayer in this state at any time during the  
29 twelve-month period immediately prior to being employed at the economic development project.  
30 For an essential industry, a person employed on a full-time basis in an existing job at the  
31 economic development project averaging at least thirty-five hours per week may be considered  
32 an eligible employee for the purposes of the program authorized by sections 100.700 to 100.850;

33 (9) "Eligible industry", a business located within the state of Missouri which is engaged  
34 in interstate or intrastate commerce for the purpose of manufacturing, processing or assembling  
35 products, conducting research and development, or providing services in interstate commerce,  
36 office industries, or agricultural processing, but excluding retail, health or professional services.  
37 "Eligible industry" does not include a business which closes or substantially reduces its operation  
38 at one location in the state and relocates substantially the same operation to another location in  
39 the state. This does not prohibit a business from expanding its operations at another location in  
40 the state provided that existing operations of a similar nature located within the state are not  
41 closed or substantially reduced. This also does not prohibit a business from moving its  
42 operations from one location in the state to another location in the state for the purpose of  
43 expanding such operation provided that the board determines that such expansion cannot  
44 reasonably be accommodated within the municipality in which such business is located, or in the  
45 case of a business located in an incorporated area of the county, within the county in which such  
46 business is located, after conferring with the chief elected official of such municipality or county  
47 and taking into consideration any evidence offered by such municipality or county regarding the  
48 ability to accommodate such expansion within such municipality or county. An eligible industry  
49 must:

50 (a) Invest a minimum of fifteen million dollars, or ten million dollars for an office  
51 industry, in an economic development project; and

52 (b) Create a minimum of one hundred new jobs for eligible employees at the economic  
53 development project or a minimum of five hundred jobs if the economic development project  
54 is an office industry or a minimum of two hundred new jobs if the economic development project  
55 is an office industry located within a distressed community as defined in section 135.530, or in  
56 the case of an approved company for a project for a world headquarters of a business whose

57 primary function is tax return preparation in any home rule city with more than four hundred  
58 thousand inhabitants and located in more than one county, create a minimum of one hundred new  
59 jobs for eligible employees at the economic development project. An industry that meets the  
60 definition of "essential industry" may be considered an eligible industry for the purposes of the  
61 program authorized by sections 100.700 to 100.850.

62

63 Notwithstanding the preceding provisions of this subdivision, a development agency, as such  
64 term is defined in subdivision (3) of section 100.255, or a corporation, limited liability company,  
65 or partnership formed on behalf of a development agency, at the option of the board, may be  
66 authorized to act as an eligible industry with such obligations and rights otherwise applicable to  
67 an eligible industry, including the rights of an approved company under section 100.850, so long  
68 as the eligible industry otherwise meets the requirements imposed by this subsection;

69 (10) "Essential industry", a business that otherwise meets the definition of eligible  
70 industry except an essential industry shall:

71 (a) Be a targeted industry;

72 (b) Be located in a home rule city with more than twenty-six thousand but less than  
73 twenty-seven thousand inhabitants located in any county with a charter form of government and  
74 with more than one million inhabitants or in a city of the fourth classification with more than  
75 four thousand three hundred but fewer than four thousand four hundred inhabitants and located  
76 in any county with a charter form of government and with more than one million inhabitants;

77 (c) Have maintained at least two thousand jobs at the proposed economic development  
78 project site each year for a period of four years preceding the year in which application for the  
79 program authorized by sections 100.700 to 100.850 is made and during the year in which said  
80 application is made;

81 (d) Retain, at the proposed economic development project site, the level of employment  
82 that existed at the site in the taxable year immediately preceding the year in which application  
83 for the program, authorized by sections 100.700 to 100.850, is made. Retention of such level  
84 of employment shall commence three years from the date of issuance of the certificates and  
85 continue for the duration of the certificates; and

86 (e) Invest a minimum of five hundred million dollars in the economic development  
87 project by the end of the third year after the issuance of the certificates under this program;

88 (11) "New job", a job in a new or expanding eligible industry not including jobs of  
89 recalled workers, replacement jobs or jobs that formerly existed in the eligible industry in the  
90 state. For an essential industry, an existing job may be considered a new job for the purposes of  
91 the program authorized by sections 100.700 to 100.850;

92 (12) "Office industry", a regional, national or international headquarters, a  
93 telecommunications operation, a computer operation, an insurance company, or a credit card  
94 billing and processing center;

95 (13) "Program costs", all necessary and incidental costs of providing program services  
96 including payment of the principal of premium, if any, and interest on certificates, including  
97 capitalized interest, issued to finance a project, and funding and maintenance of a debt service  
98 reserve fund to secure such certificates. Program costs shall include:

99 (a) Obligations incurred for labor and obligations incurred to contractors, subcontractors,  
100 builders and materialmen in connection with the acquisition, construction, installation or  
101 equipping of an economic development project;

102 (b) The cost of acquiring land or rights in land and any cost incidental thereto, including  
103 recording fees;

104 (c) The cost of contract bonds and of insurance of all kinds that may be required or  
105 necessary during the course of acquisition, construction, installation or equipping of an economic  
106 development project which is not paid by the contractor or contractors or otherwise provided for;

107 (d) All costs of architectural and engineering services, including test borings, surveys,  
108 estimates, plans and specifications, preliminary investigations and supervision of construction,  
109 as well as the costs for the performance of all the duties required by or consequent upon the  
110 acquisition, construction, installation or equipping of an economic development project;

111 (e) All costs which are required to be paid under the terms of any contract or contracts  
112 for the acquisition, construction, installation or equipping of an economic development project;  
113 and

114 (f) All other costs of a nature comparable to those described in this subdivision;

115 (14) "Program services", administrative expenses of the board, including contracted  
116 professional services, and the cost of issuance of certificates;

117 (15) "Targeted industry", an industry or one of a cluster of industries that is identified  
118 by the department as critical to the state's economic security and growth [and affirmed as such  
119 by the joint committee on economic development policy and planning established in section  
120 620.602].

122 EXPLANATION: OBSOLETE SOCIAL SECURITY PROVISIONS ARE CHANGED TO  
123 BRING MISSOURI INTO COMPLIANCE WITH FEDERAL LAW:

104.342. 1. Any person hired by the state on or after August 13, 1986, in any of the  
2 positions described in this subsection shall be a member of the system from the date on which  
3 such employment begins. This subsection shall apply to any person duly certified under the law  
4 governing the certification of teachers who is employed full time:

5 (1) As a teacher by the division of youth services;

6 (2) As a teacher by a division of the state department of social services and who renders  
7 services in a school whose standards of education are set and which is supervised by a public  
8 school officer of the county in which the school is located, by the department of elementary and  
9 secondary education or by the coordinating board for higher education;

10 (3) As a teacher by the section of inmate education of the department of corrections;

11 (4) In either a teaching or supervisory teaching capacity by the department of mental  
12 health, in which his or her duties include participation in the educational program of the  
13 department of mental health.

14 2. Any person employed in any of the positions described in subsection 1 of this section  
15 immediately prior to and on August 13, 1986, may elect, in writing, to:

16 (1) Become a member of the Missouri state employees' retirement system effective  
17 January 1, 1987. Any person who, by virtue of an election made under this subdivision, becomes  
18 a member of the Missouri state employees' retirement system shall be entitled to creditable prior  
19 service credit for service rendered in any of the positions described in subsection 1 of this  
20 section. Members who so elect shall be eligible, upon written request filed with the public  
21 school retirement system, to receive a refund of their accumulated contributions including  
22 interest of six percent and upon payment of such refund, the public school retirement systems  
23 shall pay to the state employees' retirement system before June 30, 1987, an amount equal to the  
24 amount paid the public school retirement system on behalf of each member so electing by the  
25 member's employer; or

26 (2) Remain a member of the public school retirement system of Missouri created under  
27 sections 169.010 to 169.140. Any person entitled to make the election provided by this  
28 subsection who does not make such election, in writing, by January 1, 1987, shall be deemed to  
29 have elected to be governed by subdivision (1) of this subsection.

30 3. Any person who is employed on a full-time basis by Truman State University,  
31 Northwest Missouri State University, Central Missouri State University, Southeast Missouri  
32 State University, Southwest Missouri State University, Harris-Stowe State College or Missouri  
33 Southern State College and Missouri Western State College shall be a member of the system;  
34 except that any person who is duly certified under the laws governing the certification of teachers  
35 and who is a full-time employee of such institution or institutions on June 14, 1989, and is  
36 contributing because of such employment to a retirement system established under sections  
37 169.010 to 169.140 or sections 169.410 to 169.540, may make an election to continue in that  
38 retirement system if such election is made on or before December 31, 1989. This election shall  
39 not apply to any such person who commenced receiving retirement benefits prior to January 1,  
40 1990, from any state retirement system because of such service.

41           4. Effective January 1, 1990, only after an affirmative referendum in accordance with  
42 section 105.353, any person who is employed on a full-time basis by the department of  
43 elementary and secondary education shall be a member of the system; except that any person  
44 duly certified under the law governing the certification of teachers who is a full-time employee  
45 at any time during the period extending from June 14, 1989, through December 31, 1989, and  
46 is contributing because of such employment to the retirement system established under sections  
47 169.010 to 169.140, may elect to continue in that retirement system if such election is made on  
48 or before December 31, 1989. This election shall not apply to any such person who commenced  
49 receiving retirement benefits prior to January 1, 1990, from any state retirement system because  
50 of such service.

51           5. On June 14, 1989, all newly employed persons in the positions described in subsection  
52 3 of this section shall become members of the Missouri state employees' retirement system.  
53 Effective January 1, 1990, and only after an affirmative referendum provided for in subsection  
54 4 of this section, all newly employed persons in the positions described in subsection 4 of this  
55 section shall become members of the Missouri state employees' retirement system.

56           6. Any employee actively employed on June 14, 1989, who, because of employment in

65           7. Any person entitled to make the election provided by subsection 3 or 4 of this section,  
66 who does not make such election, in writing, on or before December 31, 1989, shall be deemed

68           (1) Those persons described in subsections 3 and 4 of this section who elect or have  
69 elected by written request filed with the board to be members of this system, shall be entitled to  
70 creditable prior service for service rendered in any of the positions described in subsections 1,  
71 3 and 4 of this section. Any person who so elects shall be eligible, upon written request filed  
72 with the board on or before March 31, 1990, with the retirement system established under  
73 sections 169.010 to 169.140 or sections 169.410 to 169.540, to receive a refund of the member's  
74 accumulated contributions for the creditable service in any of the positions described in  
75 subsections 1, 3 and 4 of this section, plus interest at an annual rate of six percent computed on  
76 the refundable balance, if any, in the member's account in that retirement system as of June 30,

1989. Such refunds shall be made prior to June 1, 1990. If any creditable prior service transferred under subsection 1, 3 or 4 of this section, or subsection 3 of section 104.372, includes periods of service not covered by the federal Social Security Act, as provided in sections 105.300 to [105.445] **105.430**, then, in calculating the benefit amount payable to such member, the normal annuity shall be an amount equal to two and one-tenth percent of the average compensation of the member multiplied by the number of years of such creditable service for the positions described in subsections 1, 3 and 4 of this section not covered by the federal Social Security Act in addition to an amount payable under section 104.374 for all service covered by the federal Social Security Act. The normal annuity as described in this subdivision shall be adjusted for early retirement, if applicable;

(2) Any person described in subsections 3 and 4 of this section, who elects to remain in one of the retirement systems established under sections 169.010 to 169.140 or sections 169.410 to 169.540, shall, notwithstanding any provision of chapter 169 to the contrary, be a noncontributing member of such system and shall receive a refund of the member's accumulated contributions for the creditable service in any of the positions described in subsection 1, 3 or 4 of this section, plus interest at an annual rate of six percent computed on the refundable balance, if any, in the member's account in that retirement system as of June 30, 1989. Such refunds shall be made prior to June 1, 1990. At the time of retirement under the provisions of sections 169.010 to 169.140 or sections 169.410 to 169.540, such person shall receive a retirement benefit computed under the then existing law of that retirement system; except that, for any person employed in a position described in subsection 4 of this section, the benefit shall be the amount computed as though the position were not covered by the federal Social Security Act, reduced by the amount of any federal Social Security benefit the person may receive which is attributable to service rendered in the positions described in subsection 4 of this section after December 31, 1989.

8. Upon payment of the refunds provided in subdivision (1) of subsection 7 of this section, each refunding retirement system shall pay to the state employees' retirement system, by December 31, 1990, an amount actuarially determined to equal the liability transferred from such retirement systems. At least ninety days before each regular session of the general assembly the board of trustees of the affected public school retirement system shall certify to the division of budget an actuarially determined estimate of the amount which will be necessary during the next appropriation period to pay all liabilities, including costs of administration, which shall exist or accrue under subsections 1 through 7 of this section during such period. The estimate shall be computed as a level percentage of payroll compensation to cover the normal cost and to amortize the accrued liability over a period not to exceed forty years. The commissioner of administration shall request appropriation of the amount calculated under the provisions of this

113 subsection. The commissioner of administration monthly shall requisition and certify the  
114 payment to the executive secretary of the appropriate school retirement system.

115 9. Notwithstanding any provisions of chapter 169 to the contrary, any member who

129 employees or beneficiaries. Lincoln University shall pay to the Missouri state employees'  
130 retirement system on or before July 1, 1988, an amount equal to all funds and securities thereon  
131 contained in the Lincoln University retirement, disability and death benefit plan less the amount  
132 needed to purchase annuities for retiree and survivor benefits.

133 11. Effective July 1, 1988, the Lincoln University board of curators shall certify to the  
134 board of trustees of the Missouri state employees' retirement system all persons eligible to  
135 receive but not yet receiving benefits under the Lincoln University retirement, disability and  
136 death benefit plan, for service prior to June 30, 1988, together with the amounts payable and  
137 supporting documentation as to the methods, plan provisions and data used to calculate such  
138 benefits, to the satisfaction of the board of trustees of the Missouri state employees' retirement  
139 system, and the Missouri state employees' retirement system shall assume responsibility for  
140 payment of such benefits in the future.

141 12. Any person employed on a full-time basis by Lincoln University on or after July 1,  
142 1988, shall become a member of the Missouri state employees' retirement system, and may elect  
143 in writing to receive creditable prior service for all full-time service to Lincoln University if such  
144 service is not now credited the member under the Missouri state employees' retirement system,  
145 and provided the member elects in writing to forfeit all rights accrued under the Lincoln  
146 University retirement, disability and death benefit plan for such service.

147 13. (1) Any person who is employed by Harris-Stowe State College as a teacher or  
148 administrator on August 28, 1995, who was employed full time by Harris-Stowe College prior

149 to September 1, 1978, who became a member of the Missouri state employees' retirement system  
150 on or after September 1, 1978, and who has been continuously employed by the college, may  
151 purchase creditable prior service for any service rendered to Harris-Stowe College prior to  
152 September 1, 1978, which is not otherwise credited under the Missouri state employees'

154 (2) Any person eligible to purchase creditable prior service under the provisions of

170 (c) If the member had received a refund of contributions related to service covered by  
171 the St. Louis public school retirement system, the amount stipulated in paragraph (a) of this

173 otherwise, such amount shall be paid to the Missouri state employees' retirement system by the  
174 St. Louis public school retirement system;

175 (3) Any amount payable to the Missouri state employees' retirement system by the

194 14. In no event shall any person receive service credit for the same period of service

104.1024. 1. Any member who terminates employment may retire on or after attaining  
2 normal retirement eligibility by making application in written form and manner approved by the  
3 appropriate board. The written application shall set forth the annuity starting date which shall  
4 not be earlier than the first day of the second month following the month of the execution and  
5 filing of the member's application for retirement nor later than the first day of the fourth month  
6 following the month of the execution and filing of the member's application for retirement. The  
7 payment of the annuity shall be made the last working day of each month, providing all  
8 documentation required under section 104.1027 for the calculation and payment of the benefits  
9 is received by the board.

10 2. A member's annuity shall be paid in the form of a life annuity, except as provided in  
11 section 104.1027, and shall be an amount for life equal to one and seven-tenths percent of the  
12 final average pay of the member multiplied by the member's years of credited service.

13 3. The life annuity defined in subsection 2 of this section shall not be less than a monthly  
14 amount equal to fifteen dollars multiplied by the member's full years of credited service.

15 4. If as of the annuity starting date of a member who has attained normal retirement  
16 eligibility the sum of the member's years of age and years of credited service equals eighty or  
17 more years and if the member's age is at least forty-eight years but less than sixty-two years, or,  
18 in the case of a member of the highway patrol who shall be subject to the mandatory retirement  
19 provision of section 104.080, the mandatory retirement age and completion of five years of  
20 credited service, then in addition to the life annuity described in subsection 2 of this section, the  
21 member shall receive a temporary annuity equal to eight-tenths of one percent of the member's

22 final average pay multiplied by the member's years of credited service. The temporary annuity  
23 and any cost-of-living adjustments attributable to the temporary annuity pursuant to section  
24 104.1045 shall terminate at the end of the calendar month in which the earlier of the following  
25 events occurs: the member's death or the member's attainment of the earliest age of eligibility  
26 for reduced Social Security retirement benefits, but no later than age sixty-two.

27 5. The annuity described in subsection 2 of this section for any person who has credited  
28 service not covered by the federal Social Security Act, as provided in sections 105.300 to  
29 [105.445] **105.430**, shall be calculated as follows: the life annuity shall be an amount equal to  
30 two and five-tenths percent of the final average pay of the member multiplied by the number of  
31 years of service not covered by the federal Social Security Act in addition to one and  
32 seven-tenths percent of the final average pay of the member multiplied by the member's years  
33 of credited service covered by the federal Social Security Act.

34 6. Effective July 1, 2002, any member, except an elected official or a member of the  
35 general assembly, who has not been paid retirement benefits and continues employment for at  
36 least two years beyond the date of normal retirement eligibility, may elect to receive an annuity  
37 and lump sum payment or payments, determined as follows:

38 (1) A retroactive starting date shall be established which shall be a date selected by the  
39 member; provided, however, that the retroactive starting date selected by the member shall not  
40 be a date which is earlier than the date when a normal annuity would have first been payable.  
41 In addition, the retroactive starting date shall not be more than five years prior to the annuity  
42 starting date. The member's selection of a retroactive starting date shall be done in twelve-month  
43 increments, except this restriction shall not apply when the member selects the total available  
44 time between the retroactive starting date and the annuity starting date;

45 (2) The prospective annuity payable as of the annuity starting date shall be determined  
46 pursuant to the provisions of this section, with the exception that it shall be the amount which  
47 would have been payable at the annuity starting date had the member actually retired on the  
48 retroactive starting date under the retirement plan selected by the member. Other than for the  
49 lump sum payment or payments specified in subdivision (3) of this subsection, no other amount  
50 shall be due for the period between the retroactive starting date and the annuity starting date;

51 (3) The lump sum payable shall be ninety percent of the annuity amounts which would  
52 have been paid to the member from the retroactive starting date to the annuity starting date had  
53 the member actually retired on the retroactive starting date and received a life annuity. The  
54 member shall elect to receive the lump sum amount either in its entirety at the same time as the  
55 initial annuity payment is made or in three equal annual installments with the first payment made  
56 at the same time as the initial annuity payment;

57 (4) Any annuity payable pursuant to this section that is subject to a division of benefit  
58 order pursuant to section 104.1051 shall be calculated as follows:

59 (a) Any service of a member between the retroactive starting date and the annuity  
60 starting date shall not be considered credited service except for purposes of calculating the  
61 division of benefit; and

62 (b) The lump sum payment described in subdivision (3) of this section shall not be  
63 subject to any division of benefit order; and

64 (5) For purposes of determining annual benefit increases payable as part of the lump sum  
65 and annuity provided pursuant to this section, the retroactive starting date shall be considered the  
66 member's date of retirement.

105.300. When used in sections 105.300 to [105.440] **105.430**, the following terms

3 (1) "Applicable federal law", those provisions of the federal law, including federal

5 benefits of Title 2 of the Social Security Act (42 U.S.C.A. § 401 et seq.) to employees of states,  
6 political subdivisions and their instrumentalities;

7 (2) "Employee", elective or appointive officers and employees of the state, including  
8 members of the general assembly, and elective or appointive officers and employees of any  
9 political subdivision of the state, including county officers remunerated wholly by fees from  
10 sources other than county funds, or any instrumentality of either the state or such political  
11 subdivisions; and employees of a group of two or more political subdivisions of the state  
12 organized to perform common functions or services;

13 (3) "Employee tax", the tax imposed by section 1400 of the federal Internal Revenue  
14 Code of 1939 and section 3101 of the federal Internal Revenue Code of 1954;

15 (4) "Employment", any service performed by any employee of the state or any of its  
16 political subdivisions or any instrumentality of either of them, which may be covered, under  
17 applicable federal law, in the agreement between the state and the [Secretary of Health,  
18 Education and Welfare] **Commissioner of the Social Security Administration**, except services,  
19 which in the absence of an agreement entered into under sections 105.300 to [105.440] **105.430**  
20 would constitute "employment" as defined in section 210 of the Social Security Act (42 U.S.C.A.  
21 § 410); any services performed by an employee as a member of a coverage group, in positions  
22 covered by a retirement system on the date such agreement is made applicable to such coverage  
23 group, which retirement system is supported wholly or in part by the state or any of its

instrumentalities or political subdivisions, shall not be considered as "employment" within the meaning of sections 105.300 to [105.440] **105.430**; however, service which under the Social Security Act may be included only upon certification by the governor in accordance with section 218(d)(3) of that act shall be included in the term "employment" if and when the governor issues, with respect to such service, a certificate to the [Secretary of Health, Education and Welfare pursuant to] **Commissioner of the Social Security Administration** under section 105.353;

(5) "Federal agency", any federal officer, department, or agency which is charged on behalf of the federal government with the particular federal function referred to in connection with such term;

(6) "Federal Insurance Contributions Act", subchapter A of chapter 9 of the federal Internal Revenue Code of 1939 and subchapters A and B of chapter 21 of the federal Internal Revenue Code of 1954, as such codes have been and may be amended;

(7) "Instrumentality", an instrumentality of a state or of one or more of its political subdivisions but only if such instrumentality is a juristic entity which is legally separate and distinct from the state or such political subdivision and whose employees are not by virtue of their relation to such juristic entity employees of the state or such subdivision;

(8) "Political subdivision", any county, township, municipal corporation, school district, or other governmental entity of equivalent rank;

(9) "Social Security Act", the act of Congress approved August 14, 1935, Title 42, Chapter 7, United States Code, officially cited as the "Social Security Act", (42 U.S.C.A. § 401, et seq.), as such act has been and may from time to time be amended;

(10) "State administrator", director, division of accounting, office of administration;

(11) "State agency", office of administration, division of accounting;

(12) "Wages", all remuneration for employment as defined herein, including the cash value of all remuneration paid in any medium other than cash, except that the term shall not include that part of such remuneration which, even if it were for "employment" within the meaning of the federal Insurance Contributions Act, would not constitute "wages" within the meaning of that act.

EXPLANATION: OBSOLETE SOCIAL SECURITY PROVISIONS ARE CHANGED TO BRING MISSOURI INTO COMPLIANCE WITH FEDERAL LAW:

105.310. 1. The state agency, with the approval of the governor, shall enter into on behalf of the state an agreement with the [Secretary of Health and Human Services] **Commissioner of the Social Security Administration**, consistent with sections 105.300 to [105.440] **105.430**, for the purpose of extending the benefits of the federal old age and survivors insurance system to employees of the state or of any of its political subdivisions, or of any

6 instrumentality of any one or more of them, with respect to services specified in such agreement,  
7 which constitute employment as defined in section 105.300. Such agreement may contain  
8 provisions relating to coverage, benefits, contributions, effective date, modifications and  
9 termination of the agreement, administration and other appropriate provisions, and except as

14 2. A modification entered into after December 31, 1954, and prior to January 1, 1958,

17 3. All services which constitute employment as defined in section 105.300 and are  
18 performed in the employ of the state by employees of the state shall be covered by the agreement.

19 4. [All services shall be covered by the agreement which:

20 (1) Constitute employment as defined in section 105.300;

21 (2) Are performed in the employ of a political subdivision or in the employ of an  
22 instrumentality of either the state or a political subdivision; except services performed in the  
23 employ of any municipality in connection with its operation of a public transportation system as  
24 defined in section 210(1) of the Social Security Act (42 U.S.C.A. § 410); and there is hereby  
25 granted to the governing body of such municipality and the officers in charge of such  
26 transportation system such powers and authority as may be necessary to comply with the Social  
27 Security Act in extending the benefits of the federal old age and survivors insurance system to  
28 the employees of such public transportation system; and

29 (3) Are covered by a plan which is in conformity with the terms of the agreement  
30 approved by the state agency under section 105.350] **Services which constitute employment**  
31 **as defined in section 105.300 and Section 210 of the Social Security Act, 42 U.S.C. Section**  
32 **410, and are performed in the employ of a political subdivision or instrumentality of the**  
33 **state may be covered as defined by the terms of the agreement.**

34 5. As modified the agreement shall include all services described in either subsection 3  
35 or 4 of this section and performed by individuals in positions covered by a retirement system  
36 with respect to which the governor has issued a certificate to the [Secretary of Health and Human  
37 Services pursuant to] **Commissioner of the Social Security Administration under** section  
38 105.353.

39

40 EXPLANATION: OBSOLETE SOCIAL SECURITY PROVISIONS ARE CHANGED TO  
41 BRING MISSOURI INTO COMPLIANCE WITH FEDERAL LAW:

105.330. Any instrumentality jointly created by this state and any other state or states is hereby authorized upon the granting of like authority by such other state or states:

(1) To enter into an agreement with the [Secretary of Health, Education and Welfare] **Commissioner of the Social Security Administration** whereby the benefits of the federal old age and survivors insurance system shall be extended to employees of such instrumentality;

(2) To require its employees to pay, and for that purpose deduct from their wages, contributions equal to the amounts which they would be required to pay under section 105.340, subsection 1, if they were covered by an agreement made pursuant to section 105.310;

(3) To make payments to the Secretary of the Treasury in accordance with such agreement, including payments from its own funds, and otherwise to comply with such agreements. Such agreement, to the extent practicable, shall be consistent with the provisions of sections 105.300 to [105.440] **105.430**.

105.340. 1. Every employee of the state whose services are covered by an agreement entered into under section 105.310 shall be required to pay for the period of coverage to the trustee contributions with respect to wages equal to the amount of the employee tax which would be imposed by the Federal Insurance Contributions Act (26 U.S.C.A. § 1400). The liability shall arise in consideration of the employee's retention in the service, or his entry upon service after the passage of sections 105.300 to [105.440] **105.430**.

2. The contributions imposed by this section shall be collected by the trustee by deducting the amount of the contributions from wages paid, but failure to make the deductions shall not relieve the employee from liability for the contribution.

3. If more or less than the correct amount of the employee's contribution is paid or deducted with respect to any remuneration, proper adjustments or refund shall be made, without interest, in such manner and at such times as the state agency shall prescribe.

25 coverage unit shall make reports, in the form and containing such information as the state agency  
26 may from time to time require, and that it shall comply with all provisions which the state or  
27 federal agency may find necessary to assure the correctness and verification of such reports].

16 2. Upon receiving evidence satisfactory to him that with respect to any referendum the  
17 conditions specified in section 218(d)(3) of the Social Security Act have been met, the governor  
18 shall so certify to the [Secretary of Health, Education and Welfare] **Commissioner of the Social**  
19 **Security Administration.**

20 3. In the event the employees in positions covered by the public school retirement system  
21 of Missouri, except employees of any state college or state teachers' college, vote to be included  
22 under an agreement under sections 105.300 to [105.440] **105.430**, the employing political  
23 subdivision, instrumentalities and the state shall enter into and execute an agreement with the  
24 state agency for extending the benefits of Title 2 of the Social Security Act (42 U.S.C.A. § 401  
25 et seq.) to their employees.

27 EXPLANATION: OBSOLETE SOCIAL SECURITY PROVISIONS ARE CHANGED TO  
28 BRING MISSOURI INTO COMPLIANCE WITH FEDERAL LAW:

105.370. 1. Each political subdivision or instrumentality whose plan has been approved  
2 under section 105.350 shall pay to the [trustee with respect to wages at such times as the state  
3 agency may prescribe contributions in the amounts and at the rates specified in the agreement  
4 entered into by the state agency] **Internal Revenue Service contributions, together with any**  
5 **applicable interest and penalties, in the amounts and at the rates prescribed by federal law.**

6 2. Each political subdivision or instrumentality required to make payments under  
7 sections 105.300 to [105.440] **105.430** is authorized, in consideration of the employee's retention  
8 in, or entry upon, employment after the passage of sections 105.300 to [105.440] **105.430**, to  
9 impose upon its employees, as to services which are covered by an approved plan, a contribution  
10 with respect to wages, not exceeding the amount of the employee tax which would be imposed  
11 by the Federal Insurance Contributions Act (26 U.S.C.A. § 1400) and to deduct the amount of  
12 the contribution from the wages when paid. Contributions so collected shall be paid to the  
13 [trustee] **Internal Revenue Service** in partial discharge of the liability of the political  
14 subdivision or instrumentality. Failure to deduct the contribution shall not relieve the employee  
15 or employer of liability therefor.

135.210. 1. Any governing authority which desires to have any portion of a city or  
2 unincorporated area of a county under its control designated as an enterprise zone shall hold a  
3 public hearing for the purpose of obtaining the opinion and suggestions of those persons who  
4 will be affected by such designation. The governing authority shall notify the director of such  
5 hearing at least thirty days prior thereto and shall publish notice of such hearing in a newspaper

6 of general circulation in the area to be affected by such designation at least twenty days prior to  
7 the date of the hearing but not more than thirty days prior to such hearing. Such notice shall state  
8 the time, location, date and purpose of the hearing. The director, or the director's designee, shall  
9 attend such hearing.

10 2. After a public hearing is held as required in subsection 1 of this section, the governing  
11 authority may file a petition with the department requesting the designation of a specific area as  
12 an enterprise zone. Such petition shall include, in addition to a description of the physical,

24 designation of the area as an enterprise zone;

25 (5) A statement describing the projected positive and negative effects of designation of  
26 the area as an enterprise zone; and

27 (6) A specific plan to provide assistance to any person or business dislocated as a result  
28 of activities within the zone. Such plan shall determine the need of dislocated persons for  
29 relocation assistance; provide, prior to displacement, information about the type, location and  
30 price of comparable housing or commercial property; provide information concerning state and  
31 federal programs for relocation assistance and provide other advisory services to displaced  
32 persons. Public agencies may choose to provide assistance under the Uniform Relocation and  
33 Real Property Acquisition Act, 42 U.S.C. section 4601, et seq. to meet the requirements of this  
34 subdivision.

35 3. [Notwithstanding the provisions of section 135.250, the director of the department of  
36 economic development shall, prior to the designation of any enterprise zone, submit to the joint  
37 committee on economic development policy and planning, established in section 620.602, rules  
38 and regulations pertaining to the designation of enterprise zones. Following approval by the joint  
39 committee, such rules and regulations shall be issued pursuant to the provisions of section  
40 536.021. Upon approval of an enterprise zone designation by the department, the director shall  
41 submit such enterprise zone designation to the joint committee for its approval. An enterprise

42 zone designation shall be effective upon such approval by the joint committee. The director shall  
43 report annually to the joint committee the number and location of all enterprise zones designated,  
44 together with the business activity within each designated enterprise zone.

45 4.] No more than fifty such areas may be designated by the director as an enterprise zone  
46 under the provisions of this subsection, except that any enterprise zones authorized apart from  
47 this subsection by specific legislative enactment, on or after August 28, 1991, shall not be  
48 counted toward the limitation set forth in this subsection. After fifty enterprise zones, plus any  
49 others authorized apart from this subsection by specific legislative enactment first designated on  
50 or after August 28, 1991, have been designated by the director, additional enterprise zones may

59 five-year period, including business investments and the creation of new jobs. [The director shall  
60 present the director's evaluation to the joint legislative committee on economic development  
61 policy and planning.] If the director finds that the plan outlined in the application for designation  
62 was not implemented in good faith, or if such zone no longer qualifies under the original criteria,

65 cancelled. All agreements negotiated under the benefits of such zone shall remain in effect for  
66 the originally agreed upon duration. The [committee] **director** shall schedule a hearing on such  
67 recommendation for not later than sixty days after the recommendation is filed with it. At the  
68 hearing, interested parties, including the director, may present witnesses and evidence as to why  
69 the enterprise zone designation for that particular area should be continued or cancelled. Within  
70 thirty days after the hearing, the [committee] **director** shall determine whether or not the  
71 designation should be continued. If it is not continued, the director shall remove the designation  
72 from the area and, following the procedures outlined in this section, award the designation of an  
73 enterprise zone to another applicant. If an area has requested a designated enterprise zone, and  
74 met all existing statutory requirements, but has not been designated such, then the applicant may  
75 appeal [to the joint legislative committee on economic development policy and planning] for a  
76 hearing to determine its eligibility for such a designation. [The review of the director's  
77 evaluation and the hearing thereon, and any appeal as provided for in this subsection, by the joint

7 number of tons sold to each person;

9 **development** reasonably requires. The application shall be received and reviewed by the  
10 division of energy of the department of [natural resources] **economic development** and the  
11 division shall certify to the department of revenue each applicant which qualifies as a wood  
12 energy-producing facility.

14 EXPLANATION: THE DEPARTMENT REFERENCE IN THIS SECTION IS OBSOLETE

135.950. The following terms, whenever used in sections 135.950 to 135.970 mean:

2 (1) "Average wage", the new payroll divided by the number of new jobs;

3 (2) "Blighted area", an area which, by reason of the predominance of defective or  
4 inadequate street layout, unsanitary or unsafe conditions, deterioration of site improvements,  
5 improper subdivision or obsolete platting, or the existence of conditions which endanger life or  
6 property by fire and other causes, or any combination of such factors, retards the provision of  
7 housing accommodations or constitutes an economic or social liability or a menace to the public  
8 health, safety, morals, or welfare in its present condition and use. The term "blighted area" shall  
9 also include any area which produces or generates or has the potential to produce or generate  
10 electrical energy from a renewable energy resource, and which, by reason of obsolescence,  
11 decadence, blight, dilapidation, deteriorating or inadequate site improvements, substandard  
12 conditions, the predominance or defective or inadequate street layout, unsanitary or unsafe  
13 conditions, improper subdivision or obsolete platting, or the existence of conditions which  
14 endanger the life or property by fire or other means, or any combination of such factors, is  
15 underutilized, unutilized, or diminishes the economic usefulness of the land, improvements, or

16 lock and dam site within such area for the production, generation, conversion, and conveyance  
17 of electrical energy from a renewable energy resource;

18 (3) "Board", an enhanced enterprise zone board established pursuant to section 135.957;

19 (4) "Commencement of commercial operations" shall be deemed to occur during the first  
20 taxable year for which the new business facility is first put into use by the taxpayer in the  
21 enhanced business enterprise in which the taxpayer intends to use the new business facility;

22 (5) "County average wage", the average wages in each county as determined by the  
23 department for the most recently completed full calendar year. However, if the computed county  
24 average wage is above the statewide average wage, the statewide average wage shall be deemed  
25 the county average wage for such county for the purpose of determining eligibility. The  
26 department shall publish the county average wage for each county at least annually.  
27 Notwithstanding the provisions of this subdivision to the contrary, for any taxpayer that in  
28 conjunction with their project is relocating employees from a Missouri county with a higher  
29 county average wage, such taxpayer shall obtain the endorsement of the governing body of the  
30 community from which jobs are being relocated or the county average wage for their project shall  
31 be the county average wage for the county from which the employees are being relocated;

32 (6) "Department", the department of economic development;

33 (7) "Director", the director of the department of economic development;

34 (8) "Employee", a person employed by the enhanced business enterprise that is scheduled  
35 to work an average of at least one thousand hours per year, and such person at all times has  
36 health insurance offered to him or her, which is partially paid for by the employer;

37 (9) "Enhanced business enterprise", an industry or one of a cluster of industries that is  
38 either:

39 (a) Identified by the department as critical to the state's economic security and growth;  
40 or

41 (b) Will have an impact on industry cluster development, as identified by the governing  
42 authority in its application for designation of an enhanced enterprise zone and approved by the  
43 department; but excluding gambling establishments (NAICS industry group 7132), retail trade  
44 (NAICS sectors 44 and 45), educational services (NAICS sector 61), religious organizations  
45 (NAICS industry group 8131), public administration (NAICS sector 92), and food and drinking  
46 places (NAICS subsector 722), however, notwithstanding provisions of this section to the  
47 contrary, headquarters or administrative offices of an otherwise excluded business may qualify  
48 for benefits if the offices serve a multistate territory. In the event a national, state, or regional  
49 headquarters operation is not the predominant activity of a project facility, the new jobs and  
50 investment of such headquarters operation is considered eligible for benefits under this section

51 if the other requirements are satisfied. Service industries may be eligible only if a majority of  
52 its annual revenues will be derived from out of the state;

53 (10) "Existing business facility", any facility in this state which was employed by the  
54 taxpayer claiming the credit in the operation of an enhanced business enterprise immediately  
55 prior to an expansion, acquisition, addition, or replacement;

56 (11) "Facility", any building used as an enhanced business enterprise located within an  
57 enhanced enterprise zone, including the land on which the facility is located and all machinery,  
58 equipment, and other real and depreciable tangible personal property acquired for use at and  
59 located at or within such facility and used in connection with the operation of such facility;

60 (12) "Facility base employment", the greater of the number of employees located at the  
61 facility on the date of the notice of intent, or for the twelve-month period prior to the date of the  
62 notice of intent, the average number of employees located at the facility, or in the event the  
63 project facility has not been in operation for a full twelve-month period, the average number of  
64 employees for the number of months the facility has been in operation prior to the date of the  
65 notice of intent;

66 (13) "Facility base payroll", the total amount of taxable wages paid by the enhanced  
67 business enterprise to employees of the enhanced business enterprise located at the facility in the  
68 twelve months prior to the notice of intent, not including the payroll of owners of the enhanced  
69 business enterprise unless the enhanced business enterprise is participating in an employee stock  
70 ownership plan. For the purposes of calculating the benefits under this program, the amount of  
71 base payroll shall increase each year based on the consumer price index or other comparable  
72 measure, as determined by the department;

73 (14) "Governing authority", the body holding primary legislative authority over a county  
74 or incorporated municipality;

75 (15) "Megaproject", any manufacturing or assembling facility, approved by the  
76 department for construction and operation within an enhanced enterprise zone, which satisfies

78 (a) The new capital investment is projected to exceed three hundred million dollars over

90 corresponding classification in subsequent federal industry classification systems;

91           (17) "New business facility", a facility that does not produce or generate electrical energy  
92 from a renewable energy resource and satisfies the following requirements:

93           (a) Such facility is employed by the taxpayer in the operation of an enhanced business  
94 enterprise. Such facility shall not be considered a new business facility in the hands of the  
95 taxpayer if the taxpayer's only activity with respect to such facility is to lease it to another person  
96 or persons. If the taxpayer employs only a portion of such facility in the operation of an  
97 enhanced business enterprise, and leases another portion of such facility to another person or  
98 persons or does not otherwise use such other portions in the operation of an enhanced business  
99 enterprise, the portion employed by the taxpayer in the operation of an enhanced business

109 enhanced business enterprise, the operation of the same or a substantially similar enhanced  
110 business enterprise is not continued by the taxpayer at such facility; and

111           (d) Such facility is not a replacement business facility, as defined in subdivision (27) of  
112 this section;

113           (18) "New business facility employee", an employee of the taxpayer in the operation of  
114 a new business facility during the taxable year for which the credit allowed by section 135.967  
115 is claimed, except that truck drivers and rail and barge vehicle operators and other operators of  
116 rolling stock for hire shall not constitute new business facility employees;

117           (19) "New business facility investment", the value of real and depreciable tangible  
118 personal property, acquired by the taxpayer as part of the new business facility, which is used by  
119 the taxpayer in the operation of the new business facility, during the taxable year for which the  
120 credit allowed by 135.967 is claimed, except that trucks, truck-trailers, truck semitrailers, rail  
121 vehicles, barge vehicles, aircraft and other rolling stock for hire, track, switches, barges, bridges,

122 tunnels, and rail yards and spurs shall not constitute new business facility investments. The total  
123 value of such property during such taxable year shall be:

124 (a) Its original cost if owned by the taxpayer; or

166 from a renewable energy resource;

- 169 (b) Solar thermal sources or photovoltaic cells and panels;
- 170 (c) Dedicated crops grown for energy production;
- 171 (d) Cellulosic agricultural residues;

198 exceeds the total number of employees at the old facility by at least two;

199 (28) "Same or substantially similar enhanced business enterprise", an enhanced business  
200 enterprise in which the nature of the products produced or sold, or activities conducted, are  
201 similar in character and use or are produced, sold, performed, or conducted in the same or similar  
202 manner as in another enhanced business enterprise.

Any moneys deposited in such fund shall be used to support programs that prepare children prior to the age in which they are eligible to enroll in kindergarten under section 160.053 to enter school ready to learn. All moneys deposited in the early childhood development, education and care fund shall be annually appropriated for voluntary early childhood development, education and care programs serving children in every region of the state not yet enrolled in kindergarten. For fiscal year 2013 and each subsequent fiscal year, at least thirty-five million dollars of the funds received from the master settlement agreement, as defined in section 196.1000, shall be deposited in the early childhood development, education and care fund.

3. [Only textbooks which are filed with the state board of education pursuant to section 170.061 shall be purchased and loaned under this section. No textbooks shall be purchased or loaned under this section to be used in any form of religious instruction or worship.

4.] Each school board shall purchase from the incidental fund of the district all the new or used textbooks for all the pupils in all grades and preschool programs of the public schools of the district. The board may also expend incidental fund moneys to provide supplementary texts, library and reference books, contractual educational television services, and any other instructional supplies for all the pupils of the public schools of the district. All books purchased from district funds are the property of the district but shall be furnished, under rules and regulations prescribed by the school board, to the pupils without charge, except for abuse or willful destruction.

(6) Require providers to be tested for tuberculosis on the schedule required for employees in licensed facilities;

(7) Require providers to notify parents if the provider does not have immediate access to a telephone;

(8) Make providers aware of local opportunities for training in first aid and child care;

(9) Promulgate rules and regulations to define preservice training requirements for child care providers and employees pursuant to applicable federal laws and regulations;

(10) Establish procedures for conducting unscheduled on-site monitoring of child care providers prior to receiving state or federal funds for providing child care services either by direct payment or through reimbursement to a child care beneficiary, and annually thereafter;

(11) Require child care providers who receive assistance under applicable federal laws and regulations to report to the department any serious injuries or death of children occurring in child care; and

144 and convincing evidence that grounds exist for termination pursuant to subsection 2, 4 or 5 of  
145 this section.

146           7. When considering whether to terminate the parent-child relationship pursuant to  
147 subsection 2 or 4 of this section or subdivision (1), (2), (3) or (4) of subsection 5 of this section,  
148 the court shall evaluate and make findings on the following factors, when appropriate and  
149 applicable to the case:

150           (1) The emotional ties to the birth parent;

151           (2) The extent to which the parent has maintained regular visitation or other contact with  
152 the child;

153           (3) The extent of payment by the parent for the cost of care and maintenance of the child  
154 when financially able to do so including the time that the child is in the custody of the division  
155 or other child-placing agency;

156           (4) Whether additional services would be likely to bring about lasting parental  
157 adjustment enabling a return of the child to the parent within an ascertainable period of time;

158           (5) The parent's disinterest in or lack of commitment to the child;

159           (6) The conviction of the parent of a felony offense that the court finds is of such a  
160 nature that the child will be deprived of a stable home for a period of years; provided, however,  
161 that incarceration in and of itself shall not be grounds for termination of parental rights;

162           (7) Deliberate acts of the parent or acts of another of which the parent knew or should  
163 have known that subjects the child to a substantial risk of physical or mental harm.

164           8. The court may attach little or no weight to infrequent visitations, communications, or  
165 contributions. It is irrelevant in a termination proceeding that the maintenance of the  
166 parent-child relationship may serve as an inducement for the parent's rehabilitation.

167           9. In actions for adoption pursuant to chapter 453, the court may hear and determine the  
168 issues raised in a petition for adoption containing a prayer for termination of parental rights filed  
169 with the same effect as a petition permitted pursuant to subsection 2, 4, or 5 of this section.

170           10. The disability or disease of a parent shall not constitute a basis for a determination  
171 that a child is a child in need of care, for the removal of custody of a child from the parent, or for  
172 the termination of parental rights without a specific showing that there is a causal relation  
173 between the disability or disease and harm to the child.

- 226.805. 1. There is hereby created the "Interagency Committee on Special Transportation" within the Missouri department of transportation. The special transportation planning council shall be composed of the area agency on aging, the regional center for developmental disabilities, the regional planning commission and other local organizations responsible for funding and organizing special transportation designated by the interagency committee. The special transportation planning councils will oversee and approve the preparation of special transportation plans. Staff support for the special transportation planning councils will be provided by the regional planning commissions serving the area with funds provided by the department of transportation for this purpose;
  - (3) Jointly establish a uniform planning format and content;
  - (4) Individually and jointly establish uniform budgeting and reporting standards for all transportation funds administered by the member agencies. These standards shall be adopted into the administrative rules of each member agency;
  - (5) Individually establish annual allocations of funds to support special transportation services in each of the designated planning and service areas;
  - (6) Individually and jointly adopt a five-year planning budget for the capital and operating needs of special transportation in Missouri;
  - (7) Individually develop administrative and adopt rules for the substate division of special transportation funds;

36 (8) Jointly review and accept annual capital and operating plans for the designated  
37 special transportation planning and service areas;

38 (9) Individually submit proposed expenditures to the interagency committee for review

8 commission as provided by chapter 621 against any holder of any license issued under sections

41 (10) The applicant or license holder is finally adjudged insane or incompetent by a court

43 (11) Use of any advertisement or solicitation which is false;

44 (12) Violations of sections 407.511 to 407.556, section 578.120, which resulted in a  
45 conviction or finding of guilt or violation of any federal motor vehicle laws which result in a

47 3. Any such complaint shall be filed within one year of the date upon which the  
48 department receives notice of an alleged violation of an applicable statute or regulation. After  
49 the filing of such complaint, the proceedings shall, except for the matters set forth in subsection  
50 5 of this section, be conducted in accordance with the provisions of chapter 621. Upon a finding  
51 by the administrative hearing commission that the grounds, provided in subsection 2 of this  
52 section, for disciplinary action are met, the department may, singly or in combination, refuse to  
53 issue the person a license, issue a license for a period of less than two years, issue a private

92 (2) For any license which the department believes may be subject to suspension or

(3) At any hearing before the director conducted under this subsection, the director or his or her designated hearing officer shall consider all evidence relevant to the issue of whether the license should be suspended or revoked due to the occurrence of any of the acts set forth in subsection 5 herein. Within twenty business days after such hearing, the director or his or her designated hearing officer shall issue a written order, with findings of fact and conclusions of law, which either grants or denies the issuance of an order of suspension or revocation. The suspension or revocation shall be effective ten days after the date of the order. The written order of the director or his or her hearing officer shall be the final decision of the director and shall be subject to judicial review under the provisions of chapter 536.

In lieu of acting under subsection 2 or 6 of this section, the department of revenue may enter into an agreement with the holder of the license to ensure future compliance with sections 301.210, 301.213, 307.380, sections 301.217 to 301.229, and sections 301.550 to 301.580. Such agreement may include an assessment fee not to exceed five hundred dollars per violation or five thousand dollars in the aggregate unless otherwise permitted by law, probation terms and conditions, and other requirements as may be deemed appropriate by the department of revenue and the holder of the license. Any fees collected by the department of revenue under this subsection shall be deposited into the motor vehicle commission fund created in section 301.560.

EXPLANATION: CHANGES THE LANGUAGE IN PARAGRAPH (a) OF SUBDIVISION (10) OF SUBSECTION 2 TO COMPLY WITH FEDERAL LAW:

302.700. 1. Sections 302.700 to 302.780 may be cited as the "Uniform Commercial Driver's License Act".

2. When used in sections 302.700 to 302.780, the following words and phrases mean:

(1) "Alcohol", any substance containing any form of alcohol, including, but not limited to, ethanol, methanol, propanol and isopropanol;

6 (2) "Alcohol concentration", the number of grams of alcohol per one hundred milliliters  
7 of blood or the number of grams of alcohol per two hundred ten liters of breath or the number  
8 of grams of alcohol per sixty-seven milliliters of urine;

9 (3) "CDL driver", a person holding or required to hold a commercial driver's license  
10 (CDL);

11 (4) "CDLIS driver record", the electronic record of the individual commercial driver's  
12 status and history stored by the state of record as part of the Commercial Driver's License  
13 Information System (CDLIS) established under 49 U.S.C. Section 31309, et seq.;

14 (5) "CDLIS motor vehicle record (CDLIS MVR)", a report generated from the CDLIS  
15 driver record which meets the requirements for access to CDLIS information and is provided by  
16 states to users authorized in 49 CFR 384, subject to the provisions of the Driver Privacy  
17 Protection Act, 18 U.S.C. Sections 2721 to 2725, et seq.;

18 (6) "Commercial driver's instruction permit", a commercial learner's permit issued to an  
19 individual by a state or other jurisdiction of domicile in accordance with the standards contained  
20 in 49 CFR 383, which, when carried with a valid driver's license issued by the same state or  
21 jurisdiction, authorizes the individual to operate a class of commercial motor vehicle when  
22 accompanied by a holder of a valid commercial driver's license for purposes of behind-the-wheel  
23 training. When issued to a commercial driver's license holder, a commercial learner's permit  
24 serves as authorization for accompanied behind-the-wheel training in a commercial motor  
25 vehicle for which the holder's current commercial driver's license is not valid;

26 (7) "Commercial driver's license (CDL)", a license issued by this state or other  
27 jurisdiction of domicile in accordance with 49 CFR 383 which authorizes the individual to  
28 operate a class of commercial motor vehicle;

29 (8) "Commercial driver's license downgrade", occurs when:

30 (a) A driver changes the self-certification to interstate, but operates exclusively in  
31 transportation or operation excepted from 49 CFR 391, as provided in 49 CFR 390.3(f), 391.2,  
32 391.68, or 398.3;

33 (b) A driver changes the self-certification to intrastate only, if the driver qualifies under  
34 the state's physical qualification requirements for intrastate only;

35 (c) A driver changes the self-certification to intrastate, but operating exclusively in  
36 transportation or operations excepted from all or part of the state driver qualification  
37 requirements; or

38 (d) The state removes the commercial driver's license privilege from the driver's license;

39 (9) "Commercial driver's license information system (CDLIS)", the information system  
40 established pursuant to the Commercial Motor Vehicle Safety Act of 1986 (Title XII of Pub. Law

41 99-570) to serve as a clearinghouse for locating information related to the licensing and  
42 identification of commercial motor vehicle drivers;

43 (10) "Commercial motor vehicle", a motor vehicle or combination of motor vehicles  
44 used in commerce to transport passengers or property;

45 (a) If the vehicle has a gross combination weight rating or gross combination weight of  
46 twenty-six thousand one or more pounds, **whichever is greater**, inclusive of a towed unit which  
47 has a gross vehicle weight rating or gross vehicle weight of more than ten thousand [one] pounds  
48 [or more], whichever is greater;

49 (b) If the vehicle has a gross vehicle weight rating or gross vehicle weight of twenty-six  
50 thousand one or more pounds, whichever is greater;

51 (c) If the vehicle is designed to transport sixteen or more passengers, including the  
52 driver; or

53 (d) If the vehicle is transporting hazardous materials and is required to be placarded  
54 under the Hazardous Materials Transportation Act (46 U.S.C. Section 1801, et seq.);

55 (11) "Controlled substance", any substance so classified under Section 102(6) of the  
56 Controlled Substances Act (21 U.S.C. Section 802(6)), and includes all substances listed in  
57 Schedules I through V of 21 CFR 1308, as they may be revised from time to time;

58 (12) "Conviction", an unvacated adjudication of guilt, including pleas of guilt and nolo  
59 contendere, or a determination that a person has violated or failed to comply with the law in a  
60 court of original jurisdiction or an authorized administrative proceeding, an unvacated forfeiture  
61 of bail or collateral deposited to secure the person's appearance in court, the payment of a fine  
62 or court cost, or violation of a condition of release without bail, regardless of whether the penalty  
63 is rebated, suspended or prorated, including an offense for failure to appear or pay;

64 (13) "Director", the director of revenue or his authorized representative;

65 (14) "Disqualification", any of the following three actions:

66 (a) The suspension, revocation, or cancellation of a commercial driver's license or  
67 commercial driver's instruction permit;

68 (b) Any withdrawal of a person's privileges to drive a commercial motor vehicle by a  
69 state, Canada, or Mexico as the result of a violation of federal, state, county, municipal, or local  
70 law relating to motor vehicle traffic control or violations committed through the operation of  
71 motor vehicles, other than parking, vehicle weight, or vehicle defect violations;

72 (c) A determination by the Federal Motor Carrier Safety Administration that a person  
73 is not qualified to operate a commercial motor vehicle under 49 CFR 383.52 or 391;

74 (15) "Drive", to drive, operate or be in physical control of a commercial motor vehicle;

75 (16) "Driver", any person who drives, operates, or is in physical control of a motor  
76 vehicle, or who is required to hold a commercial driver's license;

77 (17) "Driver applicant", an individual who applies to obtain, transfer, upgrade, or renew  
78 a commercial driver's license or commercial driver's instruction permit in this state;

79 (18) "Driving under the influence of alcohol", the commission of any one or more of the  
80 following acts:

81 (a) Driving a commercial motor vehicle with the alcohol concentration of four  
82 one-hundredths of a percent or more as prescribed by the Secretary or such other alcohol  
83 concentration as may be later determined by the Secretary by regulation;

84 (b) Driving a commercial or noncommercial motor vehicle while intoxicated in violation  
85 of any federal or state law, or in violation of a county or municipal ordinance;

86 (c) Driving a commercial or noncommercial motor vehicle with excessive blood alcohol  
87 content in violation of any federal or state law, or in violation of a county or municipal  
88 ordinance;

89 (d) Refusing to submit to a chemical test in violation of section 302.574, section  
90 302.750, any federal or state law, or a county or municipal ordinance; or

91 (e) Having any state, county or municipal alcohol-related enforcement contact, as defined  
92 in subsection 3 of section 302.525; provided that any suspension or revocation pursuant to  
93 section 302.505, committed in a noncommercial motor vehicle by an individual twenty-one years

97 of at least two-hundredths of one percent or more, and if committed in a commercial motor  
98 vehicle, a concentration of four-hundredths of one percent or more;

99 (19) "Driving under the influence of a controlled substance", the commission of any one  
100 or more of the following acts in a commercial or noncommercial motor vehicle:

101 (a) Driving a commercial or noncommercial motor vehicle while under the influence of  
102 any substance so classified under Section 102(6) of the Controlled Substances Act (21 U.S.C.  
103 Section 802(6)), including any substance listed in Schedules I through V of 21 CFR 1308, as they  
104 may be revised from time to time;

105 (b) Driving a commercial or noncommercial motor vehicle while in a drugged condition  
106 in violation of any federal or state law or in violation of a county or municipal ordinance; or

109 (20) "Electronic device", includes but is not limited to a cellular telephone, personal

113 subdivision of a state, who owns or leases a commercial motor vehicle or assigns a driver to

- 115           (22) "Endorsement", an authorization on an individual's commercial driver's license or  
116 commercial learner's permit required to permit the individual to operate certain types of  
117 commercial motor vehicles;
- 118           (23) "Farm vehicle", a commercial motor vehicle controlled and operated by a farmer  
119 used exclusively for the transportation of agricultural products, farm machinery, farm supplies,  
120 or a combination of these, within one hundred fifty miles of the farm, other than one which  
121 requires placarding for hazardous materials as defined in this section, or used in the operation  
122 of a common or contract motor carrier, except that a farm vehicle shall not be a commercial  
123 motor vehicle when the total combined gross weight rating does not exceed twenty-six thousand  
124 one pounds when transporting fertilizers as defined in subdivision (29) of this subsection;
- 125           (24) "Fatality", the death of a person as a result of a motor vehicle accident;
- 126           (25) "Felony", any offense under state or federal law that is punishable by death or  
127 imprisonment for a term exceeding one year;
- 128           (26) "Foreign", outside the fifty states of the United States and the District of Columbia;
- 129           (27) "Gross combination weight rating" or "GCWR", the value specified by the  
130 manufacturer as the loaded weight of a combination (articulated) vehicle. In the absence of a  
131 value specified by the manufacturer, GCWR will be determined by adding the GVWR of the  
132 power unit and the total weight of the towed unit and any load thereon;
- 133           (28) "Gross vehicle weight rating" or "GVWR", the value specified by the manufacturer  
134 as the loaded weight of a single vehicle;
- 135           (29) "Hazardous materials", any material that has been designated as hazardous under  
136 49 U.S.C. Section 5103 and is required to be placarded under subpart F of CFR 172 or any  
137 quantity of a material listed as a select agent or toxin in 42 CFR 73. Fertilizers, including but  
138 not limited to ammonium nitrate, phosphate, nitrogen, anhydrous ammonia, lime, potash, motor  
139 fuel or special fuel, shall not be considered hazardous materials when transported by a farm  
140 vehicle provided all other provisions of this definition are followed;
- 141           (30) "Imminent hazard", the existence of a condition that presents a substantial  
142 likelihood that death, serious illness, severe personal injury, or a substantial endangerment to  
143 health, property, or the environment may occur before the reasonably foreseeable completion  
144 date of a formal proceeding begins to lessen the risk of that death, illness, injury, or  
145 endangerment;
- 146           (31) "Issuance", the initial licensure, license transfers, license renewals, and license  
147 upgrades;

148           (32) "Manual transmission" (also known as a stick shift, stick, straight drive or standard  
149 transmission), a transmission utilizing a driver-operated clutch that is activated by a pedal or  
150 lever and a gear-shift mechanism operated either by hand or foot. All other transmissions,  
151 whether semiautomatic or automatic, will be considered automatic for the purposes of the  
152 standardized restriction code;

153           (33) "Medical examiner", a person who is licensed, certified, or registered, in accordance  
154 with applicable state laws and regulations, to perform physical examinations. The term includes,  
155 but is not limited to, doctors of medicine, doctors of osteopathy, physician assistants, advanced  
156 practice nurses, and doctors of chiropractic;

157           (34) "Medical variance", when a driver has received one of the following that allows the  
158 driver to be issued a medical certificate:

159           (a) An exemption letter permitting operation of a commercial motor vehicle under 49  
160 CFR 381, Subpart C or 49 CFR 391.64;

161           (b) A skill performance evaluation certificate permitting operation of a commercial  
162 motor vehicle under 49 CFR 391.49;

163           (35) "Mobile telephone", a mobile communication device that is classified as or uses any  
164 commercial mobile radio service, as defined in the regulations of the Federal Communications  
165 Commission, 47 CFR 20.3, but does not include two-way or citizens band radio services;

166           (36) "Motor vehicle", any self-propelled vehicle not operated exclusively upon tracks;

167           (37) "Noncommercial motor vehicle", a motor vehicle or combination of motor vehicles  
168 not defined by the term commercial motor vehicle in this section;

169           (38) "Out of service", a temporary prohibition against the operation of a commercial  
170 motor vehicle by a particular driver, or the operation of a particular commercial motor vehicle,  
171 or the operation of a particular motor carrier;

172           (39) "Out-of-service order", a declaration by an authorized enforcement officer of a  
173 federal, state, Canadian, Mexican or any local jurisdiction, that a driver, or a commercial motor  
174 vehicle, or a motor carrier operation, is out of service under 49 CFR 386.72, 392.5, 392.9a,  
175 395.13, or 396.9, or comparable laws, or the North American Standard Out-of-Service Criteria;

176           (40) "School bus", a commercial motor vehicle used to transport preprimary, primary,  
177 or secondary school students from home to school, from school to home, or to and from  
178 school-sponsored events. School bus does not include a bus used as a common carrier as defined  
179 by the Secretary;

180           (41) "Secretary", the Secretary of Transportation of the United States;

181           (42) "Serious traffic violation", driving a commercial motor vehicle in such a manner  
182 that the driver receives a conviction for the following offenses or driving a noncommercial motor  
183 vehicle when the driver receives a conviction for the following offenses and the conviction

184 results in the suspension or revocation of the driver's license or noncommercial motor vehicle  
185 driving privilege:

186 (a) Excessive speeding, as defined by the Secretary by regulation;

187 (b) Careless, reckless or imprudent driving which includes, but shall not be limited to,  
188 any violation of section 304.016, any violation of section 304.010, or any other violation of

218 than one hundred nineteen gallons and an aggregate rated capacity of one thousand gallons or  
219 more that is either permanently or temporarily attached to the vehicle or the chassis. A

220 commercial motor vehicle transporting an empty storage container tank, not designed for  
221 transportation, with a rated capacity of one thousand gallons or more, that is temporarily attached  
222 to a flatbed trailer is not considered a tank vehicle;

223 (45) "Texting", manually entering alphanumeric text into, or reading text from, an  
224 electronic device. This action includes but is not limited to short message service, emailing,  
225 instant messaging, commanding or requesting access to a website, pressing more than a single  
226 button to initiate or terminate a voice communication using a mobile telephone, or engaging in  
227 any other form of electronic text retrieval or entry, for present or future communication. Texting  
228 does not include:

5 pursuant to the provisions of this chapter is not entitled to a license or a certificate of authority,  
6 may file a written affidavit with the executive director of the board which the affiant shall sign  
7 and swear to and in which the affiant shall clearly set forth the reasons for the affiant's charge  
8 or charges that the license or certificate of an architect or professional engineer or professional  
9 land surveyor **or professional landscape architect** should be suspended or revoked or not  
10 renewed or that a license or certificate should not be issued to an applicant.

11           2. If the affidavit so filed does not contain statements of fact which if true would  
12 authorize, pursuant to the provisions of this chapter, suspension or revocation of the accused's  
13 license or certificate, or does not contain statements of fact which if true would authorize,  
14 pursuant to the provisions of this chapter, the refusal of the renewal of an existing license or  
15 certificate or the refusal of a license or certificate to an applicant, the board shall either dismiss  
16 the charge or charges or, within its discretion, cause an investigation to be made of the charges  
17 contained in the affidavit, after which investigation the board shall either dismiss the charge or  
18 charges or proceed against the accused by written complaint as provided in subsection 3 of this  
19 section.

20           3. If the affidavit contains statements of fact which if true would authorize pursuant to  
21 the provisions of this chapter the revocation or suspension of an accused's license or certificate,  
22 the board shall cause an investigation to be made of the charge or charges contained in the  
23 affidavit and unless the investigation discloses the falsity of the facts upon which the charge or  
24 charges in the affidavit are based, the board shall file with and in the administrative hearing  
25 commission a written complaint against the accused setting forth the cause or causes for which  
26 the accused's license or certificate of authority should be suspended or revoked. Thereafter, the  
27 board shall be governed by and shall proceed in accordance with the provisions of chapter 621.

28           4. If the charges contained in the affidavit filed with the board would constitute a cause  
29 or causes for which pursuant to the provisions of this chapter an accused's license or certificate  
30 of authority should not be renewed or a cause or causes for which pursuant to the provisions of  
31 this chapter a certificate should not be issued, the board shall cause an investigation to be made  
32 of the charge or charges and unless the investigation discloses the falsity of the facts upon which  
33 the charge or charges contained in the affidavit are based, the board shall refuse to permit an  
34 applicant to be examined upon the applicant's qualifications for licensure or shall refuse to issue  
35 or renew a license or certificate of authority, as the case may require.

36           5. The provisions of this section shall not be so construed as to prevent the board on its  
37 own initiative from instituting and conducting investigations and based thereon to make written  
38 complaints in and to the administrative hearing commission.

39           6. If for any reason the provisions of chapter 621 become inapplicable to the board, then,  
40 and in that event, the board shall proceed to charge, adjudicate and otherwise act in accordance  
41 with the provisions of chapter 536.

5 schools and appoint the necessary inspectors and examining assistants;

(17) Using, or permitting the use of, the person's name under the designation of "Doctor", "Dr.", "M.D.", or "D.O.", or any similar designation with reference to the commercial exploitation of any goods, wares or merchandise;

(18) Knowingly making or causing to be made a false statement or misrepresentation of a material fact, with intent to defraud, for payment pursuant to the provisions of chapter 208 or chapter 630 or for payment from Title XVIII or Title XIX of the [federal Medicare program] **Social Security Act**;

(19) Failure or refusal to properly guard against contagious, infectious or communicable diseases or the spread thereof; maintaining an unsanitary office or performing professional services under unsanitary conditions; or failure to report the existence of an unsanitary condition in the office of a physician or in any health care facility to the board, in writing, within thirty days after the discovery thereof;

(20) Any candidate for licensure or person licensed to practice as a physical therapist, paying or offering to pay a referral fee or, notwithstanding section 334.010 to the contrary, practicing or offering to practice professional physical therapy independent of the prescription and direction of a person licensed and registered as a physician and surgeon pursuant to this chapter, as a dentist pursuant to chapter 332, as a podiatrist pursuant to chapter 330, as an advanced practice registered nurse under chapter 335, or any licensed and registered physician,

154 (21) Any candidate for licensure or person licensed to practice as a physical therapist,

Before restoring to good standing a license, certificate or permit issued pursuant to this chapter which has been in a revoked, suspended or inactive state for any cause for more than two years, the board may require the applicant to attend such continuing medical education courses and pass such examinations as the board may direct.

7. In any investigation, hearing or other proceeding to determine a licensee's or applicant's fitness to practice, any record relating to any patient of the licensee or applicant shall be discoverable by the board and admissible into evidence, regardless of any statutory or common law privilege which such licensee, applicant, record custodian or patient might otherwise invoke. In addition, no such licensee, applicant, or record custodian may withhold records or testimony bearing upon a licensee's or applicant's fitness to practice on the ground of privilege between such licensee, applicant or record custodian and a patient.

EXPLANATION: UPDATES THE REFERENCE TO THE COMMISSION ON ACCREDITATION IN PHYSICAL THERAPY EDUCATION IN SUBSECTION 7:

334.506. 1. As used in this section, "approved health care provider" means a person holding a current and active license as a physician and surgeon under this chapter, a chiropractor under chapter 331, a dentist under chapter 332, a podiatrist under chapter 330, a physician assistant under this chapter, an advanced practice registered nurse under chapter 335, or any licensed and registered physician, chiropractor, dentist, or podiatrist practicing in another jurisdiction whose license is in good standing.

2. A physical therapist shall not initiate treatment for a new injury or illness without a prescription from an approved health care provider.

3. A physical therapist may provide educational resources and training, develop fitness or wellness programs for asymptomatic persons, or provide screening or consultative services

11 within the scope of physical therapy practice without the prescription and direction of an  
12 approved health care provider.

13 4. A physical therapist may examine and treat without the prescription and direction of  
14 an approved health care provider any person with a recurring self-limited injury within one year  
15 of diagnosis by an approved health care provider or a chronic illness that has been previously  
16 diagnosed by an approved health care provider. The physical therapist shall:

17 (1) Contact the patient's current approved health care provider within seven days of  
18 initiating physical therapy services under this subsection;

19 (2) Not change an existing physical therapy referral available to the physical therapist  
20 without approval of the patient's current approved health care provider;

21 (3) Refer to an approved health care provider any patient whose medical condition at the  
22 time of examination or treatment is determined to be beyond the scope of practice of physical  
23 therapy;

24 (4) Refer to an approved health care provider any patient whose condition for which  
25 physical therapy services are rendered under this subsection has not been documented to be  
26 progressing toward documented treatment goals after six visits or fourteen days, whichever first  
27 occurs;

28 (5) Notify the patient's current approved health care provider prior to the continuation  
29 of treatment if treatment rendered under this subsection is to continue beyond thirty days. The  
30 physical therapist shall provide such notification for each successive period of thirty days.

31 5. The provision of physical therapy services of evaluation and screening pursuant to this  
32 section shall be limited to a physical therapist, and any authority for evaluation and screening  
33 granted within this section may not be delegated. Upon each reinitiation of physical therapy  
34 services, a physical therapist shall provide a full physical therapy evaluation prior to the  
35 reinitiation of physical therapy treatment. Physical therapy treatment provided pursuant to the  
36 provisions of subsection 4 of this section may be delegated by physical therapists to physical  
37 therapist assistants only if the patient's current approved health care provider has been so  
38 informed as part of the physical therapist's seven-day notification upon reinitiation of physical

50 **Commission on Accreditation in Physical Therapy** Education (CAPTE) who satisfies

4 by the board. The application shall include, but not be limited to, disclosure of the following:

- 5           (1) The applicant's full name;
- 6           (2) The applicant's office address or addresses and telephone number or numbers;
- 7           (3) The applicant's home address and telephone number;
- 8           (4) The date and number of the applicant's license;
- 9           (5) All final disciplinary actions taken against the applicant by any professional  
10 association or society, licensed hospital or medical staff of a hospital, physical therapy facility,  
11 state, territory, federal agency or [county] **country**; and
- 12           (6) Information concerning the applicant's current physical and mental fitness to practice  
13 his or her profession.

14

15 The applicant may be required to successfully complete a test administered by the board on the  
16 laws and rules related to the practice of physical therapy. The test process, dates, and passing  
17 scores shall be established by the board by rule.

18           2. A notice for application for registration shall be made available to each person  
19 licensed in this state. The failure to receive the notice does not, however, relieve any person of  
20 the duty to register and pay the fee required by sections 334.500 to 334.620 nor exempt such  
21 person from the penalties provided by sections 334.500 to 334.620 for failure to register.

22           3. If a physical therapist does not renew such license for two consecutive renewal  
23 periods, such license shall be deemed void.

24           4. Each applicant for registration shall accompany the application for registration with  
25 a registration fee to be paid to the director of revenue for the licensing period for which  
26 registration is sought.

27           5. If the application is filed and the fee paid after the registration renewal date, a  
28 delinquent fee shall be paid; except that, whenever in the opinion of the board the applicant's  
29 failure to register is caused by extenuating circumstances including illness of the applicant, as  
30 defined by rule, the delinquent fee may be waived by the board.

31           6. Upon application and submission by such person of evidence satisfactory to the board  
32 that such person is licensed to practice in this state and upon the payment of fees required to be  
33 paid by this chapter, the board shall issue to such person a certificate of registration. The  
34 certificate of registration shall contain the name of the person to whom it is issued and his or her  
35 office address, the expiration date, and the number of the license to practice.

36           7. Upon receiving such certificate, every person shall cause the certificate to be readily  
37 available or conspicuously displayed at all times in every practice location maintained by such  
38 person in the state. If the licensee maintains more than one practice location in this state, the  
39 board shall, without additional fee, issue to such licensee duplicate certificates of registration for  
40 each practice location so maintained. If any licensee changes practice locations during the period  
41 for which any certificate of registration has been issued, the licensee shall, within fifteen days  
42 thereafter, notify the board of such change and the board shall issue to the licensee, without  
43 additional fee, a new registration certificate showing the new location.

44           8. Whenever any new license is granted to any physical therapist or physical therapist  
45 assistant under the provisions of this chapter, the board shall, upon application therefor, issue to  
46 such physical therapist or physical therapist assistant a certificate of registration covering a  
47 period from the date of the issuance of the license to the next renewal date without the payment  
48 of any registration fee.

energy requirements;

(f) Meets all applicable safety, performance, interconnection, and reliability standards  
established by the National Electrical Code, the National Electrical Safety Code, the Institute of  
Electrical and Electronics Engineers, Underwriters Laboratories, the Federal Energy Regulatory  
Commission, and any local governing authorities; and

24 (g) Contains a mechanism that automatically disables the unit and interrupts the flow of  
25 electricity back onto the supplier's electricity lines in the event that service to the  
26 customer-generator is interrupted;

27 (4) "Department", the department of [natural resources] **economic development**;

28 (5) "Net metering", using metering equipment sufficient to measure the difference

48 single-hour peak load for the previous calendar year;

49 (2) Offer to the customer-generator a tariff or contract that is identical in electrical  
50 energy rates, rate structure, and monthly charges to the contract or tariff that the customer would  
51 be assigned if the customer were not an eligible customer-generator but shall not charge the  
52 customer-generator any additional standby, capacity, interconnection, or other fee or charge that  
53 would not otherwise be charged if the customer were not an eligible customer-generator; and

54 (3) Disclose annually the availability of the net metering program to each of its  
55 customers with the method and manner of disclosure being at the discretion of the supplier.

56 4. A customer-generator's facility shall be equipped with sufficient metering equipment  
57 that can measure the net amount of electrical energy produced or consumed by the  
58 customer-generator. If the customer-generator's existing meter equipment does not meet these  
59 requirements or if it is necessary for the electric supplier to install additional distribution

60 equipment to accommodate the customer-generator's facility, the customer-generator shall  
61 reimburse the retail electric supplier for the costs to purchase and install the necessary additional  
62 equipment. At the request of the customer-generator, such costs may be initially paid for by the  
63 retail electric supplier, and any amount up to the total costs and a reasonable interest charge may  
64 be recovered from the customer-generator over the course of up to twelve billing cycles. Any  
65 subsequent meter testing, maintenance or meter equipment change necessitated by the  
66 customer-generator shall be paid for by the customer-generator.

67         5. Consistent with the provisions in this section, the net electrical energy measurement  
68 shall be calculated in the following manner:

69         (1) For a customer-generator, a retail electric supplier shall measure the net electrical  
70 energy produced or consumed during the billing period in accordance with normal metering  
71 practices for customers in the same rate class, either by employing a single, bidirectional meter  
72 that measures the amount of electrical energy produced and consumed, or by employing multiple  
73 meters that separately measure the customer-generator's consumption and production of  
74 electricity;

75         (2) If the electricity supplied by the supplier exceeds the electricity generated by the  
76 customer-generator during a billing period, the customer-generator shall be billed for the net  
77 electricity supplied by the supplier in accordance with normal practices for customers in the same  
78 rate class;

79         (3) If the electricity generated by the customer-generator exceeds the electricity supplied  
80 by the supplier during a billing period, the customer-generator shall be billed for the appropriate  
81 customer charges for that billing period in accordance with subsection 3 of this section and shall  
82 be credited an amount at least equal to the avoided fuel cost of the excess kilowatt-hours  
83 generated during the billing period, with this credit applied to the following billing period;

84         (4) Any credits granted by this subsection shall expire without any compensation at the  
85 earlier of either twelve months after their issuance or when the customer-generator disconnects  
86 service or terminates the net metering relationship with the supplier;

87         (5) For any rural electric cooperative under chapter 394, or municipal utility, upon  
88 agreement of the wholesale generator supplying electric energy to the retail electric supplier, at  
89 the option of the retail electric supplier, the credit to the customer-generator may be provided by  
90 the wholesale generator.

91         6. (1) Each qualified electric energy generation unit used by a customer-generator shall  
92 meet all applicable safety, performance, interconnection, and reliability standards established by  
93 any local code authorities, the National Electrical Code, the National Electrical Safety Code, the  
94 Institute of Electrical and Electronics Engineers, and Underwriters Laboratories for distributed  
95 generation. No supplier shall impose any fee, charge, or other requirement not specifically

106 authorized by this section or the rules promulgated under subsection 9 of this section unless the  
107 fee, charge, or other requirement would apply to similarly situated customers who are not  
108 customer-generators, except that a retail electric supplier may require that a customer-generator's  
109 system contain a switch, circuit breaker, fuse, or other easily accessible device or feature located  
110 in immediate proximity to the customer-generator's metering equipment that would allow a  
111 utility worker the ability to manually and instantly disconnect the unit from the utility's electric  
112 distribution system;

113 (2) For systems of ten kilowatts or less, a customer-generator whose system meets the  
114 standards and rules under subdivision (1) of this subsection shall not be required to install  
115 additional controls, perform or pay for additional tests or distribution equipment, or purchase  
116 additional liability insurance beyond what is required under subdivision (1) of this subsection  
117 and subsection 4 of this section;

118 (3) For customer-generator systems of greater than ten kilowatts, the commission for  
119 public utilities and the governing body for other utilities shall, by rule or equivalent formal action  
120 by each respective governing body:

121 (a) Set forth safety, performance, and reliability standards and requirements; and

122 (b) Establish the qualifications for exemption from a requirement to install additional  
123 controls, perform or pay for additional tests or distribution equipment, or purchase additional  
124 liability insurance.

125 7. (1) Applications by a customer-generator for interconnection of a qualified electric  
126 energy generation unit meeting the requirements of subdivision (3) of subsection 2 of this section  
127 to the distribution system shall be accompanied by the plan for the customer-generator's electrical  
128 generating system, including but not limited to a wiring diagram and specifications for the  
129 generating unit, and shall be reviewed and responded to by the retail electric supplier within  
130 thirty days of receipt for systems ten kilowatts or less and within ninety days of receipt for all  
other systems. Prior to the interconnection of the qualified generation unit to the supplier's  
system, the customer-generator will furnish the retail electric supplier a certification from a  
qualified professional electrician or engineer that the installation meets the requirements of  
subdivision (1) of subsection 6 of this section. If the application for interconnection is approved  
by the retail electric supplier and the customer-generator does not complete the interconnection  
within one year after receipt of notice of the approval, the approval shall expire and the  
customer-generator shall be responsible for filing a new application.

(2) Upon the change in ownership of a qualified electric energy generation unit, the new  
customer-generator shall be responsible for filing a new application under subdivision (1) of this  
subsection.

131           8. Each commission-regulated supplier shall submit an annual net metering report to the  
132 commission, and all other nonregulated suppliers shall submit the same report to their respective  
133 governing body and make said report available to a consumer of the supplier upon request,  
134 including the following information for the previous calendar year:

- 135           (1) The total number of customer-generator facilities;
- 136           (2) The total estimated generating capacity of its net-metered customer-generators; and
- 137           (3) The total estimated net kilowatt-hours received from customer-generators.

138           9. The commission shall, within nine months of January 1, 2008, promulgate initial rules  
139 necessary for the administration of this section for public utilities, which shall include  
140 regulations ensuring that simple contracts will be used for interconnection and net metering. For  
141 systems of ten kilowatts or less, the application process shall use an all-in-one document that  
142 includes a simple interconnection request, simple procedures, and a brief set of terms and  
143 conditions. Any rule or portion of a rule, as that term is defined in section 536.010, that is  
144 created under the authority delegated in this section shall become effective only if it complies  
145 with and is subject to all of the provisions of chapter 536 and, if applicable, section 536.028.  
146 This section and chapter 536 are nonseverable and if any of the powers vested with the general  
147 assembly under chapter 536 to review, to delay the effective date, or to disapprove and annul a  
148 rule are subsequently held unconstitutional, then the grant of rulemaking authority and any rule  
149 proposed or adopted after August 28, 2007, shall be invalid and void.

150           10. The governing body of a rural electric cooperative or municipal utility shall, within  
151 nine months of January 1, 2008, adopt policies establishing a simple contract to be used for  
152 interconnection and net metering. For systems of ten kilowatts or less, the application process  
153 shall use an all-in-one document that includes a simple interconnection request, simple  
154 procedures, and a brief set of terms and conditions.

155           11. For any cause of action relating to any damages to property or person caused by the  
156 generation unit of a customer-generator or the interconnection thereof, the retail electric supplier  
157 shall have no liability absent clear and convincing evidence of fault on the part of the supplier.

158           12. The estimated generating capacity of all net metering systems operating under the  
159 provisions of this section shall count towards the respective retail electric supplier's  
160 accomplishment of any renewable energy portfolio target or mandate adopted by the Missouri  
161 general assembly.

162           13. The sale of qualified electric generation units to any customer-generator shall be  
163 subject to the provisions of sections 407.700 to 407.720. The attorney general shall have the  
164 authority to promulgate in accordance with the provisions of chapter 536 rules regarding  
165 mandatory disclosures of information by sellers of qualified electric generation units.

166 Any interested person who believes that the seller of any electric generation unit is  
167 misrepresenting the safety or performance standards of any such systems, or who believes that  
168 any electric generation unit poses a danger to any property or person, may report the same to the  
169 attorney general, who shall be authorized to investigate such claims and take any necessary and  
170 appropriate actions.

171 14. Any costs incurred under this act by a retail electric supplier shall be recoverable in  
172 that utility's rate structure.

173 15. No consumer shall connect or operate an electric generation unit in parallel phase  
174 and synchronization with any retail electric supplier without written approval by said supplier  
175 that all of the requirements under subdivision (1) of subsection 7 of this section have been met.  
176 For a consumer who violates this provision, a supplier may immediately and without notice  
177 disconnect the electric facilities of said consumer and terminate said consumer's electric service.

178 16. The manufacturer of any electric generation unit used by a customer-generator may  
179 be held liable for any damages to property or person caused by a defect in the electric generation  
180 unit of a customer-generator.

181 17. The seller, installer, or manufacturer of any electric generation unit who knowingly  
182 misrepresents the safety aspects of an electric generation unit may be held liable for any damages  
183 to property or person caused by the electric generation unit of a customer-generator.

393.1025. As used in sections 393.1020 to 393.1030, the following terms mean:

2 (1) "Commission", the public service commission;

4 (3) "Electric utility", any electrical corporation as defined by section 386.020;

5 (4) "Renewable energy credit" or "REC", a tradeable certificate of proof that one  
6 megawatt-hour of electricity has been generated from renewable energy sources; and

7 (5) "Renewable energy resources", electric energy produced from wind, solar thermal  
8 sources, photovoltaic cells and panels, dedicated crops grown for energy production, cellulosic  
9 agricultural residues, plant residues, methane from landfills, from agricultural operations, or from  
10 wastewater treatment, thermal depolymerization or pyrolysis for converting waste material to  
11 energy, clean and untreated wood such as pallets, hydropower (not including pumped storage)  
12 that does not require a new diversion or impoundment of water and that has a nameplate rating  
13 of ten megawatts or less, fuel cells using hydrogen produced by one of the above-named  
14 renewable energy sources, and other sources of energy not including nuclear that become  
15 available after November 4, 2008, and are certified as renewable by rule by the department.

16 EXPLANATION: THE DEPARTMENT REFERENCE IN THIS SECTION IS OBSOLETE  
17 BASED ON THE DEPARTMENTAL REORGANIZATION IN EXECUTIVE ORDER 13-03:

393.1030. 1. The commission shall, in consultation with the department, prescribe by  
2 rule a portfolio requirement for all electric utilities to generate or purchase electricity generated  
3 from renewable energy resources. Such portfolio requirement shall provide that electricity from  
4 renewable energy resources shall constitute the following portions of each electric utility's sales:

- 5 (1) No less than two percent for calendar years 2011 through 2013;
- 6 (2) No less than five percent for calendar years 2014 through 2017;
- 7 (3) No less than ten percent for calendar years 2018 through 2020; and
- 8 (4) No less than fifteen percent in each calendar year beginning in 2021. At least two  
9 percent of each portfolio requirement shall be derived from solar energy. The portfolio  
10 requirements shall apply to all power sold to Missouri consumers whether such power is  
11 self-generated or purchased from another source in or outside of this state. A utility may comply  
12 with the standard in whole or in part by purchasing RECs. Each kilowatt-hour of eligible energy  
13 generated in Missouri shall count as 1.25 kilowatt-hours for purposes of compliance.

14 2. The commission, in consultation with the department and within one year of  
15 November 4, 2008, shall select a program for tracking and verifying the trading of renewable  
16 energy credits. An unused credit may exist for up to three years from the date of its creation.  
17 A credit may be used only once to comply with sections 393.1020 to 393.1030 and may not also  
18 be used to satisfy any similar nonfederal requirement. An electric utility may not use a credit  
19 derived from a green pricing program. Certificates from net-metered sources shall initially be  
20 owned by the customer-generator. The commission, except where the department is specified,  
21 shall make whatever rules are necessary to enforce the renewable energy standard. Such rules  
22 shall include:

- 23 (1) A maximum average retail rate increase of one percent determined by estimating and  
24 comparing the electric utility's cost of compliance with least-cost renewable generation and the  
25 cost of continuing to generate or purchase electricity from entirely nonrenewable sources, taking  
26 into proper account future environmental regulatory risk including the risk of greenhouse gas  
27 regulation. Notwithstanding the foregoing, until June 30, 2020, if the maximum average retail  
28 rate increase would be less than or equal to one percent if an electric utility's investment in  
29 solar-related projects initiated, owned or operated by the electric utility is ignored for purposes  
30 of calculating the increase, then additional solar rebates shall be paid and included in rates in an  
31 amount up to the amount that would produce a retail rate increase equal to the difference between  
32 a one percent retail rate increase and the retail rate increase calculated when ignoring an electric  
33 utility's investment in solar-related projects initiated, owned, or operated by the electric utility.  
34 Notwithstanding any provision to the contrary in this section, even if the payment of additional

35 solar rebates will produce a maximum average retail rate increase of greater than one percent  
36 when an electric utility's investment in solar-related projects initiated, owned or operated by the  
37 electric utility are included in the calculation, the additional solar rebate costs shall be included  
38 in the prudently incurred costs to be recovered as contemplated by subdivision (4) of this  
39 subsection;

40 (2) Penalties of at least twice the average market value of renewable energy credits for  
41 the compliance period for failure to meet the targets of subsection 1 of this section. An electric  
42 utility will be excused if it proves to the commission that failure was due to events beyond its  
43 reasonable control that could not have been reasonably mitigated, or that the maximum average  
44 retail rate increase has been reached. Penalties shall not be recovered from customers. Amounts  
45 forfeited under this section shall be remitted to the department to purchase renewable energy  
46 credits needed for compliance. Any excess forfeited revenues shall be used by the [department's  
47 energy center] **division of energy** solely for renewable energy and energy efficiency projects;

48 (3) Provisions for an annual report to be filed by each electric utility in a format  
49 sufficient to document its progress in meeting the targets;

50 (4) Provision for recovery outside the context of a regular rate case of prudently incurred  
51 costs and the pass-through of benefits to customers of any savings achieved by an electrical  
52 corporation in meeting the requirements of this section.

53 3. As provided for in this section, except for those electrical corporations that qualify for  
54 an exemption under section 393.1050, each electric utility shall make available to its retail  
55 customers a solar rebate for new or expanded solar electric systems sited on customers' premises,  
56 up to a maximum of twenty-five kilowatts per system, measured in direct current that were  
57 confirmed by the electric utility to have become operational in compliance with the provisions  
58 of section 386.890. The solar rebates shall be two dollars per watt for systems becoming  
59 operational on or before June 30, 2014; one dollar and fifty cents per watt for systems becoming  
60 operational between July 1, 2014, and June 30, 2015; one dollar per watt for systems becoming  
61 operational between July 1, 2015, and June 30, 2016; fifty cents per watt for systems becoming  
62 operational between July 1, 2016, and June 30, 2017; fifty cents per watt for systems becoming  
63 operational between July 1, 2017, and June 30, 2019; twenty-five cents per watt for systems  
64 becoming operational between July 1, 2019, and June 30, 2020; and zero cents per watt for  
65 systems becoming operational after June 30, 2020. An electric utility may, through its tariffs,  
66 require applications for rebates to be submitted up to one hundred eighty-two days prior to the  
67 June thirtieth operational date. Nothing in this section shall prevent an electrical corporation  
68 from offering rebates after July 1, 2020, through an approved tariff. If the electric utility  
69 determines the maximum average retail rate increase provided for in subdivision (1) of  
70 subsection 2 of this section will be reached in any calendar year, the electric utility shall be

71 entitled to cease paying rebates to the extent necessary to avoid exceeding the maximum average  
72 retail rate increase if the electrical corporation files with the commission to suspend its rebate  
73 tariff for the remainder of that calendar year at least sixty days prior to the change taking effect.  
74 The filing with the commission to suspend the electrical corporation's rebate tariff shall include  
75 the calculation reflecting that the maximum average retail rate increase will be reached and  
76 supporting documentation reflecting that the maximum average retail rate increase will be  
77 reached. The commission shall rule on the suspension filing within sixty days of the date it is  
78 filed. If the commission determines that the maximum average retail rate increase will be  
79 reached, the commission shall approve the tariff suspension. The electric utility shall continue  
80 to process and pay applicable solar rebates until a final commission ruling; however, if the  
81 continued payment causes the electric utility to pay rebates that cause it to exceed the maximum  
82 average retail rate increase, the expenditures shall be considered prudently incurred costs as  
83 contemplated by subdivision (4) of subsection 2 of this section and shall be recoverable as such  
84 by the electric utility. As a condition of receiving a rebate, customers shall transfer to the electric  
85 utility all right, title, and interest in and to the renewable energy credits associated with the new  
86 or expanded solar electric system that qualified the customer for the solar rebate for a period of  
87 ten years from the date the electric utility confirmed that the solar electric system was installed  
88 and operational.

89 4. The department shall, in consultation with the commission, establish by rule a  
90 certification process for electricity generated from renewable resources and used to fulfill the  
91 requirements of subsection 1 of this section. Certification criteria for renewable energy  
92 generation shall be determined by factors that include fuel type, technology, and the  
93 environmental impacts of the generating facility. Renewable energy facilities shall not cause  
94 undue adverse air, water, or land use impacts, including impacts associated with the gathering  
95 of generation feedstocks. If any amount of fossil fuel is used with renewable energy resources,  
96 only the portion of electrical output attributable to renewable energy resources shall be used to

104 implementation of, the provisions of this section. Any rule or portion of a rule, as that term is  
105 defined in section 536.010, that is created under the authority delegated in this section shall  
106 become effective only if it complies with and is subject to all of the provisions of chapter 536

107 and, if applicable, section 536.028. This section and chapter 536 are nonseverable and if any of  
108 the powers vested with the general assembly pursuant to chapter 536 to review, to delay the  
109 effective date, or to disapprove and annul a rule are subsequently held unconstitutional, then the

407.485. 1. It shall be an unfair business practice in violation of section 407.020 for a  
2 for-profit entity or natural person to collect unwanted household items via a public receptacle  
3 and resell the deposited items for profit unless the deposited item receptacle prominently displays  
4 a statement in bold letters at least two inches high and two inches wide stating: "DEPOSITED  
5 ITEMS ARE NOT FOR CHARITABLE ORGANIZATIONS AND WILL BE RESOLD FOR  
6 PROFIT. DEPOSITED ITEMS ARE NOT TAX DEDUCTIBLE."

7 2. It shall be an unfair business practice in violation of section 407.020 for a for-profit  
8 entity or natural person to collect donations of unwanted household items via a public receptacle  
9 and resell the donated items where some or all of the proceeds from the sale are directly given  
10 to a not-for-profit entity unless the donation receptacle prominently displays a statement in bold  
11 letters at least two inches high and two inches wide stating: "DONATIONS TO THE  
12 FOR-PROFIT COMPANY: (name of the company) ARE SOLD FOR PROFIT AND (% of  
13 proceeds donated to the not-for-profit) % OF ALL PROCEEDS ARE DONATED TO (name of  
14 the nonprofit beneficiary organization's name)."

15 3. It shall be an unfair business practice in violation of section 407.020 for a for-profit  
16 entity or natural person to collect donations of unwanted household items via a public receptacle  
17 and resell the donated items, where such for-profit entity is paid a flat fee, not contingent upon  
18 the proceeds generated by the sale of the collected goods, and one hundred percent of the  
19 proceeds from the sale of the items are given directly to the not-for-profit, unless the donation  
20 receptacle prominently displays a statement in bold letters at least two inches high and two  
21 inches wide stating: "THIS DONATION RECEPTACLE IS OPERATED BY THE  
22 FOR-PROFIT ENTITY: (name of the for-profit/individual) ON BEHALF OF (name of the  
23 nonprofit beneficiary organization's name)."

24 4. It shall be an unfair business practice in violation of section 407.020 for a  
25 not-for-profit entity to collect donations of unwanted household items via a public receptacle and  
26 resell the donated items unless the donation receptacle prominently displays a statement in bold  
27 letters at least two inches high and two inches wide stating: "THIS RECEPTACLE IS OWNED  
28 AND OPERATED BY THE NOT-FOR-PROFIT ENTITY: (name of the not-for-profit/charity)  
29 AND (% of proceeds donated to the not-for-profit) % OF THE PROCEEDS FROM THE SALE

30 OF ANY DONATIONS SHALL BE USED FOR THE CHARITABLE MISSION OF (charity  
31 name/charitable cause).".

32 5. The term "bold letters" as used in subsections 1, 2, and 3 of this section shall mean  
33 a primary color on a white background so as to be clearly visible to the public.

34 6. Nothing in this section shall apply to paper, glass, or aluminum products that are  
35 donated for the purpose of being recycled in the manufacture of other products.

36 7. All receptacles described in this section shall conspicuously display the name, address,  
37 and telephone number of the owner and operator of the receptacle. The owner or operator of the  
38 receptacle shall maintain permission to place the receptacle on the property from the property  
39 owner or his or her agent where the receptacle is located. Such permission shall be in writing  
40 and clearly identify the owner of the receptacle and property owner or his or her agent in addition  
41 to the nature of the collections and where proceeds will be accrued. Failure to secure such  
42 permission shall constitute an unfair business practice in addition to any other statutory  
43 conditions. Unless otherwise agreed upon in writing, the property owner or his or her agent may  
44 remove the receptacle. Any charges incurred in such removal shall be the responsibility of the  
45 owner of the receptacle. Unless the receptacle owner pays such charges within thirty calendar  
46 days of the sending of a written certified letter from the property owner stating his or her intent  
47 to remove the receptacle, the receptacle owner shall relinquish any right to the receptacle. If the  
48 receptacle does not conspicuously display the name, address, and telephone number of the owner  
49 and operator of the receptacle, the receptacle shall be considered abandoned property and may  
50 be destroyed or permanently possessed by the property owner or their agent.

51 [8. Any owner and operator of a receptacle that does not display the address of the owner  
52 and operator, but does display the website of the owner and operator, shall make the address  
53 easily accessible on such website for the property owner to send the letter specified in subsection  
54 7 of this section. The provisions of this subsection shall expire on September 1, 2014.]

9 rule is substantially not petroleum and would yield substantial energy security and environmental  
10 benefits, used in a vehicle that complies with the standards and requirements applicable to such  
11 vehicle pursuant to sections 414.400 to 414.417 when using such fuel or power source;

12 (2) "CAFE standard", the federal Corporate Average Fuel Economy standard, 15 U.S.C.  
13 2002 or 40 CFR Parts 86 and 600 or 49 CFR Part 538 or proposed rule 49 CFR Part 538 until  
14 such rule is finalized;

15 (3) "Department", the department of [natural resources] **economic development**;

16 (4) "Director", the director of the department of [natural resources] **economic**  
17 **development**;

18 (5) "State agency", the same meaning as such term is defined in section 536.010;

19 (6) "Vehicle fleet", any fleet comprised of vehicles with a manufacturer's gross vehicle  
20 weight rating of not more than eight thousand five hundred pounds registered for operation on  
21 the highways of this state pursuant to chapter 301.

22 2. The department in consultation with the commissioner of administration shall develop  
23 and implement a program to manage and progressively reduce state agency vehicle fleet fuel  
24 consumption and promote the use of alternative fuels. The program shall require state agencies  
25 to meet minimum guidelines for efficient fleet management. Such guidelines shall be updated  
26 and revised every two years and shall require the overall vehicle fleet fuel efficiency for each  
27 agency to meet or exceed the fuel efficiency that would be achieved if each vehicle in the  
28 agency's fleet met the CAFE standard. The department may promulgate rules necessary to  
29 implement such guidelines. Further, provided that suppliers or state agencies have or can  
30 reasonably be expected to have established alternative fuel refueling stations as needed, the  
31 program shall require that at least thirty percent of all motor fuel purchased annually for use in  
32 alternative fuel vehicles, calculated in gasoline gallon equivalents, to be alternative fuel by July  
33 1, 2001. Any alternative fuel purchased by a state agency for use in vehicles not included in their  
34 vehicle fleet as defined in subsection 1 of this section, calculated in gasoline gallon equivalents,  
35 may be credited toward the annual alternative fuel purchase goal. The program shall  
36 systematically replace existing state-owned vehicles and vehicles paid for with any state money,  
37 including vehicles purchased by the university system, with vehicles manufactured, assembled  
38 or produced in the United States, as required by sections 34.350 to 34.359.

39 3. The commissioner of administration shall identify specific vehicle models within each  
40 vehicle procurement class that meet or exceed the CAFE standard. State agencies shall identify  
41 specific vehicle models within each vehicle procurement class that have a life cycle cost which  
42 is less than or equal to the average life cycle cost of those vehicles in the class which are  
43 manufactured, assembled or produced in the United States. Life cycle costs shall include but are

44 not limited to the original cost of the vehicle, conversion cost if applicable, costs associated with  
45 vehicle emissions to the extent that such statistics are available, and projected cost of operation,  
46 including fuel cost and maintenance and salvage value to the extent that reliable maintenance and  
47 salvage value statistics are available. Unless a state agency submits to the department a fleet  
48 efficiency plan that complies with the minimum guidelines for energy efficiency established  
49 pursuant to subsection 2 of this section, or unless otherwise approved by the office of  
50 administration pursuant to subsection 4 of this section, all purchases of vehicles for state agency  
51 vehicle fleets shall meet the above standards.

52 4. The commissioner of administration may waive the CAFE standard requirements of  
53 subsection 3 of this section, for only those vehicles which satisfy one or more of the following  
54 conditions, for any state agency upon receipt of documentation that has been certified by the  
55 director of the state agency as satisfying one or more of the following conditions:

56 (1) Such vehicles are used primarily in off-road, construction, or road maintenance  
57 applications;

58 (2) Such vehicles are regularly used in the movement of maintenance or construction  
59 equipment;

60 (3) Such vehicles are trucks or utility vehicles as defined by the office of administration  
61 that are regularly used to transport trailers for the purpose of moving state equipment; or

62 (4) Such vehicles are vehicles with manufacturer-stated seating capacity exceeding that  
63 for six persons and the director of the agency has certified that the vehicle will be used to  
64 transport its rated capacity in persons and/or cargo. Agencies which are granted such waivers  
65 shall comply with the planning requirements of section 414.403.

66 5. The purchase of all class III vehicles, as defined by the office of administration, shall  
67 be approved through the appropriations process for all departments except the highway patrol.  
68 The provisions of this subsection shall not apply to the purchase of used vehicles from the  
69 highway patrol.

24 by Section 107 of the federal Clean Air Act, as amended, or in an area designated as a

25 maintenance area for ozone under Section 175A of the federal Clean Air Act, as amended,  
26 state-owned vehicles shall not be required to use a fuel ethanol blend.

16 appointed by the governor shall be subject to the advice and consent of the senate. Consistent  
17 with the requirements of the [WIA] **WIOA**, the governor shall designate one member of the  
18 board to be its chairperson.

19 5. [Except as otherwise provided in subsection 6 of this section,] Each member of the

35 (5) "Taxpayer", any individual, partnership, or corporation as described  
36 in section 143.441, 143.471, or section 148.370 that is subject to the tax imposed  
37 in chapter 143, excluding withholding tax imposed by sections 143.191 to

42 2. For all taxable years beginning on or after January 1, 1999, but ending  
43 on or before December 31, 2007, a taxpayer shall be granted a tax credit for up

46 budget in excess of three hundred thousand dollars. For all taxable years

For all taxable years ending on or before December 31, 2007, tax credits certified pursuant to subsection 2 of this section shall not exceed one million dollars per taxpayer per year, and shall not exceed a total for all tax credits certified of one million five hundred thousand dollars per year. For all taxable years beginning on or after January 1, 2008, tax credits certified under subsection 1 of this section shall not exceed a total for all tax credits certified of four million five hundred thousand dollars per year. Taxpayers may carry forward unused credits for up to five tax periods, provided all such credits shall be claimed within ten tax periods following the tax period in which the film production or production-related activities for which the credits are certified by the department occurred.

5. Notwithstanding any provision of law to the contrary, any taxpayer may sell, assign, exchange, convey or otherwise transfer tax credits allowed in subsection 2 of this section. The taxpayer acquiring the tax credits may use the acquired credits to offset the tax liabilities otherwise imposed by chapter 143, excluding withholding tax imposed by sections 143.191 to 143.265, or chapter 148. Unused acquired credits may be carried forward for up to five tax periods, provided all such credits shall be claimed within ten tax periods following the tax period in which the film production or production-related activities for which the credits are certified by the department occurred.

[135.903. 1. To qualify as a rural empowerment zone, an area shall meet all the following criteria:

(1) The area is one of pervasive poverty, unemployment, and general distress;

(2) At least sixty-five percent of the population has earned income below eighty percent of the median income of all residents within the state according to the United States Census Bureau's American Community Survey, based on the most recent of five-year period estimate data in which the final year of the estimate ends in either zero or five or other appropriate source as approved by the director;

(3) The population of the area is at least four hundred but not more than three thousand five hundred at the time of designation as a rural empowerment zone;

(4) The level of unemployment of persons, according to the most recent data available from the division of employment security or from the United States Bureau of Census and approved by the director, within the area exceeds one and one-half times the average rate of unemployment for the state of Missouri over the previous twelve months, or the percentage of area residents employed on a full-time basis is less than fifty percent of the statewide percentage of residents employed on a full-time basis;

(5) The area is situated more than ten miles from any existing rural empowerment zone;

(6) The area is situated in a county of the third classification without a township form of government and with more than eight thousand nine hundred twenty-five but less than nine thousand twenty-five inhabitants; and

(7) The area is not situated in an existing enterprise zone.

2. The governing body of any county in which an area may be designated a rural empowerment zone shall submit to the department an application showing that the area complies with the requirements of subsection 1 of this section. The department shall declare the area a rural empowerment zone if upon investigation the department finds that the area meets the requirements of subsection 1 of this section. If the area is found not to meet the requirements, the governing body shall have the opportunity to submit another application for designation as a rural empowerment zone and the department shall designate the area a rural empowerment zone if upon investigation the department finds that the area meets the requirements of subsection 1 of this section.

3. There shall be no more than two rural empowerment zones as created under sections 135.900 to 135.906 in existence at any time.]

(7) "Income", federal adjusted gross income, and in the case of ownership of the homestead by trust, the income of the settlor applicant shall be imputed to the income of the trust for purposes of determining eligibility with regards to the maximum upper limit;

(8) "Maximum upper limit", in the calendar year 2005, the income sum of seventy thousand dollars; in each successive calendar year this amount shall be raised by the incremental increase in the general price level, as defined pursuant to article X, section 17 of the Missouri Constitution.

3. Pursuant to article X, section 6(a) of the Constitution of Missouri, if in the prior tax year, the property tax liability on any parcel of subclass (1) real property increased by more than the homestead exemption limit, without regard for any prior credit received due to the provisions of this section, then any eligible owner of the property shall receive a homestead exemption credit to be applied in the current tax year property tax liability to offset the prior year increase to tax liability that exceeds the homestead exemption limit, except as eligibility for the credit is limited by the provisions of this section. The amount of the credit shall be listed separately on each taxpayer's tax bill for the current tax year, or on a document enclosed with the taxpayer's bill. The homestead exemption credit shall not affect the process of setting the tax rate as required pursuant to article X, section 22 of the Constitution of Missouri and section 137.073 in any prior, current, or subsequent tax year.

4. If application is made in 2005, any potential eligible owner may apply for the homestead exemption credit by completing an application through their local assessor's office. The application shall be on forms provided to the assessor's office by the department. Forms also shall be made available on the department's internet site and at all permanent branch offices and all full-time, temporary, or fee offices maintained by the department of revenue. The applicant shall attest under penalty of perjury:

(1) To the applicant's age;

(2) That the applicant's prior year income was less than the maximum upper limit;

(3) To the address of the homestead property; and

(4) That any improvements made to the homestead, not made to accommodate a disabled person, did not total more than five percent of the prior

year appraised value. The applicant shall also include with the application copies of receipts indicating payment of property tax by the applicant for the homestead property for the two prior tax years.

5. If application is made in 2005, the assessor, upon request for an application, shall:

(1) Certify the parcel number and owner of record as of January first of the homestead, including verification of the acreage classified as residential on the assessor's property record card;

(2) Obtain appropriate prior tax year levy codes for each homestead from the county clerks for inclusion on the form;

(3) Record on the application the assessed valuation of the homestead for the current tax year, and any new construction or improvements for the current tax year; and

(4) Sign the application, certifying the accuracy of the assessor's entries.

6. If application is made after 2005, any potential eligible owner may apply for the homestead exemption credit by completing an application. Applications may be completed between April first and October fifteenth of any tax year in order for the taxpayer to be eligible for the homestead exemption credit in the tax year next following the calendar year in which the homestead exemption credit application was completed. The application shall be on forms provided by the department. Forms also shall be made available on the department's internet site and at all permanent branch offices and all full-time, temporary, or fee offices maintained by the department of revenue. The applicant shall attest under penalty of perjury:

(1) To the applicant's age;

(2) That the applicant's prior year income was less than the maximum upper limit;

(3) To the address of the homestead property;

(4) That any improvements made to the homestead, not made to accommodate a disabled person, did not total more than five percent of the prior year appraised value; and

(5) The applicant shall also include with the application copies of receipts indicating payment of property tax by the applicant for the homestead property for the three prior tax years.

7. Each applicant shall send the application to the department by October fifteenth of each year for the taxpayer to be eligible for the homestead exemption credit in the tax year next following the calendar year in which the application was completed.

8. If application is made in 2005, upon receipt of the applications, the department shall calculate the tax liability, adjusted to exclude new construction or improvements verify compliance with the maximum income limit, verify the age of the applicants, and make adjustments to these numbers as necessary on the applications. The department also shall disallow any application where the

applicant has also filed a valid application for the senior citizens property tax credit, pursuant to sections 135.010 to 135.035. Once adjusted tax liability, age, and income are verified, the director shall determine eligibility for the credit, and provide a list of all verified eligible owners to the county collectors or county clerks in counties with a township form of government by December fifteenth of each year. By January fifteenth, the county collectors or county clerks in counties with a township form of government shall provide a list to the department of any verified eligible owners who failed to pay the property tax due for the tax year that ended immediately prior. Such eligible owners shall be disqualified from receiving the credit in the current tax year.

9. If application is made after 2005, upon receipt of the applications, the department shall calculate the tax liability, verify compliance with the maximum income limit, verify the age of the applicants, and make adjustments to these numbers as necessary on the applications. The department also shall disallow any application where the applicant also has filed a valid application for the senior citizens property tax credit under sections 135.010 to 135.035. Once adjusted tax liability, age, and income are verified, the director shall determine eligibility for the credit and provide a list of all verified eligible owners to the county assessors or county clerks in counties with a township form of government by December fifteenth of each year. By January fifteenth, the county assessors shall provide a list to the department of any verified eligible owners who made improvements not for accommodation of a disability to the homestead and the dollar amount of the assessed value of such improvements. If the dollar amount of the assessed value of such improvements totaled more than five percent of the prior year appraised value, such eligible owners shall be disqualified from receiving the credit in the current tax year.

10. The director shall calculate the level of appropriation necessary to set the homestead exemption limit at five percent when based on a year of general reassessment or at two and one-half percent when based on a year without general reassessment for the homesteads of all verified eligible owners, and provide such calculation to the speaker of the house of representatives, the president pro tempore of the senate, and the director of the office of budget and planning in the office of administration by January thirty-first of each year.

11. For applications made in 2005, the general assembly shall make an appropriation for the funding of the homestead exemption credit that is signed by the governor, then the director shall, by July thirty-first of such year, set the homestead exemption limit. The limit shall be a single, statewide percentage increase to tax liability, rounded to the nearest hundredth of a percent, which, if applied to all homesteads of verified eligible owners who applied for the homestead exemption credit in the immediately prior tax year, would cause all but one-quarter of one percent of the amount of the appropriation, minus any withholding by the governor, to be distributed during that fiscal year. The remaining one-quarter of one percent shall be distributed to the county

assessment funds of each county on a proportional basis, based on the number of eligible owners in each county; such one-quarter percent distribution shall be delineated in any such appropriation as a separate line item in the total appropriation. If no appropriation is made by the general assembly during any tax year or no funds are actually distributed pursuant to any appropriation therefor, then no homestead preservation credit shall apply in such year.

12. After setting the homestead exemption limit for applications made in 2005, the director shall apply the limit to the homestead of each verified eligible owner and calculate the credit to be associated with each verified eligible owner's homestead, if any. The director shall send a list of those eligible owners who are to receive the homestead exemption credit, including the amount of each credit, the certified parcel number of the homestead, and the address of the homestead property, to the county collectors or county clerks in counties with a township form of government by August thirty-first. Pursuant to such calculation, the director shall instruct the state treasurer as to how to distribute the appropriation and assessment fund allocation to the county collector's funds of each county or the treasurer ex officio collector's fund in counties with a township form of government where recipients of the homestead exemption credit are located, so as to exactly offset each homestead exemption credit being issued, plus the one-quarter of one percent distribution for the county assessment funds. As a result of the appropriation, in no case shall a political subdivision receive more money than it would have received absent the provisions of this section plus the one-quarter of one percent distribution for the county assessment funds. Funds, at the direction of the county collector or the treasurer ex officio collector in counties with a township form of government, shall be deposited in the county collector's fund of a county or the treasurer ex officio collector's fund or may be sent by mail to the collector of a county, or the treasurer ex officio collector in counties with a township form of government, not later than October first in any year a homestead exemption credit is appropriated as a result of this section and shall be distributed as moneys in such funds are commonly distributed from other property tax revenues by the collector of the county or the treasurer ex officio collector of the county in counties with a township form of government, so as to exactly offset each homestead exemption credit being issued. (1) Any new program authorized under the provisions of this section shall automatically sunset six years after the effective date of this section; and

(2) This section shall terminate on September first of the year following the year in which any new program authorized under this section is sunset, and the revisor of statutes shall designate such sections and this section in a revision bill for repeal.]

[143.105. Notwithstanding the provisions of section 143.071, to the contrary, a tax is hereby imposed upon the Missouri taxable income of corporations in an amount equal to five percent of Missouri taxable income.]

[143.106. 1. Notwithstanding the provisions of section 143.171, to the contrary, a taxpayer shall be allowed a deduction for his federal income tax liability under chapter 1 of the Internal Revenue Code for the same taxable year for which the Missouri return is being filed after reduction for all credits thereon, except the credit for payments of federal estimated tax, the credit for the overpayment of any federal tax, and the credits allowed by the Internal Revenue Code by section 31 (tax withheld on wages), section 27 (tax of foreign country and United States possessions), and section 34 (tax on certain uses of gasoline, special fuels, and lubricating oils).

2. If a federal income tax liability for a tax year prior to the applicability of sections 143.011 to 143.996 for which he was not previously entitled to a Missouri deduction is later paid or accrued, he may deduct the federal tax in the later year to the extent it would have been deductible if paid or accrued in the prior year.]

[160.459. 1. There is hereby established the "Rebuild Missouri Schools Program" under which the state board of education shall distribute no-interest funding to eligible school districts from moneys appropriated by the general assembly to the rebuild Missouri schools program fund for the purposes of this section to assist in paying the costs of emergency projects.

2. As used in this section, the following terms mean:

(1) "Eligible school district", any public school district that has one or more school facilities that have experienced severe damage or destruction due to an act of God or extreme weather events, including but not limited to tornado, flood, or hail;

(2) "Emergency project", reconstruction, replacement or renovation of, or repair to, any school facilities located in an area that has been declared a disaster area by the governor or President of the United States because of severe damage;

(3) "Fund", the rebuild Missouri schools fund created by this section and funded by appropriations of the general assembly;

(4) "Severe damage", such level of damage as to render all or a substantial portion of a facility within a school district unusable for the purpose for which it was being used immediately prior to the event that caused the damage.

3. Under rules and procedures established by the state board of education, eligible school districts may receive moneys from the fund to pay for the costs of one or more emergency projects.

24               4. Each eligible school district applying for such funding shall enter into  
25 an agreement with the state board of education which shall provide for all of the  
26 following:

27               (1) The funding shall be used only to pay the costs of an emergency  
28 project;

29               (2) The eligible school district shall pay no interest for the funding;

13 education institution and attains a teaching certificate and either a bachelors or

17 to engage in qualified employment upon graduation from a higher education  
18 institution for five years; and

19           (e) Upon graduation from the higher education institution, engages in

21           (3) "Qualified employment", employment as a teacher in a school located  
22 in a school district that is not classified as accredited by the state board of  
23 education at the time the eligible applicant signs their first contract to teach in  
24 such district. Preference in choosing schools to receive participating teachers  
25 shall be given to schools in such school districts with a  
26 higher-than-the-state-average of students eligible to receive a reduced lunch price

64       stipend under this subsection shall not exceed the actual cost of tuition, required  
65       fees, and room and board for the eligible applicant at the institution of higher

67           5. The department shall maintain a Missouri teaching fellows program  
68       coordinator position, the main responsibility of which shall be the identification,  
69       recruitment, and selection of potential students meeting the requirements of

102 in any fiscal year. The maximum of one million dollars in any fiscal year shall  
103 be adjusted annually by the same percentage as the increase in the general price  
104 level as measured by the Consumer Price Index for All Urban Consumers for the  
105 United States, or its successor index, as defined and officially recorded by the  
106 United States Department of Labor or its successor agency.]  
107

[168.702. Pursuant to section 23.253 of the Missouri sunset act:

2 (1) Any new program authorized under section 168.700 shall  
3 automatically sunset six years after August 28, 2007, unless reauthorized by an  
4 act of the general assembly; and

(2) If such program is reauthorized, the program authorized under section 168.700 shall automatically sunset twelve years after the effective date of the reauthorization of this act; and

(3) Section 168.700 shall terminate on September first of the calendar year immediately following the calendar year in which a program authorized under section 168.700 is sunset.]

EXPLANATION: SECTIONS 170.055 TO 170.161 CONTAIN OBSOLETE TEXTBOOK LANGUAGE:

[170.055. No school board shall pay a higher price for books than is paid by any other school district in this state, or in any other state purchasing textbooks in the open market. No contract for books for a period of more than five years shall be made by any school district under the provisions of this law. Any owner, agent, solicitor or publisher of textbooks who shall offer for sale in this state or sell to any board of directors or board of education textbooks at a higher price than herein specified shall be guilty of a misdemeanor and shall upon conviction thereof be punished by a fine of not less than five hundred dollars and not more than ten thousand dollars for each offense.]

[170.061. Before the publisher of any school textbook offers the same for sale to any school board in the state of Missouri, he shall file a copy of the textbook in the office of the state board of education with a sworn statement of the list price and the lowest net price at which the book is sold anywhere in the United States under like conditions of distribution. The publisher shall file with the state board of education a written agreement to furnish the book or books to any school board in Missouri at the price so filed. The publisher must further agree to reduce the prices in Missouri if reductions are made elsewhere in the country, so that at no time may any book be sold in Missouri at a higher price than is received for the same book elsewhere in the country where like methods of distribution prevail. The publisher shall further agree that all books offered for sale in Missouri shall be equal in quality to those deposited in the office of the state board of education as to paper, binding, print, illustration and all points that may affect the value of the books.]

[170.071. Before the publisher of any school textbook offers it for sale to any school board in the state of Missouri, and at the time of the filing of the textbook in the office of the state board of education, the publisher shall pay into the treasury of the state of Missouri a filing fee of ten dollars for each book offered by the publisher. A series of books by the same author and upon the same subject constitute one book for this purpose. The fees received constitute a fund out of which, upon requisition made by the state board of education, shall be paid the expenses of publishing lists and other information for the use of

9 school boards, clerk hire and the other necessary expenses in connection with the  
10 filing of all textbooks submitted for adoption in the state of Missouri.]  
11

2 [170.081. To insure compliance with the conditions under which school  
3 textbooks may be sold in the state of Missouri, the publisher shall file with the  
4 state board of education a bond of not less than two thousand dollars nor more  
5 than ten thousand dollars, to be approved by the state board and the amount to be  
6 fixed by it; upon compliance with this and sections 170.071, 170.131 and  
7 170.141, the publisher shall thereupon be licensed to sell school books in this  
8 state.]

2 [170.091. The state board of education shall furnish annually each school  
3 district with a list of publishers who have conformed to the law relating to sample  
4 books, prices and bond.]

2 [170.101. If in any case the publisher furnishes books inferior in any  
3 particular to the sample on file with the state board of education, or requires  
4 higher prices than those listed with the board, then the school board shall inform  
5 the state board of education of the failure of the publisher to comply with the  
6 terms of his contract. The state board of education shall thereupon notify the  
7 publisher of the complaint, and, if the publisher disregards the notification and  
8 fails to comply immediately with the terms of his contract, then the state board  
9 of education shall institute legal proceedings for the forfeiture of the bond of the  
10 publisher.]

2 [170.111. Before seeking to enter into contract with any school board, the  
3 publisher shall furnish the clerk of the school board with a duplicate printed list  
4 of the books and prices filed with the state board of education.]

2 [170.131. When any publisher of school textbooks files with the state  
3 board of education the samples and lists provided for in section 170.061, the  
4 publisher at the same time shall file a sworn statement that he has no  
5 understanding or agreement of any kind with any other publisher, or interest in  
6 the business of any other publisher, with the effect, design or intent to control the  
7 prices on books or to restrict competition in the adoption or sale thereof.]

2 [170.141. Before being licensed to sell school textbooks in this state, the  
3 publisher thereof shall file with the state board of education a sworn statement,  
4 showing the ownership of the publishing house, with the interest, names and  
5 addresses of the owners, and specifically stating whether or not the publisher, or  
6 the owner of any interest or shares in the publishing house, is the owner of any  
7 interest or shares in any other publishing house, and if so, giving the name and  
address thereof.]

2 [170.151. If at any time any publisher enters into any understanding,  
3 agreement or combination to control the prices or to restrict competition in the  
4 adoption or sale of school books, or if the statements required of the publisher by  
5 sections 170.131 and 170.141 are untrue in any respect, then the attorney general  
6 shall institute and prosecute legal proceedings for the forfeiture of the bond of the  
7 publisher and for the revocation of his authority to sell school books in this state,  
8 and all contracts made by the publisher under this law shall thereupon become  
9 null and void at the option of the other parties thereto.]

2 [170.161. Any publisher who sells, or offers for sale or adoption in this  
3 state, school textbooks of any kind without first obtaining licenses therefor under  
4 this law is guilty of a misdemeanor and upon conviction shall be fined not less  
5 than five hundred dollars and not more than five thousand dollars.]

6 EXPLANATION: THIS SECTION IS OBSOLETE DUE TO THE REPEAL OF SECTIONS  
7 173.198 AND 173.199 IN 2012:

2 [173.197. Sections 173.197 to 173.199 shall be known and may be cited  
3 as the "Higher Education Scholarship Program". The general assembly hereby  
4 finds and declares that Missouri citizens should be encouraged to pursue  
5 academic disciplines necessary for the future economic well-being of this state  
6 to maintain competitiveness in a global economy; therefore, the purpose of  
7 sections 173.197 to 173.199 is to increase the number of students pursuing and  
8 receiving undergraduate degrees in mathematics, science, and foreign languages,  
9 and to increase the number of students pursuing and receiving graduate degrees  
10 in mathematics, science, engineering and foreign languages, by offering  
11 scholarships and fellowships as incentives to pursue such disciplines.]

12 EXPLANATION: SECTIONS 205.580 TO 208.760 ARE OBSOLETE; THERE ARE NO  
13 POOR FARMS IN MISSOURI:

2 [205.580. Poor persons shall be relieved, maintained and supported by  
3 the county of which they are inhabitants.]

2 [205.590. Aged, infirm, lame, blind or sick persons, who are unable to  
3 support themselves, and when there are no other persons required by law and able  
4 to maintain them, shall be deemed poor persons.]

2 [205.600. No person shall be deemed an inhabitant within the meaning  
3 of sections 205.580 to 205.760, who has not resided in the county for the space  
4 of twelve months next preceding the time of any order being made respecting  
5 such poor person, or who shall have removed from another county for the  
6 purpose of imposing the burden of keeping such poor person on the county where  
7 he or she last resided for the time aforesaid.]

2 [205.610. The county commission of each county, on the knowledge of  
3 the judges of such tribunal, or any of them, or on the information of any associate  
4 circuit judge of the county in which any person entitled to the benefit of the  
5 provisions of sections 205.580 to 205.760 resides, shall from time to time, and  
6 as often and for as long a time as may be necessary, provide, at the expense of the  
7 county, for the relief, maintenance and support of such persons.]

2 [205.620. The county commission shall at all times use its discretion and  
3 grant relief to all persons, without regard to residence, who may require its  
4 assistance.]

2 [205.630. The county commission of the proper county shall allow such  
3 sum as it shall think reasonable, for the funeral expenses of any person who shall  
4 die within the county without means to pay such funeral expenses.]

2 [205.640. The several county commissions shall have power, whenever  
3 they may think it expedient, to purchase or lease, or may purchase and lease, any  
4 quantity of land in their respective counties, not exceeding three hundred and  
5 twenty acres, and receive a conveyance to their county for the same.]

2 [205.650. Such county commission may cause to be erected on the land  
3 so purchased or leased a convenient poorhouse or houses, and cause other  
4 necessary labor to be done, and repairs and improvements made, and may  
5 appropriate from the revenues of their respective counties such sums as will be  
6 sufficient to pay the purchase money in one or more payments to improve the  
7 same, and to defray the necessary expenses.]

2 [205.660. The county commission shall have power to make all necessary  
3 and proper orders and rules for the support and government of the poor kept at  
4 such poorhouse, and for supplying them with the necessary raw materials to be  
5 converted by their labor into articles of use, and for the disposing of the products  
6 of such labor and applying the proceeds thereof to the support of the institution.]  
7

2 [205.670. The several county commissions shall set apart from the  
3 revenues of the counties such sums for the annual support of the poor as shall  
4 seem reasonable, which sums the county treasurers shall keep separate from other  
5 funds, and pay the same out on the warrants of their county commissions.]

2 [205.680. Any county which now has or may hereafter have within such  
3 county a city having a special charter and which city now has or may hereafter  
4 have a population of not less than ten thousand inhabitants and not more than  
5 thirty thousand inhabitants shall, out of the funds of such county, provide for the

5 care of the poor in said county, including poor of such city or cities, and no such  
6 city shall hereafter be exempt from any tax for the support of the poor of such  
7 county. No money shall hereafter be refunded to any such city by any such  
8 county on account of any money expended by said county for the support of the  
9 poor of said county.]

10

2 [205.690. Whenever such poorhouse or houses are erected, the county  
3 commission shall have power to appoint a fit and discreet person to superintend  
4 the same and the poor who may be kept thereat, and to allow such superintendent  
5 a reasonable compensation for his services.]

5

2 [205.700. Such superintendent shall have power to cause persons kept at  
3 such poorhouse, who are able to do useful labor, to perform the same by  
4 reasonable and humane coercion.]

4

2 [205.710. The county commission may at any time, for good cause,  
3 remove the superintendent and appoint another to fill the vacancy.]

3

2 [205.720. It shall be the duty of the superintendent of the poor, or poor  
3 farm, as provided for in sections 205.580 to 205.760, to keep a book furnished  
4 by the county commission, and enter therein a book account of all business  
5 transactions had or done or caused to be done by him as superintendent. Said  
6 book shall show an itemized account of all farm products, stock and other articles  
7 sold by the superintendent or by his authority, and of all articles purchased for the  
8 use of the poor, or for the use or improvement of the poor farm or the buildings  
9 thereon, and of all expenses for farm labor and other work or services done by  
10 order or contract of the superintendent, and of such other items as may be ordered  
11 kept therein by the county commission.]

11

2 [205.730. It shall be the duty of the superintendent to appear before the  
3 county commission on the first day of every regular session thereof, and at such  
4 other times as the commission may require, and present said book to said  
5 commission for their inspection. Should the superintendent fail or refuse to keep  
6 such book and present the same to the county commission, as provided in  
7 sections 205.580 to 205.760, it shall be considered sufficient cause for his  
8 removal, and it shall be the duty of the county commission to remove the same,  
9 and appoint another to fill the vacancy.]

9

2 [205.740. All money that shall come into the hands of the superintendent  
3 from the sale of farm products, stock or other articles belonging to the county,  
4 and all other money belonging to the county that shall come into his hands from  
5 other sources, except by warrants drawn in his favor by the county commission,

4

5 shall be paid into the county treasury and placed with the fund for the support of  
6 the poor, and a receipt taken for the same.]  
7

2 [205.750. Every superintendent, before entering upon his duties, shall  
3 enter into a bond to the state of Missouri in a sum not less than five hundred nor  
4 more than three thousand dollars, to be determined by the county commission,  
5 conditioned that he will faithfully account for all money belonging to the county  
6 that shall come into his hands, and that he will exercise due diligence and care  
7 over property belonging to the county, under his control. Said bond shall be  
8 approved by the county commission and filed with the clerk thereof.]

2 [205.760. Sections 205.720 to 205.750 shall not apply to any county  
3 where the support and keeping of the poor is let out by contract, nor to any county  
4 where the superintendent rents or leases the poor farm and stocks the same and  
5 furnishes the necessary farm implements used thereon at his own expense, and  
6 carries on said farm at his own expense.]  
7

7 EXPLANATION: THIS SECTION SUNSET 08-28-13:

2 [208.178. 1. On or after July 1, 1995, the department of social services  
3 may make available for purchase a policy of health insurance coverage through  
4 the Medicaid program. Premiums for such a policy shall be charged based upon  
5 actuarially sound principles to pay the full cost of insuring persons under the  
6 provisions of this section. The full cost shall include both administrative costs  
7 and payments for services. Coverage under a policy or policies made available  
8 for purchase by the department of social services shall include coverage of all or  
9 some of the services listed in section 208.152 as determined by the director of the  
10 department of social services. Such a policy may be sold to a person who is  
11 otherwise uninsured and who is:

12 (1) A surviving spouse eligible for coverage under sections 376.891 to  
13 376.894, who is determined under rules and regulations of the department of  
14 social services to be unable to afford continuation of coverage under that section;

15 (2) An adult over twenty-one years of age who is not pregnant and who  
16 resides in a household with an income which does not exceed one hundred  
17 eighty-five percent of the federal poverty level for the applicable family size. Net  
18 taxable income shall be used to determine that portion of income of a  
19 self-employed person; or

20 (3) A dependent of an insured person who resides in a household with an  
21 income which does not exceed one hundred eighty-five percent of the federal  
22 poverty level for the applicable family size.

23 2. Any policy of health insurance sold pursuant to the provisions of this  
24 section shall conform to requirements governing group health insurance under  
chapters 375, 376, and 379.

25           3. The department of social services shall establish policies governing the  
26 issuance of health insurance policies pursuant to the provisions of this section by  
27 rules and regulations developed in consultation with the department of insurance,  
28 financial institutions and professional registration.

29           4. Under section 23.253 of the Missouri sunset act:

30           (1) The provisions of the program authorized under this section shall  
31 automatically sunset one year after August 28, 2012, unless reauthorized by an  
32 act of the general assembly; and

33           (2) If such program is reauthorized, the program authorized under this  
34 section shall automatically sunset one year after the effective date of the  
35 reauthorization of this section; and

36           (3) This section shall terminate on September first of the calendar year  
37 immediately following the calendar year in which the program authorized under  
38 this section is sunset.]

39  
40 EXPLANATION: SECTION 208.275 CREATING THE COORDINATING COUNCIL ON  
41 SPECIAL TRANSPORTATION WAS REPEALED IN 2014:

          [208.630. The coordinating council on special transportation created in  
2 section 208.275 shall, in cooperation with the department of social services,  
3 coordinate existing transportation reports for Missouri's elderly and persons with  
4 disabilities. Such reports shall be compiled as one comprehensive plan to meet  
5 the special transportation needs of the elderly and persons with disabilities. The  
6 plan shall contain a strategy for implementation and recommendations for  
7 funding. The plan shall be delivered to the governor, the president pro tem of the  
8 senate, and the speaker of the house of representatives by September 1, 1995.]

9  
10 EXPLANATION: THE FUND IN THIS SECTION IS OBSOLETE AND CONTAINS NO  
11 BALANCE:

          [208.975. 1. There is hereby created in the state treasury the "Health  
2 Care Technology Fund" which shall consist of all gifts, donations, transfers, and  
3 moneys appropriated by the general assembly, and bequests to the fund. The  
4 state treasurer shall be custodian of the fund and may approve disbursements  
5 from the fund in accordance with sections 30.170 and 30.180. The fund shall be  
6 administered by the department of social services in accordance with the  
7 recommendations of the MO HealthNet oversight committee unless otherwise  
8 specified by the general assembly. Moneys in the fund shall be distributed in  
9 accordance with specific appropriation by the general assembly. The director of  
10 the department of social services shall submit his or her recommendations for the  
11 disbursement of the funds to the governor and the general assembly.

18 intended to improve the safety, quality, and costs of health care services in the  
19 state, including but not limited to the following:

- 20 (1) Electronic medical records;
- 21 (2) Community health records;
- 22 (3) Personal health records;
- 23 (4) E-prescribing;
- 24 (5) Telemedicine;
- 25 (6) Telemonitoring; and
- 26 (7) Electronic access for participants and providers to obtain MO  
27 HealthNet service authorizations.

28 3. Prior to any moneys being appropriated or expended from the health  
29 care technology fund for the programs or improvements listed in subsection 2 of  
30 this section, there shall be competitive requests for proposals consistent with state  
31 procurement policies of chapter 34. After such process is completed, the  
32 provisions of subsection 1 of this section relating to the administration of fund  
33 moneys shall be effective.

34 4. For purposes of this section, "elected public official or any state  
35 employee" means a person who holds an elected public office in a municipality,  
36 a county government, a state government, or the federal government, or any state  
37 employee, and the spouse of either such person, and any relative within one  
38 degree of consanguinity or affinity of either such person.

39 5. Any amounts appropriated or expended from the health care  
40 technology fund in violation of this section shall be remitted by the payee to the  
41 fund with interest paid at the rate of one percent per month. The attorney general  
42 is authorized to take all necessary action to enforce the provisions of this section,  
43 including but not limited to obtaining an order for injunction from a court of  
44 competent jurisdiction to stop payments from being made from the fund in  
45 violation of this section.

46 6. Any business or corporation which receives moneys expended from  
47 the health care technology fund in excess of five hundred thousand dollars in  
48 exchange for products or services and, during a period of two years following  
49 receipt of such funds, employs or contracts with any current or former elected  
50 public official or any state employee who had any direct decision-making or  
51 administrative authority over the awarding of health care technology fund  
52 contracts or the disbursement of moneys from the fund shall be subject to the  
53 provisions contained within subsection 5 of this section. Employment of or  
54 contracts with any current or former elected public official or any state employee  
55 which commenced prior to May 1, 2007, shall be exempt from these provisions.

56 7. Any moneys remaining in the fund at the end of the biennium shall  
57 revert to the credit of the general revenue fund, except for moneys that were gifts,  
58 donations, or bequests.

59           8. The state treasurer shall invest moneys in the fund in the same manner  
60 as other funds are invested. Any interest and moneys earned on such investments  
61 shall be credited to the fund.

62           9. The MO HealthNet division shall promulgate rules setting forth the  
63 procedures and methods implementing the provisions of this section and establish  
64 criteria for the disbursement of funds under this section to include but not be  
65 limited to grants to community health networks that provide the majority of care  
66 provided to MO HealthNet and low-income uninsured individuals in the  
67 community, and preference for health care entities where the majority of the  
68 patients and clients served are either participants of MO HealthNet or are from  
69 the medically underserved population. Any rule or portion of a rule, as that term  
70 is defined in section 536.010, that is created under the authority delegated in this  
71 section shall become effective only if it complies with and is subject to all of the  
72 provisions of chapter 536 and, if applicable, section 536.028. This section and  
73 chapter 536 are nonseverable and if any of the powers vested with the general  
74 assembly pursuant to chapter 536 to review, to delay the effective date, or to  
75 disapprove and annul a rule are subsequently held unconstitutional, then the grant  
76 of rulemaking authority and any rule proposed or adopted after August 28, 2007,  
77 shall be invalid and void.]

79 EXPLANATION: THE JOINT COMMITTEE ON MEDICAID TRANSFORMATION  
80 EXPIRED ON JANUARY 1, 2014:

2           [208.993. 1. The president pro tempore of the senate and the speaker of  
3 the house of representatives may jointly establish a committee to be known as the  
4 "Joint Committee on Medicaid Transformation".

5           2. The committee may study the following:

6           (1) Development of methods to prevent fraud and abuse in the MO  
7 HealthNet system;

8           (2) Advice on more efficient and cost-effective ways to provide coverage  
9 for MO HealthNet participants;

10          (3) An evaluation of how coverage for MO HealthNet participants can  
11 resemble that of commercially available health plans while complying with  
12 federal Medicaid requirements;

13          (4) Possibilities for promoting healthy behavior by encouraging patients  
14 to take ownership of their health care and seek early preventative care;

15          (5) Advice on the best manner in which to provide incentives, including  
16 a shared risk and savings to health plans and providers to encourage  
17 cost-effective delivery of care; and

18          (6) Ways that individuals who currently receive medical care coverage  
19 through the MO HealthNet program can transition to obtaining their health  
20 coverage through the private sector.

21          3. If established, the joint committee shall be composed of twelve  
members. Six members shall be from the senate, with four members appointed

by the president pro tempore of the senate, and two members of the minority party appointed by the president pro tempore of the senate with the advice of the minority leader of the senate. Six members shall be from the house of representatives, with four members appointed by the speaker of the house of representatives, and two members of the minority party appointed by the speaker of the house of representatives with the advice of the minority leader of the house of representatives.

4. The provisions of this section shall expire on January 1, 2014.]

EXPLANATION: THE TASK FORCE CREATED IN THIS SECTION SUBMITTED A REPORT AND EXPIRED ON JANUARY 1, 2015:

[210.105. 1. There is hereby created the "Missouri Task Force on Prematurity and Infant Mortality" within the children's services commission to consist of the following eighteen members:

(1) The following six members of the general assembly:

(a) Three members of the house of representatives, with two members to be appointed by the speaker of the house and one member to be appointed by the minority leader of the house;

(b) Three members of the senate, with two members to be appointed by the president pro tem of the senate and one member to be appointed by the minority leader of the senate;

(2) The director of the department of health and senior services, or the director's designee;

(3) The director of the department of social services, or the director's designee;

(4) The director of the department of insurance, financial institutions and professional registration, or the director's designee;

(5) One member representing a not-for-profit organization specializing in prematurity and infant mortality;

(6) Two members who shall be either a physician or nurse practitioner specializing in obstetrics and gynecology, family medicine, pediatrics or perinatology;

(7) Two consumer representatives who are parents of individuals born prematurely, including one parent of an individual under the age of eighteen;

(8) Two members representing insurance providers in the state;

(9) One small business advocate; and

(10) One member of the small business regulatory fairness board.

Members of the task force, other than the legislative members and directors of state agencies, shall be appointed by the governor with the advice and consent of the senate by September 15, 2011.

2. A majority of a quorum from among the task force membership shall elect a chair and vice chair of the task force.

32 3. A majority vote of a quorum of the task force is required for any  
33 action.

34 4. The chairperson of the children's services commission shall convene  
35 the initial meeting of the task force by no later than October 15, 2011. The task  
36 force shall meet at least quarterly; except that the task force shall meet at least  
37 twice prior to the end of 2011. Meetings may be held by telephone or video  
38 conference at the discretion of the chair.

39 5. Members shall serve on the commission without compensation, but  
40 may, subject to appropriation, be reimbursed for actual and necessary expenses  
41 incurred in the performance of their official duties as members of the task force.

42 6. The goal of the task force is to seek evidence-based and cost-effective  
43 approaches to reduce Missouri's preterm birth and infant mortality rates.

44 7. The task force shall:

45 (1) Submit findings to the general assembly;

46 (2) Review appropriate and relevant evidence-based research regarding  
47 the causes and effects of prematurity and birth defects in Missouri;

48 (3) Examine existing public and private entities currently associated with  
49 the prevention and treatment of prematurity and infant mortality in Missouri;

50 (4) Develop cost-effective strategies to reduce prematurity and infant  
51 mortality; and

52 (5) Issue findings and propose to the appropriate public and private  
53 organizations goals, objectives, strategies, and tactics designed to reduce  
54 prematurity and infant mortality in Missouri, including recommendations on  
55 public policy for consideration during the next appropriate session of the general  
56 assembly.

57 8. On or before December 31, 2013, the task force shall submit a report  
58 on their findings to the governor and general assembly. The report shall include  
59 any dissenting opinions in addition to any majority opinions.

60 9. The task force shall expire on January 1, 2015, or upon submission of  
61 a report under subsection 8 of this section, whichever is earlier.]

63 EXPLANATION: THIS SECTION IS OBSOLETE; THERE HAS BEEN NO ACTIVITY  
64 FROM THE INTERAGENCY WORKGROUP:

2 [251.650. 1. Not less than twice each calendar year, representatives from  
3 the department of labor and industrial relations, the department of elementary and  
4 secondary education, the department of agriculture, the department of economic  
5 development, and the department of natural resources shall meet to discuss ways  
6 in which their respective agencies may collaborate in order to secure grants  
7 established in the Energy Independence and Security Act of 2007, Public Law  
8 110-140, or other such grants that would fund: green jobs; the production of  
9 renewable fuels; increasing energy efficiency of products, buildings and vehicles;  
10 and increasing research and development relating to the manufacturing of  
renewable energy technologies. The department of natural resources is hereby

11 designated as the coordinating agency for the inter-agency collaboration under  
12 this section.

13 2. In fulfilling the goals under this section, any of the departments under  
14 subsection 1 of this section may confer with, or invite participation by, any other  
15 interested individual, agency, or organization, which shall include but not be  
16 limited to nonprofit organizations, private sector entities, institutions of higher  
17 education, and local governments. Such departments may enter into partnerships  
18 with, in accordance with federal grant requirements and as otherwise allowable  
19 by law, any individual, agency, or organization in securing a grant under this  
20 section.

21 3. No later than the first Wednesday after the first Monday of January  
22 each year, the departments outlined in subsection 1 of this section shall report  
23 jointly to the general assembly and to the governor the actions taken by their  
24 agencies in securing the grants outlined in this section.]

26 EXPLANATION: THIS SECTION ONLY APPLIES TO CALENDAR YEARS 2009, 2010,  
27 AND 2011:

2 [288.131. 1. For calendar years 2009, 2010, and 2011, each employer  
3 that is liable for contributions under this chapter, except employers with a  
4 contribution rate equal to zero, shall pay an annual unemployment automation  
5 surcharge in an amount equal to five one-hundredths of one percent of such  
6 employer's total taxable wages for the twelve-month period ending the preceding  
7 June thirtieth. However, the division may reduce the foregoing percentage to  
8 ensure that the total amount of surcharge due from all employers under this  
9 subsection shall not exceed thirteen million dollars annually. Each employer  
10 liable to pay such surcharge shall be notified of the amount due under this

17 unemployment contribution rate of each employer liable for contributions under  
18 this chapter shall be reduced by five one-hundredths of one percent, except such  
19 contribution rate shall not be less than zero.]

20 EXPLANATION: THIS SECTION EXPIRED 12-31-13:

2 [376.1192. 1. As used in this section, "health benefit plan" and "health  
3 carrier" shall have the same meaning as such terms are defined in section  
4 376.1350.

5 2. Beginning September 1, 2013, the oversight division of the joint  
6 committee on legislative research shall perform an actuarial analysis of the cost  
impact to health carriers, insureds with a health benefit plan, and other private

7 and public payers if state mandates were enacted to provide health benefit plan  
8 coverage for the following:

9 (1) Orally administered anticancer medication that is used to kill or slow  
10 the growth of cancerous cells charged at the same co-payment, deductible, or  
11 coinsurance amount as intravenously administered or injected cancer medication  
12 that is provided, regardless of formulation or benefit category determination by  
13 the health carrier administering the health benefit plan;

14 (2) Diagnosis and treatment of eating disorders that include anorexia  
15 nervosa, bulimia, binge eating, eating disorders nonspecified, and any other  
16 severe eating disorders contained in the most recent version of the Diagnostic and  
17 Statistical Manual of Mental Disorders published by the American Psychiatric  
18 Association. The actuarial analysis shall assume the following are included in  
19 health benefit plan coverage:

20 (a) Residential treatment for eating disorders, if such treatment is  
21 medically necessary in accordance with the Practice Guidelines for the Treatment  
22 of Patients with Eating Disorders, as most recently published by the American  
23 Psychiatric Association; and

24 (b) Access to medical treatment that provides coverage for integrated  
25 care and treatment as recommended by medical and mental health care  
26 professionals, including but not limited to psychological services, nutrition  
27 counseling, physical therapy, dietician services, medical monitoring, and  
28 psychiatric monitoring.

29 3. By December 31, 2013, the director of the oversight division of the  
30 joint committee on legislative research shall submit a report of the actuarial  
31 findings prescribed by this section to the speaker of the house of representatives,  
32 the president pro tempore of the senate, and the chairpersons of the house of  
33 representatives committee on health insurance and the senate small business,  
34 insurance and industry committee, or the committees having jurisdiction over  
35 health insurance issues if the preceding committees no longer exist.

36 4. For the purposes of this section, the actuarial analysis of health benefit  
37 plan coverage shall assume that such coverage:

38 (1) Shall not be subject to any greater deductible or co-payment than  
39 other health care services provided by the health benefit plan; and

40 (2) Shall not apply to a supplemental insurance policy, including a life  
41 care contract, accident-only policy, specified disease policy, hospital policy  
42 providing a fixed daily benefit only, Medicare supplement policy, long-term care  
43 policy, short-term major medical policies of six months' or less duration, or any  
44 other supplemental policy.

45 5. The cost for each actuarial analysis shall not exceed thirty thousand  
46 dollars and the oversight division of the joint committee on legislative research  
47 may utilize any actuary contracted to perform services for the Missouri  
48 consolidated health care plan to perform the analysis required under this section.

49 6. The provisions of this section shall expire on December 31, 2013.]

50 EXPLANATION: SECTIONS 414.350 TO 414.359 ARE OBSOLETE; THE PROGRAM WAS  
51 NOT IMPLEMENTED SINCE ITS AUTHORIZATION IN 1998:

[414.350. As used in sections 414.350 to 414.359, the following terms  
2 mean:

- 3 (1) "Alternative fuel", the same meaning as in section 414.400;
- 4 (2) "Division", the division of energy of the department of natural  
5 resources;
- 6 (3) "Fueling station", the equipment and property directly related to  
7 dispensing of an alternative fuel into the fuel tank of a vehicle propelled by such  
8 fuel, including the compression equipment and storage vessels for such fuel at the  
9 location where such fuel is dispensed;
- 10 (4) "Fund", the Missouri alternative fuel vehicle loan fund;
- 11 (5) "Incremental cost", the difference in cost between a vehicle that

21 [414.353. 1. On or before July 1, 2000, the division shall have developed  
2 an administrative plan for implementing a program that provides financial

5 2. The program shall accept applications for loans from political  
6 subdivisions with vehicle fleets for the:

- 7 (1) Purchase of new motor vehicles capable of using alternative fuels;

2 [414.356. 1. Using the fund created in section 414.359, the division shall  
3 provide loans of:

4 (1) A maximum of two thousand dollars for the incremental cost of  
5 purchasing a new vehicle capable of operating on an alternative fuel;

6 (2) A maximum of two thousand dollars for the conversion of a new or  
7 existing vehicle designed to operate on gasoline to enable such vehicle to operate  
8 on an alternative fuel; and

9 (3) A maximum of one hundred thousand dollars for the construction of

11 2. No political subdivision shall receive in aggregate more than one

2 [414.359. 1. There is hereby created in the state treasury the "Missouri  
3 Alternative Fuel Vehicle Loan Fund". The fund may receive moneys from  
4 appropriations by the general assembly, repayments by political subdivisions of  
5 loans made pursuant to sections 414.350 to 414.359 including interest on such  
loans, and gifts, bequests, donations or any other payments made by any public

6 or private entity for use in carrying out the provisions of sections 414.350 to  
7 414.359.

8 2. The state treasurer shall deposit all of the moneys in the fund into any  
9 of the qualified depositories of this state. All such deposits shall be secured in  
10 such a manner and shall be made upon such terms and conditions as are now or  
11 may hereafter be provided by law relative to state deposits. Interest accrued by  
12 the fund shall be credited to the fund. Notwithstanding the provisions of section  
13 33.080 to the contrary, moneys in the fund shall not revert to the credit of the  
14 general revenue fund at the end of the biennium.

15 3. The fund shall be used solely for the purposes of sections 414.350 to  
16 414.359 and for no other purpose.]

10 EXPLANATION: THE COUNCIL CREATED IN THIS SECTION DOES NOT EXIST:

[620.050. 1. There is hereby created, within the department of economic  
2 development, the "Entrepreneurial Development Council". The entrepreneurial  
3 development council shall consist of seven members from businesses located  
4 within the state and licensed attorneys with specialization in intellectual property  
5 matters. All members of the council shall be appointed by the governor with the  
6 advice and consent of the senate. The terms of membership shall be set by the  
7 department of economic development by rule as deemed necessary and  
8 reasonable. Once the department of economic development has set the terms of  
9 membership, such terms shall not be modified and shall apply to all subsequent  
10 members.

11 2. The entrepreneurial development council shall, as provided by  
12 department rule, impose a registration fee sufficient to cover costs of the program  
13 for entrepreneurs of this state who desire to avail themselves of benefits,

37 if any of the powers vested with the general assembly pursuant to chapter 536 to  
38 review, to delay the effective date, or to disapprove and annul a rule are  
39 subsequently held unconstitutional, then the grant of rulemaking authority and  
40 any rule proposed or adopted after August 28, 2008, shall be invalid and void.]

[640.219. 1. There is hereby created in the state treasury the "Studies in  
2 Energy Conservation Fund", which shall consist of moneys appropriated by the  
3 general assembly or donated by any individual or entity. The fund shall be  
4 administered by the department of higher education in coordination with the  
5 department of natural resources. Upon appropriation, money in the fund shall be  
6 used solely for the purposes set forth in this section and for any administrative  
7 expenses involving the implementation of this section. Notwithstanding the  
8 provisions of section 33.080 to the contrary, any moneys remaining in the fund  
9 at the end of the biennium shall not revert to the credit of the general revenue  
10 fund. The state treasurer shall invest moneys in the fund in the same manner as  
11 other funds are invested. Any interest and moneys earned on such investments  
12 shall be credited to the fund.

13 2. Subject to an initial appropriation from the fund, there is hereby
