

HB 1859 -- DEDUCTION FOR FEDERAL INCOME TAX LIABILITY

SPONSOR: Cross

Currently, the individual income tax deduction for federal income tax liability is capped at \$5,000 for single taxpayers and \$10,000 for taxpayers filing combined returns. Beginning January 1, 2017, this bill removes the caps.

This bill is similar to HB 114 (2015).
