1 AMEND Senate Bill No. 8, Page 1, Section A, Line 2, by inserting after all of said section and line
2 the following:

4 "301.147. 1. Notwithstanding the provisions of section 301.020 to the contrary, beginning
5 July 1, 2000, the director of revenue may provide owners of motor vehicles, other than commercial
6 motor vehicles licensed in excess of fifty-four thousand pounds gross weight, the option of
7 biennially registering motor vehicles. Any vehicle manufactured as an even-numbered model year
8 vehicle shall be renewed each even-numbered calendar year and any such vehicle manufactured as
9 an odd-numbered model year vehicle shall be renewed each odd-numbered calendar year, subject to
10 the following requirements:

11 (1) The fee collected at the time of biennial registration shall include the annual registration
12 fee plus a pro rata amount for the additional twelve months of the biennial registration;

13 (2) Presentation of all documentation otherwise required by law for vehicle registration
14 including, but not limited to, a personal property tax receipt or certified statement for the preceding
15 year that no such taxes were due as set forth in section 301.025, proof of a motor vehicle safety
16 inspection and any applicable emission inspection conducted within sixty days prior to the date of
17 application, and proof of insurance as required by section 303.026.

18 2. Notwithstanding the provisions of subsection 1 of this section and the provisions of
19 section 301.020 to the contrary, beginning January 1, 2018, the director of revenue shall provide
20 owners of motor vehicles other than commercial motor vehicles licensed in excess of fifty-four
21 thousand pounds gross weight, the option of a three-year registration when the vehicle would be
22 ineligible for a biennial registration but eligible for an annual registration under subsection 1 of this
23 section, subject to the following requirements:

24 (1) The fee collected at the time of three-year registration shall include the biennial
25 registration fee plus a pro rata amount for the additional twelve months of the three-year
26 registration;

27 (2) Presentation of all documentation otherwise required by law for vehicle registration
28 including, but not limited to, a personal property tax receipt or certified statement for the two
29 preceding years that no such taxes were due as set forth under section 301.025, proof of a motor
30 vehicle safety inspection and any applicable emission inspection conducted within sixty days prior

1 to the date of application, and proof of insurance as required by section 303.026.

2 3. The director of revenue may prescribe rules and regulations for the effective
3 administration of this section. The director is authorized to adopt those rules that are reasonable and
4 necessary to accomplish the limited duties specifically delegated within this section. Any rule or
5 portion of a rule, as that term is defined in section 536.010, that is promulgated pursuant to the
6 authority delegated in this section shall become effective only if it has been promulgated pursuant to
7 the provisions of chapter 536. This section and chapter 536 are nonseverable and if any of the
8 powers vested with the general assembly pursuant to chapter 536 to review, to delay the effective
9 date or to disapprove and annul a rule are subsequently held unconstitutional, then the grant of
10 rulemaking authority and any rule proposed or adopted after July 1, 2000, shall be invalid and void.

11 [3.] 4. The director of revenue shall have the authority to stagger the registration period of
12 motor vehicles other than commercial motor vehicles licensed in excess of twelve thousand pounds
13 gross weight. Once the owner of a motor vehicle chooses the option of biennial registration, such
14 registration [must] shall be maintained for the full twenty-four month period.";and

16 Further amend said bill, Page 2, Section B, Lines 1 to 5, by removing all of said section and
17 inserting in lieu thereof the following:

19 "Section B. Because of the need to protect lives on our roads and highways, section 307.175
20 of this act is deemed necessary for the immediate preservation of the public health, welfare, peace
21 and safety, and is hereby declared to be an emergency act within the meaning of the constitution,
22 and section 307.175 of this act shall be in full force and effect upon its passage and approval."; and

24 Further amend said bill by amending the title, enacting clause, and intersectional references
25 accordingly.
