1 AMEND House Committee Substitute for Senate Bill No. 30, Page 2, Section 88.770, Line 41, by
2 inserting the following after all of said line:

4 "213.010. As used in this chapter, the following terms shall mean:

5 (1) "Age", an age of forty or more years but less than seventy years, except that it shall not
6 be an unlawful employment practice for an employer to require the compulsory retirement of any
7 person who has attained the age of sixty-five and who, for the two-year period immediately before
8 retirement, is employed in a bona fide executive or high policy-making position, if such person is
9 entitled to an immediate nonforfeitable annual retirement benefit from a pension, profit sharing,
10 savings or deferred compensation plan, or any combination of such plans, of the employer, which
11 equals, in the aggregate, at least forty-four thousand dollars;

12 (2) "Commission", the Missouri commission on human rights;

13 (3) "Complainant", a person who has filed a complaint with the commission alleging that
14 another person has engaged in a prohibited discriminatory practice;

15 (4) "Disability", a physical or mental impairment which substantially limits one or more of
16 a person's major life activities, being regarded as having such an impairment, or a record of having
17 such an impairment, which with or without reasonable accommodation does not interfere with
18 performing the job, utilizing the place of public accommodation, or occupying the dwelling in
19 question. For purposes of this chapter, the term "disability" does not include current, illegal use of
20 or addiction to a controlled substance as such term is defined by section 195.010; however, a person
21 may be considered to have a disability if that person:

22 (a) Has successfully completed a supervised drug rehabilitation program and is no longer
23 engaging in the illegal use of, and is not currently addicted to, a controlled substance or has
24 otherwise been rehabilitated successfully and is no longer engaging in such use and is not currently
25 addicted;

26 (b) Is participating in a supervised rehabilitation program and is no longer engaging in
27 illegal use of controlled substances; or

28 (c) Is erroneously regarded as currently illegally using, or being addicted to, a controlled
29 substance;

30 (5) "Discrimination", any unfair treatment based on race, color, religion, national origin,
31 ancestry, sex, age as it relates to employment, disability, or familial status as it relates to housing;

32 (6) "Dwelling", any building, structure or portion thereof which is occupied as, or designed
33 or intended for occupancy as, a residence by one or more families, and any vacant land which is
34 offered for sale or lease for the construction or location thereon of any such building, structure or
35 portion thereof;

36 (7) "Employer" includes the state, or any political or civil subdivision thereof, or any person

1 employing six or more persons within the state, and any person directly acting in the interest of an
 2 employer, but does not include corporations and associations owned and operated by religious or
 3 sectarian groups;

4 (8) "Employment agency" includes any person or agency, public or private, regularly
 5 undertaking with or without compensation to procure employees for an employer or to procure for
 6 employees opportunities to work for an employer and includes any person acting in the interest of
 7 such a person;

8 (9) "Executive director", the executive director of the Missouri commission on human
 9 rights;

10 (10) "Familial status", one or more individuals who have not attained the age of eighteen
 11 years being domiciled with:

12 (a) A parent or another person having legal custody of such individual; or

13 (b) The designee of such parent or other person having such custody, with the written
 14 permission of such parent or other person. The protections afforded against discrimination on the
 15 basis of familial status shall apply to any person who is pregnant or is in the process of securing
 16 legal custody of any individual who has not attained the age of eighteen years;

17 (11) "Human rights fund", a fund established to receive civil penalties as required by federal
 18 regulations and as set forth by subdivision (2) of subsection 11 of section 213.075, and which will
 19 be disbursed to offset additional expenses related to compliance with the Department of Housing
 20 and Urban Development regulations;

21 (12) "Labor organization" includes any organization which exists for the purpose, in whole
 22 or in part, of collective bargaining or of dealing with employers concerning grievances, terms or
 23 conditions of employment, or for other mutual aid or protection in relation to employment;

24 (13) "Local commissions", any commission or agency established prior to August 13, 1986,
 25 by an ordinance or order adopted by the governing body of any city, constitutional charter city,
 26 town, village, or county;

27 (14) "Person" includes one or more individuals, corporations, partnerships, associations,
 28 organizations, labor organizations, legal representatives, mutual companies, joint stock companies,
 29 trusts, trustees, trustees in bankruptcy, receivers, fiduciaries, or other organized groups of persons;

30 (15) "Places of public accommodation", all places or businesses offering or holding out to
 31 the general public, goods, services, privileges, facilities, advantages or accommodations for the
 32 peace, comfort, health, welfare and safety of the general public or such public places providing
 33 food, shelter, recreation and amusement, including, but not limited to:

34 (a) Any inn, hotel, motel, or other establishment which provides lodging to transient guests,
 35 other than an establishment located within a building which contains not more than five rooms for
 36 rent or hire and which is actually occupied by the proprietor of such establishment as his residence;

37 (b) Any restaurant, cafeteria, lunchroom, lunch counter, soda fountain, or other facility
 38 principally engaged in selling food for consumption on the premises, including, but not limited to,
 39 any such facility located on the premises of any retail establishment;

40 (c) Any gasoline station, including all facilities located on the premises of such gasoline
 41 station and made available to the patrons thereof;

42 (d) Any motion picture house, theater, concert hall, sports arena, stadium, or other place of
 43 exhibition or entertainment;

44 (e) Any public facility owned, operated, or managed by or on behalf of this state or any
 45 agency or subdivision thereof, or any public corporation; and any such facility supported in whole
 46 or in part by public funds, except that "places of public accommodation" shall not include any
 47 prison, jail, or other detention or confinement facility owned, operated, or managed by this state or
 48 any agency or subdivision thereof;

1 (f) Any establishment which is physically located within the premises of any establishment
2 otherwise covered by this section or within the premises of which is physically located any such
3 covered establishment, and which holds itself out as serving patrons of such covered establishment;

4 (16) "Rent" includes to lease, to sublease, to let and otherwise to grant for consideration the
5 right to occupy premises not owned by the occupant;

6 (17) "Respondent", a person who is alleged to have engaged in a prohibited discriminatory
7 practice in a complaint filed with the commission;

8 (18) "Unlawful discriminatory practice", any act that is unlawful under this chapter."; and

10 Further amend said bill by amending the title, enacting clause, and intersectional references
