1 AMEND House Committee Substitute for Senate Bill No. 30, Page 1, Section A, Line 2, by
2 inserting the following after all of said section and line:

4 "50.622. 1. Any county may amend the annual budget during any fiscal year in which the
5 county receives additional funds, and such amount or source, including, but not limited to, federal
6 or state grants or private donations, could not be estimated when the budget was adopted. The
7 county shall follow the same procedures as required in sections 50.525 to 50.745 for adoption of the
8 annual budget to amend its budget during a fiscal year.

9 2. Any county may decrease the annual budget twice during any fiscal year in which the
10 county experiences a verifiable decline in funds of two percent or more, and such amount could not
11 be estimated or anticipated when the budget was adopted, provided that any decrease in
12 appropriations shall not unduly affect any one officeholder. Before any reduction affecting an
13 independently elected officeholder can occur, negotiations shall take place with all officeholders
14 who receive funds from the affected category of funds in an attempt to cover the shortfall. The
15 county shall follow the same procedures as required in sections 50.525 to 50.745 to decrease the
16 annual budget, except that the notice provided for in section 50.600 shall be extended to thirty days
17 for purposes of this subsection. Such notice shall include a published summary of the proposed
18 reductions and an explanation of the shortfall.

19 3. Any decrease in an appropriation authorized under subsection 2 of this section shall not
20 impact any dedicated fund otherwise provided by law.

21 4. County commissioners may reduce budgets of departments under their direct supervision
22 and responsibility at any time without the restrictions imposed by this section.

23 5. Subsections 2, 3, and 4 of this section shall expire on July 1, [2016] 2027.

24 6. Notwithstanding the provisions of this section, no charter county shall be restricted from
25 amending its budget under and pursuant to the terms of its charter.

26 54.040. [1-] Except in a county with a charter form of government, a candidate for county
27 treasurer shall be at least twenty-one years of age and a resident of the state of Missouri and the
28 county in which he or she is a candidate for at least one year prior to the date of the general election
29 for such office. The candidate shall also be a registered voter and shall be current in the payment of
30 all personal and real estate taxes. Upon election to such office, the person shall continue to reside in
31 that county during his or her tenure in office. Each candidate for county treasurer shall also provide

1 to the election authority a copy of a signed affidavit from a surety company authorized to do
2 business in this state indicating that the candidate meets the bond requirements for the office of
3 county treasurer under this chapter.
