5 "211.021. [1-] As used in this chapter, unless the context clearly requires otherwise:

6 (1) "Adult" means a person [seventeen] eighteen years of age or older [except for seventeen-  
7 year-old children as defined in this section];

8 (2) "Child" means any person under [seventeen] eighteen years of age [and shall mean, in  
9 addition, any person over seventeen but not yet eighteen years of age alleged to have committed a  
10 status offense];

11 (3) "Juvenile court" means the juvenile division or divisions of the circuit court of the  
12 county, or judges while hearing juvenile cases assigned to them;

13 (4) "Legal custody" means the right to the care, custody and control of a child and the duty  
14 to provide food, clothing, shelter, ordinary medical care, education, treatment and discipline of a  
15 child. Legal custody may be taken from a parent only by court action and if the legal custody is  
16 taken from a parent without termination of parental rights, the parent's duty to provide support  
17 continues even though the person having legal custody may provide the necessities of daily living;

18 (5) "Parent" means either a natural parent or a parent by adoption and if the child is  
19 illegitimate, "parent" means the mother;

20 (6) "Shelter care" means the temporary care of juveniles in physically unrestricting facilities  
21 pending final court disposition. These facilities may include:

22 (a) "Foster home", the private home of foster parents providing twenty-four-hour care to  
23 one to three children unrelated to the foster parents by blood, marriage or adoption;

24 (b) "Group foster home", the private home of foster parents providing twenty-four-hour care  
25 to no more than six children unrelated to the foster parents by blood, marriage or adoption;

26 (c) "Group home", a child care facility which approximates a family setting, provides access  
27 to community activities and resources, and provides care to no more than twelve children;

28 (7) "Status offense", any offense as described in subdivision (2) of subsection 1 of section  
29 211.031.

30 [2. The amendments to subsection 1 of this section, as provided for in this act, shall not take  
31 effect until such time as appropriations by the general assembly for additional juvenile officer full-  
32 time equivalents and deputy juvenile officer full-time equivalents shall exceed by one million nine  
33 hundred thousand dollars the amount spent by the state for such officers in fiscal year 2007 and  
34 appropriations by the general assembly to single first class counties for juvenile court personnel  
35 costs shall exceed by one million nine hundred thousand dollars the amount spent by the state for  
36 such juvenile court personnel costs in fiscal year 2007 and notice of such appropriations has been

2 211.031. 1. Except as otherwise provided in this chapter, the juvenile court or the family  
3 court in circuits that have a family court as provided in sections 487.010 to 487.190 shall have  
4 exclusive original jurisdiction in proceedings:

5 (1) Involving any child ~~[or person seventeen years of age]~~ who may be a resident of or  
6 found within the county and who is alleged to be in need of care and treatment because:

7 (a) The parents, or other persons legally responsible for the care and support of the child ~~[or~~  
8 ~~person seventeen years of age]~~, neglect or refuse to provide proper support, education which is  
9 required by law, medical, surgical or other care necessary for his or her well-being; except that  
10 reliance by a parent, guardian or custodian upon remedial treatment other than medical or surgical  
11 treatment for a child ~~[or person seventeen years of age]~~ shall not be construed as neglect when the  
12 treatment is recognized or permitted pursuant to the laws of this state;

13 (b) The child ~~[or person seventeen years of age]~~ is otherwise without proper care, custody  
14 or support; or

15 (c) The child ~~[or person seventeen years of age]~~ was living in a room, building or other  
16 structure at the time such dwelling was found by a court of competent jurisdiction to be a public  
17 nuisance pursuant to section 195.130;

18 (d) The child ~~[or person seventeen years of age is a child]~~ is in need of mental health  
19 services and the parent, guardian or custodian is unable to afford or access appropriate mental health  
20 treatment or care for the child;

21 (2) Involving any child who may be a resident of or found within the county and who is  
22 alleged to be in need of care and treatment because:

23 (a) The child while subject to compulsory school attendance is repeatedly and without  
24 justification absent from school; or

25 (b) The child disobeys the reasonable and lawful directions of his or her parents or other  
26 custodian and is beyond their control; or

27 (c) The child is habitually absent from his or her home without sufficient cause, permission,  
28 or justification; or

29 (d) The behavior or associations of the child are otherwise injurious to his or her welfare or  
30 to the welfare of others; or

31 (e) The child is charged with an offense not classified as criminal, or with an offense  
32 applicable only to children; except that, the juvenile court shall not have jurisdiction over any child  
33 fifteen years of age who is alleged to have violated a state or municipal traffic ordinance or  
34 regulation, the violation of which does not constitute a felony, or any child who is alleged to have  
35 violated a state or municipal ordinance or regulation prohibiting possession or use of any tobacco  
36 product;

37 (3) Involving any child who is alleged to have violated a state law or municipal ordinance,  
38 or any person who is alleged to have violated a state law or municipal ordinance prior to attaining  
39 the age of ~~[seventeen]~~ eighteen years, in which cases jurisdiction may be taken by the court of the  
40 circuit in which the child or person resides or may be found or in which the violation is alleged to  
41 have occurred; except that, the juvenile court shall not have jurisdiction over any child fifteen years  
42 of age who is alleged to have violated a state or municipal traffic ordinance or regulation, the  
43 violation of which does not constitute a felony, and except that the juvenile court shall have  
44 concurrent jurisdiction with the municipal court over any child who is alleged to have violated a  
45 municipal curfew ordinance, and except that the juvenile court shall have concurrent jurisdiction  
46 with the circuit court on any child who is alleged to have violated a state or municipal ordinance or  
47 regulation prohibiting possession or use of any tobacco product;

48 (4) For the adoption of a person;

1 (5) For the commitment of a child ~~[or person seventeen years of age]~~ to the guardianship of  
2 the department of social services as provided by law; and

3 (6) Involving an order of protection pursuant to chapter 455 when the respondent is less  
4 than ~~[seventeen]~~ eighteen years of age.

5 2. Transfer of a matter, proceeding, jurisdiction or supervision for a child ~~[or person~~  
6 ~~seventeen years of age]~~ who resides in a county of this state shall be made as follows:

7 (1) Prior to the filing of a petition and upon request of any party or at the discretion of the  
8 juvenile officer, the matter in the interest of a child ~~[or person seventeen years of age]~~ may be  
9 transferred by the juvenile officer, with the prior consent of the juvenile officer of the receiving  
10 court, to the county of the child's residence or the residence of the person ~~[seventeen]~~ eighteen years  
11 of age for future action;

12 (2) Upon the motion of any party or on its own motion prior to final disposition on the  
13 pending matter, the court in which a proceeding is commenced may transfer the proceeding of a  
14 child ~~[or person seventeen years of age]~~ to the court located in the county of the child's residence ~~[or~~  
15 ~~the residence of the person seventeen years of age]~~, or the county in which the offense pursuant to  
16 subdivision (3) of subsection 1 of this section is alleged to have occurred for further action;

17 (3) Upon motion of any party or on its own motion, the court in which jurisdiction has been  
18 taken pursuant to subsection 1 of this section may at any time thereafter transfer jurisdiction of a  
19 child ~~[or person seventeen years of age]~~ to the court located in the county of the child's residence ~~[or~~  
20 ~~the residence of the person seventeen years of age]~~ for further action with the prior consent of the  
21 receiving court;

22 (4) Upon motion of any party or upon its own motion at any time following a judgment of  
23 disposition or treatment pursuant to section 211.181, the court having jurisdiction of the cause may  
24 place the child ~~[or person seventeen years of age]~~ under the supervision of another juvenile court  
25 within or without the state pursuant to section 210.570 with the consent of the receiving court;

26 (5) Upon motion of any child ~~[or person seventeen years of age]~~ or his or her parent, the  
27 court having jurisdiction shall grant one change of judge pursuant to Missouri supreme court rules;

28 (6) Upon the transfer of any matter, proceeding, jurisdiction or supervision of a child ~~[or~~  
29 ~~person seventeen years of age]~~, certified copies of all legal and social documents and records  
30 pertaining to the case on file with the clerk of the transferring juvenile court shall accompany the  
31 transfer.

32 3. In any proceeding involving any child ~~[or person seventeen years of age]~~ taken into  
33 custody in a county other than the county of the child's residence ~~[or the residence of a person~~  
34 ~~seventeen years of age]~~, the juvenile court of the county of the child's residence ~~[or the residence of~~  
35 ~~a person seventeen years of age]~~ shall be notified of such taking into custody within seventy-two  
36 hours.

37 4. When an investigation by a juvenile officer pursuant to this section reveals that the only  
38 basis for action involves an alleged violation of section 167.031 involving a child who alleges to be  
39 home schooled, the juvenile officer shall contact a parent or parents of such child to verify that the  
40 child is being home schooled and not in violation of section 167.031 before making a report of such  
41 a violation. Any report of a violation of section 167.031 made by a juvenile officer regarding a  
42 child who is being home schooled shall be made to the prosecuting attorney of the county where the  
43 child legally resides.

44 5. The disability or disease of a parent shall not constitute a basis for a determination that a  
45 child is a child in need of care or for the removal of custody of a child from the parent without a  
46 specific showing that there is a causal relation between the disability or disease and harm to the  
47 child.

48 211.032. 1. Except as otherwise provided in a circuit participating in a pilot project

1 established by the Missouri supreme court, when a child [~~or person seventeen years of age~~], alleged  
 2 to be in need of care and treatment pursuant to subdivision (1) of subsection 1 of section 211.031, is  
 3 taken into custody, the juvenile or family court shall notify the parties of the right to have a  
 4 protective custody hearing. Such notification shall be in writing.

5 2. Upon request from any party, the court shall hold a protective custody hearing. Such  
 6 hearing shall be held within three days of the request for a hearing, excluding Saturdays, Sundays  
 7 and legal holidays. For circuits participating in a pilot project established by the Missouri supreme  
 8 court, the parties shall be notified at the status conference of their right to request a protective  
 9 custody hearing.

10 3. No later than February 1, 2005, the Missouri supreme court shall require a mandatory  
 11 court proceeding to be held within three days, excluding Saturdays, Sundays, and legal holidays, in  
 12 all cases under subdivision (1) of subsection 1 of section 211.031. The Missouri supreme court  
 13 shall promulgate rules for the implementation of such mandatory court proceedings and may  
 14 consider recommendations from any pilot projects established by the Missouri supreme court  
 15 regarding such proceedings. Nothing in this subsection shall prevent the Missouri supreme court  
 16 from expanding pilot projects prior to the implementation of this subsection.

17 4. The court shall hold an adjudication hearing no later than sixty days after the child has  
 18 been taken into custody. The court shall notify the parties in writing of the specific date, time, and  
 19 place of such hearing. If at such hearing the court determines that sufficient cause exists for the  
 20 child to remain in the custody of the state, the court shall conduct a dispositional hearing no later  
 21 than ninety days after the child has been taken into custody and shall conduct review hearings  
 22 regarding the reunification efforts made by the division every ninety to one hundred twenty days for  
 23 the first year the child is in the custody of the division. After the first year, review hearings shall be  
 24 held as necessary, but in no event less than once every six months for as long as the child is in the  
 25 custody of the division.

26 5. At all hearings held pursuant to this section the court may receive testimony and other  
 27 evidence relevant to the necessity of detaining the child out of the custody of the parents, guardian  
 28 or custodian.

29 6. By January 1, 2005, the supreme court shall develop rules regarding the effect of  
 30 untimely hearings.

31 7. If the placement of any child in the custody of the children's division will result in the  
 32 child attending a school other than the school the child was attending when taken into custody:

33 (1) The child's records from such school shall automatically be forwarded to the school that  
 34 the child is transferring to upon notification within two business days by the division; or

35 (2) Upon request of the foster family, the guardian ad litem, or the volunteer advocate and  
 36 whenever possible, the child shall be permitted to continue to attend the same school that the child  
 37 was enrolled in and attending at the time the child was taken into custody by the division. The  
 38 division, in consultation with the department of elementary and secondary education, shall establish  
 39 the necessary procedures to implement the provisions of this subsection.

40 211.033. 1. No person under the age of [~~seventeen~~] eighteen years, except those transferred  
 41 to the court of general jurisdiction under the provisions of section 211.071 shall be detained in a jail  
 42 or other adult detention facility as that term is defined in section 211.151. A traffic court judge may  
 43 request the juvenile court to order the commitment of a person under the age of [~~seventeen~~] eighteen  
 44 to a juvenile detention facility.

45 2. Nothing in this section shall be construed as creating any civil or criminal liability for any  
 46 law enforcement officer, juvenile officer, school personnel, or court personnel for any action taken  
 47 or failure to take any action involving a minor child who remains under the jurisdiction of the  
 48 juvenile court under this section if such action or failure to take action is based on a good faith

1 belief by such officer or personnel that the minor child is not under the jurisdiction of the juvenile  
2 court.

3 ~~[3. The amendments to subsection 2 of this section, as provided for in this act, shall not take~~  
4 ~~effect until such time as the provisions of section 211.021 shall take effect in accordance with~~

6 211.041. When jurisdiction over the person of a child has been acquired by the juvenile  
7 court under the provisions of this chapter in proceedings coming within the applicable provisions of  
8 section 211.031, the jurisdiction of the child may be retained for the purpose of this chapter until he  
9 or she has attained the age of twenty-one years, except in cases where he or she is committed to and  
10 received by the division of youth services, unless jurisdiction has been returned to the committing  
11 court by provisions of chapter 219 through requests of the court to the division of youth services  
12 and except in any case where he or she has not paid an assessment imposed in accordance with  
13 section 211.181 or in cases where the judgment for restitution entered in accordance with section  
14 211.185 has not been satisfied. Every child over whose person the juvenile court retains jurisdiction  
15 shall be prosecuted under the general law for any violation of a state law or of a municipal  
16 ordinance which he or she commits after he or she becomes ~~[seventeen]~~ eighteen years of age. The  
17 juvenile court shall have no jurisdiction with respect to any such violation and, so long as it retains  
18 jurisdiction of the child, shall not exercise its jurisdiction in such a manner as to conflict with any  
19 other court's jurisdiction as to any such violation.

20 211.061. 1. When a child is taken into custody with or without warrant for an offense, the  
21 child, together with any information concerning the child and the personal property found in the  
22 child's possession, shall be taken immediately and directly before the juvenile court or delivered to  
23 the juvenile officer or person acting for ~~[him]~~ the child.

24 2. If any person is taken before a circuit or associate circuit judge not assigned to juvenile  
25 court or a municipal judge, and it is then, or at any time thereafter, ascertained that he or she was  
26 under the age of ~~[seventeen]~~ eighteen years at the time he or she is alleged to have committed the  
27 offense, or that he or she is subject to the jurisdiction of the juvenile court as provided by this  
28 chapter, it is the duty of the judge forthwith to transfer the case or refer the matter to the juvenile  
29 court, and direct the delivery of such person, together with information concerning him or her and  
30 the personal property found in his or her possession, to the juvenile officer or person acting as such.

31 3. When the juvenile court is informed that a child is in detention it shall examine the  
32 reasons therefor and shall immediately:

33 (1) Order the child released; or

34 (2) Order the child continued in detention until a detention hearing is held. An order to  
35 continue the child in detention shall only be entered upon the filing of a petition or motion to  
36 modify and a determination by the court that probable cause exists to believe that the child has  
37 committed acts specified in the petition or motion that bring the child within the jurisdiction of the  
38 court under subdivision (2) or (3) of subsection 1 of section 211.031.

39 4. A juvenile shall not remain in detention for a period greater than twenty-four hours  
40 unless the court orders a detention hearing. If such hearing is not held within three days, excluding  
41 Saturdays, Sundays and legal holidays, the juvenile shall be released from detention unless the court  
42 for good cause orders the hearing continued. The detention hearing shall be held within the judicial  
43 circuit at a date, time and place convenient to the court. Notice of the date, time and place of a  
44 detention hearing, and of the right to counsel, shall be given to the juvenile and his or her custodian  
45 in person, by telephone, or by such other expeditious method as is available.

46 211.071. 1. If a petition alleges that a child between the ages of twelve and ~~[seventeen]~~  
47 eighteen has committed an offense which would be considered a felony if committed by an adult,  
48 the court may, upon its own motion or upon motion by the juvenile officer, the child or the child's

1 custodian, order a hearing and may, in its discretion, dismiss the petition and such child may be  
 2 transferred to the court of general jurisdiction and prosecuted under the general law; except that if a  
 3 petition alleges that any child has committed an offense which would be considered first degree  
 4 murder under section 565.020, second degree murder under section 565.021, first degree assault  
 5 under section 565.050, forcible rape under section 566.030 as it existed prior to August 28, 2013,  
 6 rape in the first degree under section 566.030, forcible sodomy under section 566.060 as it existed  
 7 prior to August 28, 2013, sodomy in the first degree under section 566.060, first degree robbery  
 8 under section 569.020 as it existed prior to January 1, 2017, or first degree robbery under section  
 9 570.023, [or] distribution of drugs under section 195.211 as it existed prior to January 1, 2017, or  
 10 the manufacturing of a controlled substance under section 579.055, or has committed two or more  
 11 prior unrelated offenses which would be felonies if committed by an adult, the court shall order a  
 12 hearing, and may in its discretion, dismiss the petition and transfer the child to a court of general  
 13 jurisdiction for prosecution under the general law.

14 2. Upon apprehension and arrest, jurisdiction over the criminal offense allegedly committed  
 15 by any person between [~~seventeen~~] eighteen and twenty-one years of age over whom the juvenile  
 16 court has retained continuing jurisdiction shall automatically terminate and that offense shall be  
 17 dealt with in the court of general jurisdiction as provided in section 211.041.

18 3. Knowing and willful age misrepresentation by a juvenile subject shall not affect any  
 19 action or proceeding which occurs based upon the misrepresentation. Any evidence obtained during  
 20 the period of time in which a child misrepresents his or her age may be used against the child and  
 21 will be subject only to rules of evidence applicable in adult proceedings.

22 4. Written notification of a transfer hearing shall be given to the juvenile and his or her  
 23 custodian in the same manner as provided in sections 211.101 and 211.111. Notice of the hearing  
 24 may be waived by the custodian. Notice shall contain a statement that the purpose of the hearing is  
 25 to determine whether the child is a proper subject to be dealt with under the provisions of this  
 26 chapter, and that if the court finds that the child is not a proper subject to be dealt with under the  
 27 provisions of this chapter, the petition will be dismissed to allow for prosecution of the child under  
 28 the general law.

29 5. The juvenile officer may consult with the office of prosecuting attorney concerning any  
 30 offense for which the child could be certified as an adult under this section. The prosecuting or  
 31 circuit attorney shall have access to police reports, reports of the juvenile or deputy juvenile officer,  
 32 statements of witnesses and all other records or reports relating to the offense alleged to have been  
 33 committed by the child. The prosecuting or circuit attorney shall have access to the disposition  
 34 records of the child when the child has been adjudicated pursuant to subdivision (3) of subsection 1  
 35 of section 211.031. The prosecuting attorney shall not divulge any information regarding the child  
 36 and the offense until the juvenile court at a judicial hearing has determined that the child is not a  
 37 proper subject to be dealt with under the provisions of this chapter.

38 6. A written report shall be prepared in accordance with this chapter developing fully all  
 39 available information relevant to the criteria which shall be considered by the court in determining  
 40 whether the child is a proper subject to be dealt with under the provisions of this chapter and  
 41 whether there are reasonable prospects of rehabilitation within the juvenile justice system. These  
 42 criteria shall include but not be limited to:

43 (1) The seriousness of the offense alleged and whether the protection of the community  
 44 requires transfer to the court of general jurisdiction;

45 (2) Whether the offense alleged involved viciousness, force and violence;

46 (3) Whether the offense alleged was against persons or property with greater weight being  
 47 given to the offense against persons, especially if personal injury resulted;

48 (4) Whether the offense alleged is a part of a repetitive pattern of offenses which indicates

1 that the child may be beyond rehabilitation under the juvenile code;

2 (5) The record and history of the child, including experience with the juvenile justice  
3 system, other courts, supervision, commitments to juvenile institutions and other placements;

4 (6) The sophistication and maturity of the child as determined by consideration of his home  
5 and environmental situation, emotional condition and pattern of living;

6 (7) The age of the child;

7 (8) The program and facilities available to the juvenile court in considering disposition;

8 (9) Whether or not the child can benefit from the treatment or rehabilitative programs  
9 available to the juvenile court; and

10 (10) Racial disparity in certification.

11 7. If the court dismisses the petition to permit the child to be prosecuted under the general  
12 law, the court shall enter a dismissal order containing:

13 (1) Findings showing that the court had jurisdiction of the cause and of the parties;

14 (2) Findings showing that the child was represented by counsel;

15 (3) Findings showing that the hearing was held in the presence of the child and his counsel;  
16 and

17 (4) Findings showing the reasons underlying the court's decision to transfer jurisdiction.

18 8. A copy of the petition and order of the dismissal shall be sent to the prosecuting attorney.

19 9. When a petition has been dismissed thereby permitting a child to be prosecuted under the  
20 general law and the prosecution of the child results in a conviction, the jurisdiction of the juvenile  
21 court over that child is forever terminated, except as provided in subsection 10 of this section, for an  
22 act that would be a violation of a state law or municipal ordinance.

23 10. If a petition has been dismissed thereby permitting a child to be prosecuted under the  
24 general law and the child is found not guilty by a court of general jurisdiction, the juvenile court  
25 shall have jurisdiction over any later offense committed by that child which would be considered a  
26 misdemeanor or felony if committed by an adult, subject to the certification provisions of this  
27 section.

28 11. If the court does not dismiss the petition to permit the child to be prosecuted under the  
29 general law, it shall set a date for the hearing upon the petition as provided in section 211.171.

30 211.073. 1. The court shall, in a case when the offender is under ~~[seventeen]~~ eighteen years  
31 ~~[and six months]~~ of age and has been transferred to a court of general jurisdiction pursuant to  
32 section 211.071, and whose prosecution results in a conviction or a plea of guilty, consider dual  
33 jurisdiction of both the criminal and juvenile codes, as set forth in this section. The court is  
34 authorized to impose a juvenile disposition under this chapter and simultaneously impose an adult  
35 criminal sentence, the execution of which shall be suspended pursuant to the provisions of this  
36 section. Successful completion of the juvenile disposition ordered shall be a condition of the  
37 suspended adult criminal sentence. The court may order an offender into the custody of the division  
38 of youth services pursuant to this section:

39 (1) Upon agreement of the division of youth services; and

40 (2) If the division of youth services determines that there is space available in a facility  
41 designed to serve offenders sentenced under this section. If the division of youth services agrees to  
42 accept a youth and the court does not impose a juvenile disposition, the court shall make findings on  
43 the record as to why the division of youth services was not appropriate for the offender prior to  
44 imposing the adult criminal sentence.

45 2. If there is probable cause to believe that the offender has violated a condition of the  
46 suspended sentence or committed a new offense, the court shall conduct a hearing on the violation  
47 charged, unless the offender waives such hearing. If the violation is established and found the court  
48 may continue or revoke the juvenile disposition, impose the adult criminal sentence, or enter such

1 other order as it may see fit.

2 3. When an offender has received a suspended sentence pursuant to this section and the  
3 division determines the child is beyond the scope of its treatment programs, the division of youth  
4 services may petition the court for a transfer of custody of the offender. The court shall hold a  
5 hearing and shall:

6 (1) Revoke the suspension and direct that the offender be taken into immediate custody of  
7 the department of corrections; or

8 (2) Direct that the offender be placed on probation.

9 4. When an offender who has received a suspended sentence reaches the age of [seventeen]  
10 eighteen, the court shall hold a hearing. The court shall:

11 (1) Revoke the suspension and direct that the offender be taken into immediate custody of  
12 the department of corrections;

13 (2) Direct that the offender be placed on probation; or

14 (3) Direct that the offender remain in the custody of the division of youth services if the  
15 division agrees to such placement.

16 5. The division of youth services shall petition the court for a hearing before it releases an  
17 offender who comes within subsection 1 of this section at any time before the offender reaches the  
18 age of twenty-one years. The court shall:

19 (1) Revoke the suspension and direct that the offender be taken into immediate custody of  
20 the department of corrections; or

21 (2) Direct that the offender be placed on probation.

22 6. If the suspension of the adult criminal sentence is revoked, all time served by the offender  
23 under the juvenile disposition shall be credited toward the adult criminal sentence imposed.

24 211.081. 1. Whenever any person informs the court in person and in writing that a child  
25 appears to be within the purview of applicable provisions of section 211.031 [~~or that a person~~  
26 ~~seventeen years of age appears to be within the purview of the provisions of subdivision (1) of~~  
27 ~~subsection 1 of section 211.031~~], the court shall make or cause to be made a preliminary inquiry to

5 211.091. 1. The petition shall be entitled "In the interest of ....., a child under

7 ~~"In the interest of ....., a person seventeen years of age"~~ as appropriate to the subsection of  
8 section 211.031 that provides the basis for the filing of the petition].

9 2. The petition shall set forth plainly:

 17 which, if committed by an adult, would be a class A felony under the criminal code of Missouri, or

 46 extent that records of criminal proceedings are open to the public. However, the social summaries,  
 47 investigations or updates in the nature of presentence investigations, and status reports submitted to

1 confidential and shall be opened to inspection only by order of the judge of the juvenile court;

2 (3) As otherwise provided by statute;

3 (4) In all other instances, only by order of the judge of the juvenile court.

4 3. Peace officers' records, if any are kept, of children shall be kept separate from the records  
5 of persons ~~[seventeen]~~ eighteen years of age or over and shall not be open to inspection or their  
6 contents disclosed, except by order of the court. This subsection does not apply to children who are  
7 transferred to courts of general jurisdiction as provided by section 211.071 or to juveniles convicted

9 inspection or disclosure of the contents of the records of peace officers for the purpose of pursuing a

12 to persons or organizations authorized by law to compile statistics relating to juveniles. The court  
13 shall adopt procedures to protect the confidentiality of children's names and identities.

14 5. The court may, either on its own motion or upon application by the child or his or her  
15 representative, or upon application by the juvenile officer, enter an order to destroy all social  
16 histories, records, and information, other than the official court file, and may enter an order to seal  
17 the official court file, as well as all peace officers' records, at any time after the child has reached his  
18 ~~[seventeenth]~~ or her eighteenth birthday if the court finds that it is in the best interest of the child  
19 that such action or any part thereof be taken, unless the jurisdiction of the court is continued beyond

30 own motion, or upon application by the juvenile officer, enters an order to seal the records of the  
31 victim child.

32 211.421. 1. After any child has come under the care or control of the juvenile court as  
33 provided in this chapter, any person who thereafter encourages, aids, or causes the child to commit  
34 any act or engage in any conduct which would be injurious to the child's morals or health or who  
35 knowingly or negligently disobeys, violates or interferes with a lawful order of the court with  
36 relation to the child, is guilty of contempt of court, and shall be proceeded against as now provided  
37 by law and punished by imprisonment in the county jail for a term not exceeding six months or by a  
38 fine not exceeding five hundred dollars or by both such fine and imprisonment.

39 2. If it appears at a juvenile court hearing that any person ~~[seventeen]~~ eighteen years of age  
40 or over has violated section 568.045 or 568.050, RSMo, by endangering the welfare of a child, the  
41 judge of the juvenile court shall refer the information to the prosecuting or circuit attorney, as the  
42 case may be, for appropriate proceedings.

43 211.425. 1. Any person who has been adjudicated a delinquent by a juvenile court for  
44 committing or attempting to commit a sex-related offense which if committed by an adult would be  
45 considered a felony offense pursuant to chapter 566 including, but not limited to, rape, forcible  
46 sodomy, child molestation and sexual abuse, shall be considered a juvenile sex offender and shall be  
47 required to register as a juvenile sex offender by complying with the registration requirements  
48 provided for in this section, unless such juvenile adjudicated as a delinquent is fourteen years of age

1 or older at the time of the offense and the offense adjudicated would be considered a felony under  
 2 chapter 566 if committed by an adult, which is equal to or more severe than aggravated sexual abuse  
 3 under 18 U.S.C. Section 2241, including any attempt or conspiracy to commit such offense, in  
 4 which case, the juvenile shall be required to register as an adult sexual offender under sections  
 5 589.400 to 589.425. This requirement shall also apply to any person who is or has been adjudicated  
 6 a juvenile delinquent in any other state or federal jurisdiction for committing, attempting to commit,  
 7 or conspiring to commit offenses which would be proscribed herein.

8 2. Any state agency having supervision over a juvenile required to register as a juvenile sex  
 9 offender or any court having jurisdiction over a juvenile required to register as a juvenile sex  
 10 offender, or any person required to register as a juvenile sex offender, shall, within ten days of the  
 11 juvenile offender moving into any county of this state, register with the juvenile office of the  
 12 county. If such juvenile offender changes residence or address, the state agency, court or person  
 13 shall inform the juvenile office within ten days of the new residence or address and shall also be  
 14 required to register with the juvenile office of any new county of residence. Registration shall be  
 15 accomplished by completing a registration form similar to the form provided for in section 589.407.  
 16 Such form shall include, but is not limited to, the following:

35 5. Any juvenile to whom the registration requirement of this section applies shall be

 40 required to register. This requirement to register upon discharge or release from custody does not  
 41 apply in situations where the juvenile is temporarily released under guard or direct supervision from  
 42 a detention facility or similar custodial facility.

43 6. The requirement to register as a juvenile sex offender shall terminate upon the juvenile  
 44 offender reaching age twenty-one, unless such juvenile offender is required to register as an adult

46 211.431. Any person [~~seventeen~~] eighteen years of age or over who willfully violates,  
 47 neglects or refuses to obey or perform any lawful order of the court, or who violates any provision  
 48 of this chapter is guilty of a class A misdemeanor.

1           221.044. No person under the age of [~~seventeen~~] eighteen years, except those transferred to  
2 the court of general jurisdiction under the provisions of section 211.071, shall be detained in a jail or  
3 other adult detention facility as that term is defined in section 211.151. A traffic court judge may  
4 request the juvenile court to order the commitment of a person under the age of [~~seventeen~~] eighteen
