1 AMEND Senate Committee Substitute for Senate Bill No. 279, Page 2, Section 302.188, Line 34,
2 by inserting after all of said section and line the following:

4 "304.725. 1. A veteran displaying special license plates issued under section 301.145,
5 301.443, 301.451, [or] 301.456, ~~[or a veteran who is a Bronze Star recipient]~~ 301.3052, 301.3053,
6 or 301.3075, or a Distinguished Service Cross recipient, Air Force Cross recipient, or Coast Guard
7 Cross recipient who displays a placard issued under subsection 2 of this section may park his or her
8 motor vehicle, weighing not more than six thousand pounds gross weight, without charge, in a
9 metered parking space or in a parking lot or garage on any public college or university in the state
10 of Missouri, except during a special event where a separate parking fee may apply.

11 2. A veteran who has been awarded the ~~[military service award known as the "Bronze Star"]~~
12 Distinguished Service Cross, Air Force Cross, Coast Guard Cross, or a veteran who qualifies for a
13 special license plate under subsection 1 of this section may apply to the director of revenue for a
14 removable windshield placard at no cost to the veteran. Upon application, such veteran shall
15 present proof to the director of his or her receipt of such award. Such placard shall be hung from
16 the front, middle rearview mirror of a parked motor vehicle and may not be hung from the mirror
17 during operation. When there is no rearview mirror, the placard shall be displayed on the dashboard
18 on the driver's side.

19 3. A local authority's compliance with this section is solely contingent upon the approval of
20 its governing body.

21 4. This section does not exempt a vehicle displaying special license plates under section
22 301.145, 301.443, 301.451, [or] 301.456, 301.3052, 301.3053, or 301.3075, or displaying a placard
23 as provided in subsection 2 of this section, from compliance with any other state law or ordinance,
24 including, but not limited to, vehicle height restrictions, zones that prohibit stopping, parking, or
25 standing of all vehicles, parking time limitations, street sweeping, restrictions of the parking space
26 to a particular type of vehicle, or the parking of a vehicle that is involved in the operation of a street
27 vending business.

28 5. This section does not authorize a vehicle displaying special license plates under section
29 301.145, 301.443, 301.451, [or] 301.456, 301.3052, 301.3053, or 301.3075, or displaying a placard
30 as provided in subsection 2 of this section, to park in a state parking facility that is designated only
31 for state employees.

32 6. This section does not authorize a vehicle displaying special license plates under section
33 301.145, 301.443, 301.451, [or] 301.456, 301.3052, 301.3053, or 301.3075, or displaying a placard
34 as provided in subsection 2 of this section, to park during time periods other than the normal
35 business hours of, or the maximum time allotted by, a state or local authority parking facility.

36 7. This section does not require the state or a local authority to designate specific parking
