1 AMEND House Bill No. 680, Page 1, Section 160.2700, Line 7, by deleting the words, "an on-site
2 child care facility" and inserting in lieu thereof the words, "on-site child care"; and

3
4 Further amend said bill, page and section, Line 9, by deleting the words, "section 163.031" and
5 inserting in lieu thereof the words, "sections 160.415 or 163.031"; and

6
7 Further amend said bill, Pages 1 to 2, Section 160.2705, Lines 1 through 22, by deleting all of said
8 lines and inserting in lieu thereof the following:

9
10 "160.2705. 1. The department of elementary and secondary education shall authorize,
11 before January 1, 2018, a Missouri-based nonprofit organization meeting the criteria under
12 subsection 2 of this section to establish and operate four adult high schools, with:

13 (1) one adult high school to be located in a city not within a county;

14 (2) one adult high school to be located in any county of the third classification without a
15 township form of government and with more than forty-one thousand but fewer than forty-five
16 thousand inhabitants or a county contiguous to that county;

17 (3) one adult high school to be located in any county of the first classification with more
18 than two hundred sixty thousand but fewer than three hundred thousand inhabitants or a county
19 contiguous to that county; and

20 (4) one adult high school to be located in any county of the first classification with more
21 than one hundred fifty thousand but fewer than two hundred thousand inhabitants.

22 2. The department of elementary and secondary education shall grant the authorization
23 described under subsection 1 of this section based on a bid process conducted in accordance with the
24 rules and regulations governing purchasing through the office of administration. The successful
25 bidder shall:

26 (1) Demonstrate the ability to establish, within twenty-one months of the receipt of the
27 authorization, four adult high schools offering high school diplomas, an industry certification
28 program or programs, and an on-site child care facility for children of the students attending the
29 high schools;

30 (2) Commit at least two million dollars in investment for the purpose of establishing the
31 necessary infrastructure to operate four adult high schools;"; and

33 Further amend said bill and section, Pages 2 and 3, Lines 40 through 45, by deleting all of said lines
34 and inserting in lieu thereof the following:

 3 outcomes related to a student's ability to find a more rewarding job through the attainment of a high
 4 school diploma and job training and certification; and

6 3. (1) The department of elementary and secondary education shall establish academic
 7 requirements for students to obtain high"; and

 9 Further amend said bill and section, Page 3, Lines 51 through 55, by deleting all of said lines and
 10 inserting in lieu thereof the following:

 12 "academic rigor as would otherwise be necessary to attain such credits.

13 (3) The adult high school authorized under this section shall award high school diplomas to
 14 students who successfully meet the established academic requirements. The adult high school
 15 authorized under this section shall confer the diploma"; and

 17 Further amend said bill, page and section, Line 60, by deleting all of said line and inserting in lieu
 18 thereof the following:

 20 "any specific number of class minutes. The adult high school may also make classes available to
 21 students online as may be appropriate."; and

 23 Further amend said bill and page, Section 160.2715, Lines 1 through 2, by deleting the words,
 24 "section 163.031" and inserting in lieu thereof the words, "sections 160.415 or 163.031"; and

 26 Further amend said bill, page and section, Line 3, by inserting after the word, "schools" the words,
 27 "or charter schools"; and

28
 29 Further amend said bill, Page 4, Section 160.2720, Lines 1 through 8, by deleting all of said lines
 30 and inserting in lieu thereof the following:

 32 "160.2720. The nonprofit organization who receives the authorization described under
 33 section 160.2705 shall submit to the department of elementary and secondary education, the joint
 34 committee on education, and the offices of the governor, speaker of the house of representatives,
 35 and president pro tempore of the senate an annual report concerning evaluations of the adult high
 36 schools, including the impact the adult high schools have had in meeting industry needs in the state
 37 before December first of each year."; and

 39 Further amend said bill by amending the title, enacting clause, and intersectional references
 40 accordingly.
