FISCAL ANALYSIS

ASSUMPTION

Officials at the **Department of Agriculture** and the **Department of Elementary and Secondary Education** each assume there is no fiscal impact from this proposal to their respective departments.

Officials at the **West Plains School District** assume the athletic organization will pass the cost of the coaches onto its members. It is estimated to be \$1,000 to \$3,000.

Officials at the **Bakersfield School District** assume a cost of \$4,560 annually.

Officials at the **Everton School District** assume a cost of \$2,000.

Officials at the Forsyth R-III School District assume a negative impact.

Officials at the **Kansas City**, **Kirksville R-III** and the **Pettis County R-XII** school districts each assume there is no fiscal impact from this proposal to their respective district.

Oversight notes this proposal allows any student participating in activities at the Missouri state fair who is a member of an athletic team and who is missing practices while at the Missouri state fair to receive the opportunity to participate in practices relevant to their sport at the Missouri state fair. The statewide athletic organization with the student's public school as a member is required to provide a coach for the student so they can receive their practice at the Missouri state fair.

Oversight asked the Department of Agriculture about how many students may participate in the Missouri state fair. They responded:

"There were 19,890 individual competitions (called classes) offered this year. These classes fall within approximately 35 departments covering a broad range of interests from livestock to fine arts, fiddling to farm mechanics, and apiculture to curing ham. There were 32,721 total entries (youth and adult). 4,535 individuals (exhibitors) entered one or more competitions at the 2016 fair, more than 3,200 of those exhibitors were youth exhibitors. Within the livestock departments, there are generally two similar classes offered. One identified as 4-H / FFA and the other "open". Student exhibitors compete against each other in the 4-H / FFA designated classes, and they are also allowed to participate in the "open" shows competing against adults. Most student exhibitors do participate in both."

<u>ASSUMPTION</u> (continued)

Oversight is not able to determine how many students who are participating at the Missouri state fair would require a coach. Oversight notes the statewide athletic organizations are not political subdivisions of the state and therefore, any costs they incur are not included in this fiscal note. Additionally, Oversight will not show a fiscal impact to the school districts as the proposal requires the statewide athletic organizations to provide the coaches.

Officials at the **Bronaugh** and **Verona** school districts each responded to Oversight's request for fiscal impact but did not indicate a fiscal impact.
