## **FISCAL ANALYSIS**

### **ASSUMPTION**

Officials at the **Department of Elementary and Secondary Education (DESE)** assume there is no fiscal impact from this proposal.

Officials at the **Kansas City, Malta Bend, Pettis County R-XII, Wentzville R-IV** and the **West Plains School District** assume there is no fiscal impact from this proposal.

Officials at the **Everton R-III School District** assume a savings of \$3,000 annually.

Officials at the **Wright City R-II School District** assume negligible costs.

Officials at the **Forsyth R-III School District** assume a negative unknown impact.

Officials at the **Campbell R-II School District** and the **Kirksville R-III School District** each responded to Oversight's request for fiscal impact but did not indicate an impact.

**Oversight** notes a school district shall not be required to make up any day of school lost or cancelled due to inclement weather during a school year if the district has an alternative instruction plan approved by the department of elementary and secondary education for such school year. Oversight notes that currently school districts build into their schedule extra days for inclement weather (snow days). This proposal would allow a school district to adjust their calendar to not include inclement weather days. Oversight assumes this proposal is permissive and will not show an impact from this proposal.

**Oversight** notes this proposal would not allow for the use of the alternative instruction plan for more than 10 days in a school year.

Officials at the **Joint Committee on Administrative Rules** assume there is no fiscal impact from this proposal.

Officials from the **Office of the Secretary of State (SOS)** state many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$2,500. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the

General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with the core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

**Oversight** assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could request funding through the appropriation process.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
