FISCAL ANALYSIS

ASSUMPTION

Officials at the **Office of State Public Defender** cannot assume existing staff will provide competent, effective representation for any indigent persons are charged faced with the enhanced penalties for repeated offenses of animal or livestock trespassing. The Missouri State Public Defender System is currently providing legal representation in caseloads in excess of recognized standards.

While the number of new cases may be too few or uncertain to request additional funding for this specific bill, the Office of the State Public Defender will continue to request sufficient appropriations to provide competent and effective representation in all cases where the right to counsel attaches.

Officials at the **Department of Agriculture**, **Department of Corrections**, **Department of Public Safety - Highway Patrol**, **Department of Conservation**, **Office of State Courts Administrator**, and **Office of Prosecution Services** each assume this proposal will not have a fiscal impact on their respective organizations.
