FISCAL ANALYSIS

ASSUMPTION

Officials at the **Department of Higher Education** assume there is no fiscal impact from this proposal to their Department. They note that this proposal would require a memorandum of understanding between institutions and municipal law enforcement agencies, effectively duplicating §173.2050.

Oversight notes that currently §173.2050 requires public higher education institutions and law enforcement agencies to have memorandums of understanding in place regarding sexual assault, domestic violence, dating violence and stalking. Therefore, Oversight assumes this portion of the proposal would not have a fiscal impact.

Officials at the Northwest Missouri State University assume a cost of \$25,000.

Officials at the **Missouri Western State University** assume an impact of \$4,000 annually to distribute written materials to students on our sexual assault policy once an academic year.

Officials at the University of Missouri assume no significant fiscal impact.

Officials at the **Missouri State University**, **State Technical College of Missouri**, **Truman State University** and the **University of Central Missouri** each assume there is no fiscal impact from this proposal to their respective institution.

Officials at the **Boone County Sheriff**, **St. Louis County Justice Services**, **St. Louis County Police Department** and the **Springfield Police Department** each assume there is no fiscal impact from this proposal to their respective organization.

Oversight notes a portion of this proposal requires the higher education institutions to distribute written copies of its sexual assault policies to students at least once a year. Oversight assumes that the institutions may be able to include the required materials with other policies and procedures distributed to students at the start of the school year. Also, subsection 173.2100.10 requires each institution of higher education to employ at least one full-time investigator of Title IX complaints for every 20,000 students enrolled. Oversight does not know if all institutions currently meet this new requirement. Therefore, Oversight will show the impact of this bill as \$0 to (Unknown) for the distribution of the materials and/or hiring of additional FTE to meet the requirements of subsection 173.2100.10.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

This bill establishes the "Enough is Enough Act" which requires all higher education institutions to comply with Sections 1681 to 1688 of Title IX of the Education Amendments of 1972 and shall employ at least one person, for every 20,000 students, to investigate Title IX complaints.

In addition, the institutions' sexual assault policies shall contain an affirmative consent standard to determine whether the parties consented to sexual activity and specify that no student who reports, in good faith, a sexual assault incident shall be subject to discipline for violation of any drug or alcohol policy in relation to the incident.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
