FISCAL ANALYSIS

<u>ASSUMPTION</u>

Officials at the **Department of Elementary and Secondary Education** assume there may be some costs to local school districts.

Officials at the **Kansas City Public Schools** assume additional administrative costs estimated at less than \$25,000. Final cost determination cannot be estimated until DESE promulgates the rules toward implementation.

Officials at the **Bakersfield School District** assume additional costs of \$500 annually.

Officials at the **Concordia School District** assume a cost of \$225. It would require approximately 10 additional hours of the school counselor's time at \$22.50 an hour.

Officials at the **Everton School District** assume \$1,000 additional expenses.

Officials at the **Forsyth R-III School District** assume increased costs and labor of printing multiple sets of diplomas. Estimated cost \$1,000.

Officials at the **Wentzville School District** assume \$3,000 in administrative cost to identify students who receive the notation on their diploma.

Officials at the **Kirksville R-III** and the **Parkway** school districts each assume minimal impact for printing stickers and labor.

Officials at the **Malta Bend**, **Warren County R-III** and the **West Plains** school districts each assume there is no fiscal impact from this proposal to their respective districts.

Officials at the **Pettis County R-XII** assume no impact as they are a K-8 only district.

Officials at the **Middle Grove School District** responded to Oversight's request but did not indicate a fiscal impact.

Oversight notes this proposal allows a student who receives a score above the national average on a comprehensive assessment test to receive a notation on their diploma. The notation is to be determined by the Department of Elementary and Secondary Education (DESE). The comprehensive assessment tests are the ACT, ACT Compass, HSE, ASVAB, or EOC. Oversight assumes that school districts will be able to absorb the cost of tracking which students receive the

notation. Oversight assumes that the notation created by DESE will be added to the diplomas with little additional fiscal impact.
