ASSUMPTION

Officials from the **Office of the Governor (GOV)** assume this proposal requires their office to provide funding, administrative support, and staff for the operation of this commission. The fiscal impact is based upon the 2016 expenditures of the Martin Luther King Jr. Celebration Commission under the Department of Labor and Industrial Relations, and should not exceed \$29,183 annually.

Officials from the **Office of Administration** and the **Department of Insurance, Financial Institutions and Professional Registration** each assume the current proposal would not fiscally impact their respective agencies.
