FISCAL ANALYSIS

ASSUMPTION

Officials at the **Department of Revenue (DOR)** assume this proposal allows community college police officers to enforce traffic laws on any thoroughfare owned and maintained by the college. Violations within the college district will have the same effect as if they occurred on a public roads, streets, or highways of the state.

This proposal will result in an increase in the number of traffic convictions received and processed by the Department. Traffic convictions are assessed points in accordance with §302.302, RSMo. When the volume of convictions increase the Department issues more point warning and suspension notices, as required by §302.304, RSMo. This results in an increase in customer contacts. There are no statistics available to determine exactly how many additional convictions will result from this proposal. If the volume is so significant that it cannot be absorbed by existing staff, additional FTE(s) will be requested through the appropriation process.

Reinstatement fees collected are also unknown; however, the fees collected will be distributed 75% highway funds, 15% cities, and 10% counties.

Oversight assumes the proposal is permissive and, for fiscal note purposes only, will assign no fiscal impact. Oversight assumes this changes the entities permitted to enforce traffic regulations.

Officials at the **Department of Higher Education** and the **Missouri Highway Patrol** each assume there is no fiscal impact from this proposal to their respective organizations.

Officials at the **State Technical College of Missouri** assume there is no fiscal impact from this proposal.

Officials at the **Metropolitan Community College** assume there may be an impact if they choose to enforce the laws. However, this proposal is optional.

Officials at the following community colleges: Crowder, East Central Community College, Jefferson College, Moberly Area Community College, State Fair Community College, St. Charles Community College, St. Louis Community College and the Three Rivers Community College did not respond to **Oversight's** request for fiscal impact.
